Be sure when you go to Area that all forms are properly signed (**and notarized**) and completed, that you make hotel reservations for your students that make the All-State Band, and that you make housing plans yourself.

I would like to take this opportunity to thank **E. Zane Polson** and **John Young** for their service to ATSSB the last two years as Class A and AAA Representative to the ATSSB State Board of Directors. It is a time-consuming but necessary role that they played on the Executive Committee as it has tried to accommodate the needs of students and their directors.

I would also like to thank **Rob Toups** for his service to ATSSB as President this past year. Rob serves ATSSB at a fortuitous time. His alliances and associations with TMAA and TMEA leadership is a welcome tool in this time of transition for ATSSB. We see the history of ATSSB in the Scottish Rite passing as the venue has deteriorated past optimal use by a performing organization. The Cathedral still has its history and I hope it continues to exist, but the conditions for concert-goers was less than optimal even in past years, and has regressed to the point that we can no longer enjoy its space.

As you and your students experience this year's All-State clinic and concerts, please understand that we are all working hard to make it a memorable one. We are certainly open to suggestions for improvement and would welcome any constructive criticism regarding rehearsal space, performance space, hotel accommodations, etc. Believe me, MANY different scenarios have been investigated over the last four months since the decision was made regarding the Scottish Rite Auditorium. As he also said, this is just the beginning - a new direction for ATSSB in alliance with TMEA in its effort to "promote and encourage small-school bands in Texas."

You will find a schedule of rehearsals and performances in this newsletter. Please notice that the schedule is subject to change and will be kept up to date at <http://www.atssb.org/2008Rehearsals.pdf>. Please make an effort not only to thank our **Licenseses** for their support, but also to use their services. These companies have paid a fee and are under contract to use the ATSSB logo and marks on their products. They pay a portion of their receipts to the ATSSB All-State Band Scholarship. Please consider using them before any other companies offering the same or similar products: Southwest Specialties (Craig Johnson - Midlothian) = T-shirts, caps, plaques, etc.; Probst Audio (Scott Probst - Ennis) = audio recordings of concerts on CD; Jordan Sound Productions (Gary Jordan - Bullard) = recording of concerts on tapes or CD and ATSSB Area etude performance CDs; Made To Order (Dick Nye - Lubbock) = T-shirts, caps, plaques, etc.; California T's (L. Steve Taylor - Lubbock) = T-shirts, caps, plaques, etc.; On Site Digital (Randy Bryant - Austin) - recording of concerts on tapes or CD; Stephen Henry Smart Music Consultant (Stephen Henry - Vanderbilt) = SmartMusic files of audition etudes; Mattei Music Services = All-State Jazz audition CDs; Audio Refinery (Carlos Casso) = digital recording of concerts; and Cauble Sportswear, Inc. A reminder about **piccolo** and **E $\flat$  clarinet**: If your flute or clarinet player makes the All-State Band at the Area auditions January 5 and would like to play piccolo (flutes) or E $\flat$  Soprano Clarinet (clarinets), have them bring these instruments to San Antonio. After regular chair auditions are completed for flute/clarinet, we will hold separate auditions for these two instruments for each band from among those students interested in it that were selected for their respective bands. One piccolo and one soprano clarinet may be selected from among the Symphonic flutes and clarinets; also, one piccolo and one soprano clarinet may be selected from among the Concert flutes and clarinets. If no one auditions on these instruments from one, either, or both bands, then the instrument will not be used. A notice concerning this policy will be placed in the flute and clarinet packets they will receive at Area this year if they are selected for the All-State Band.

We will continue our **hotel reservation** practice. Each student that wishes to stay in ATSSB housing must pay a \$135 housing fee directly to ATSSB (the address will be on the housing form they complete at Area). ATSSB will then pay one check for the hotel rooms up front. If directors are able to reserve a room using ATSSB housing forms, they must pay for the room in one check directly to ATSSB in the amount of \$420 (split any way you can among directors sharing the room with you). Make sure you include the student name and school (or director's name and school). Remember to take care of this before January 11, 2008, or you will lose your reservation. **Each payment for housing MUST include a signed hotel tax exemption from from the school.**

We plan to hold our ATSSB **Business Session** in CC1 of the Convention Center at 12:30 p.m. on Thursday, February 14. **Elections** for Class A and Class AAA Representatives to the State Board of Directors will be held at this meeting. I hope you can make plans to attend during the busy activities in San Antonio. Remember that proxies are not allowed in these elections. A short biographical sketch and picture of each candidate for state office can be found in this Newsletter (if a biography and/or a picture was submitted).

When you get a chance, be sure to thank our **Region and Area Coordinators** for their efforts in securing audition sites, hosts, audition chairmen, computer equipment and logistics, etc. Also, let's not forget to thank our **State Chair Audition Coordinator** (Eric Gray of Gilmer) and all of his helpers and judging panels in advance of the work facing them as the two bands are seated; also Collin Anderson from Groesbeck, Mark Melton from Union Grove, and Bryant Harris from Iraan are serving in the **State Chair Auditions Office** this year. Our All-State **Symphonic Band Organizer** (Karen Dyre of Liberty Hill), All-State **Symphonic Band Percussion Organizer** (John Perrin of Liberty Hill), All-State **Concert Band Organizer** (Stacy Gist of Hutto), All-State **Concert Band Percussion**


**Organizer** (Cathie Cain of New Diana), and All-State **Jazz Ensemble Organizer** (Tim Schodowski of Quitman) still have a job ahead of them. The convention-clinic and concerts will take a LOT of preparation, advanced planning and organization - all under new circumstances that none of them even imagined when they took the responsibility as an organizer. Rooms have been booked for you and your students, rehearsal and performance space has been arranged for all three organizations, stands and percussion equipment have to be provided before chair auditions begin on Wednesday night, programs have to be completed, badges for the students have to be secured and sorted, entertainment for All-State students prior to the general meeting arranged -- not to mention many other activities taking place in the background as we prepare for the clinic. All of the people involved give so much of their time to make it a success. It would not be possible if it weren't for their dedication to the profession and the students in the All-State Bands who benefit from their efforts.

Since this will be our last communication before San Antonio, let me address those of you who will have students in the All-State Band for the first time. Please remember that many are in the "big city" for the first time. They will need **frequent contact** with you to allay their fears and keep them focused on their role as they represent not only ATSSB, but also their bands, school, and community. **Drop by rehearsals often**, especially at breaks, to see that they have a place to go and that they know what they may do in their free time. It also helps to have directors observing rehearsals at all times. Not only do we learn good rehearsal techniques from our fine clinicians, but also we can act as a restraining presence to students who might otherwise allow their attention to drift during rehearsals. There is certainly nothing wrong with leaning over a student with a cap on and quietly asking him or her to remove it -- or watching a section and noticing a student talking in a distracting manner and quietly asking them to stop. Our Organizers are with the band almost constantly, but we cannot expect them to be there every minute nor expect them to see every infraction of rehearsal protocol. Try to drop by and give a listen -- and a hand.

Our **corporate supporters** are so consistent in their desire to help provide shoulder patches and "breakout" refreshments for the all-state students. They will be recognized in the all-state programs, but I just wanted to say an additional "Thank You" to them in advance for their contributions to the continued success of the ATSSB All-State Band. The Elmer and Anita Schenk Family Trust has made a donation to ATSSB to provide the all-state programs in the future. The donation has been invested and the interest will be used to provide the programs in the future. Thank you, Founding Charter Member Elmer Schenk, for your thoughtful gift to ATSSB.

Be sure to visit with your Region Coordinators about issues you wish addressed at the State Board meeting coming up. Make your opinions about issues confronting ATSSB known to your representatives to the State Board so they can be discussed with a consensus from the membership.

Thank all of you for your continued diligence and hard work on behalf of the students in our small school programs. Keep up the great work.

## Has DCI Killed the Band Program?

One of the worst things to ever happen to music education in America has been Drum Corps International. Actually, DCI is not the problem. DCI is a very worthwhile activity that has provided some great entertainment over the years. The problem is that there are some high school marching band directors who try to copy the elite drum and bugle corps. Marching bands are not drum and bugle corps. They both have drums and they both march on a field, but there the similarity ends. Or at least it should.

A few years ago, marching band was just one tiny part of what band programs worked on. Concert band, jazz band, solo-ensemble, all-region, basketball pep-bands, spring trips, and parades were some of the events that were taken VERY seriously by band directors and their students. Marching contests were part of what we did, but they did not rule our curriculum for 6 months of the year. Equal emphasis was placed on every instrument in our bands and the "guard" (we old guys called them "flag lines") was something that some of the students did in ADDITION to playing horns.

Drum corps and marching bands are two completely different entities. The instrumentation is different, the age levels are different, the organizational sponsorship is different, the rehearsal schedule SHOULD be different, the educational purpose is different, and the intended consumer is different. Drum corps are elite in the level of expertise of its individual members. If one cannot perform up to that level they are shown the door. This naturally raises the difficulty level possible with a corps. A school band must take all-comers. A director cannot remove a member if their best effort is of lesser quality than the rest of the band. A corps demands total surrender of the member's life for many months. The drum and bugle corps member has no other classes to prepare for, no church activities, no job, and no family events. They have nothing else to do except to prepare for the next competition. As a result, the DCI performances are extremely difficult and are nearly perfect in both music and marching execution. It is nearly impossible for a high school band to reach this level of perfection at the same degree of difficulty unless the students are giving up many other parts of their life. Because of these unreasonable expectations, many good student musicians are forced out of their school band programs because they want some diversity in their life experiences.

Another factor to consider is that a drum corps performs the same show all season. This poses no problem for the audience because it is mostly a different city with a different crowd each night. However, some high school bands perform the same show for the same audience 10 weeks in a row. It takes a REALLY dedicated parent to sit through 10 performances of the same show. No band director would schedule 10 weekly concerts in the spring and perform the same 4 tunes at every concert. It is unfortunate that, for the difficult shows some band programs attempt, this is the only way to get the performance level high enough to compete in marching contests. These programs win many trophies and build pride for a few people but are they creating musicians who see playing their horns as a life-long activity? Or do the students stop playing as soon as they can because they are sick of spending May to November on the same 8 minutes of music?

Drum and bugle corps should be something that entertain us as band directors and band students, but they should NEVER be something we try to totally emulate. That makes no more sense than a 2A high school football team trying to run a West Coast Offense.

### Class A Representative



**Jerry Barker** is the director of bands at Eldorado High School in region 7. Prior to arriving in Eldorado, Jerry taught at Jim Ned (81-84), Van Vleck (84-91), Eden (91-95), Roscoe (05-00), and Coahoma (00-05). His wife, Morgan, passed away in 2003. He has two children: Morgan

(15) who is a freshman and plays the french horn, and Will (13) who is a 7th-grader and plays the trombone. Jerry is a member of ATSSB, TMEA, TBA, and ATPE. His bands have received consistent first divisions in marching and concert competitions. The Eldorado High School Band just received its 24th consecutive first division in marching. His bands have been to Area five times, finishing as 2nd alternate to state in Area D this year.

"I have been a member of ATSSB since its beginning. I have been a strong supporter of its beliefs and goals and would like to be a part in furthering those goals. My 26-year teaching career has been spent in the small school setting. Twelve of those years were in class A schools. has served as ATSSB Area West Coordinator and currently serves as an ATSSB Region 16 Middle School all-region band coordinator.

His marching bands have advanced to the finals of the UIL state marching contest five times, placing among the top three on four occasions including two state championships. The Sundown band recently earned its 20th consecutive

UIL Sweepstakes award. His bands have twice represented Texas in the National Independence Day Parade in Washington, DC. He serves as an adjudicator and clinician throughout the state.

**Priscilla Gibson** is the band director at Archer City High School in region 2. 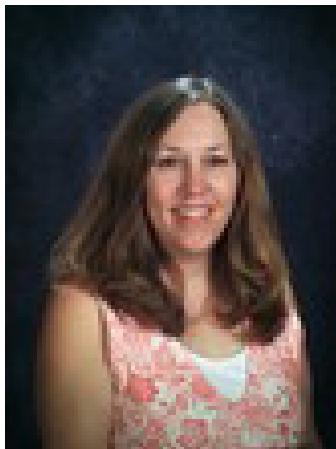
Ms. Gibson has been a band director in Region 2 for 20 years: two years teaching elementary school, 7 years in a 4A program, and 11 years in 1A band

has served as Secretary for Region 2, Band Division secretary, and Region 2 ATSSB secretary.

He holds a Bachelor of Arts in Education with emphasis in instrumental music education and a minor in vocal music education. He holds the Master of Science

in Educational Administration from Lubbock Christian University and is currently completing the classroom work necessary for Superintendent Certification from The University of Texas of the Permian Basin. He is a member of TMEA, ATSSB, MENC, OMEA and TASSP. He taught six years in Oklahoma and is completing his tenth year in Texas. Mr. Higgs has spent his entire career in 1A and 2A schools. Twice in his career Mr. Higgs has started band programs from scratch. In his sixteen years as a successful educator, Mr. Higgs's bands have accumulated numerous honors in UIL or OSSBA contests. Individual students of Mr. Higgs have won numerous medals for solo/ensemble competition and many have competed on the state level in both Oklahoma and Texas. In Oklahoma, Mr. Higgs's Jazz band competed twice on the state level coming in fourth and sixth in Class 1A. Bands under Mr. Higgs's direction have qualified for and competed in area marching contests in Texas. Mr. Higgs has also organized and hosted invitational solo/ensemble contests, concert band contests and marching band contests. He has had two students make the ATSSB All-State Band. Mr. Higgs has also served as floor monitor for the ATSSB All-State Band. He is currently completing his fourth year as the Assistant Principal, Curriculum Director, School Safety Director, Band Director and History Teacher for Covington ISD.

**Zane Polson** is currently the band director in the small panhandle town of Sunray. He is in his ninth year as the director at Sunray Independent School District. Prior to teaching in Sunray, Zane taught for 18 years in small Texas schools including Friona, Daingerfield, Lockney, and Seymour. Before becoming a head band director, Mr. Polson was an assistant to Lonnie Dooley in Seymour and to Jim Parker in Friona.
