Greetings from ATSSB!

Dear Colleague:

This Newsletter was sent to all ATSSB-eligible high schools and current members of record as first-class mail to be certain each school receives the current Prescribed Audition List Update and etude errata. If you did not receive the mailing, you may download the [Year D Update](#) from the [ATSSB Website](#).

ATSSB enjoyed another exciting and productive year in 2003-04. It was evident from the number of members we had in our twelfth year (904) and from the quality of the 2005 ATSSB All-State Bands that our organization was "sensitive to the needs and interests of A, AA and AAA band programs in Texas."

The All-State Band Clinic was a positive one with James Keene conducting the Symphonic Band, Kevin Sedatole leading our Concert Band, and Shelly Berg leading our first-ever All-State Jazz Ensemble in wonderful performances. We have secured the services of three outstanding clinicians for the 2005 clinic: Anthony Maiello is making his third appearance from George Mason University for the Symphonic Band, Fred J. Allen from Stephen F. Austin State University for the Concert Band, and H. David Caffey from California State Polytechnical University for the Jazz Ensemble. ATSSB has commissioned Fred J. Allen to write a grade 2+ piece for the ATSSB All-State Concert Band.

We invite you to join ATSSB and hope that we can help you in your task. Please print the membership form in this Newsletter and return it with your dues to the address indicated. A membership card and receipt will be returned to you as soon as possible and your name added to the roster of your ATSSB Region Coordinator (see [Officers Page](#) on the Website) so you can be kept up to date on ATSSB activities. If you wish to have students audition for membership in the ATSSB All-State Band this year, you must also become a member of [TMEA](#) because the two organizations have aligned their audition procedures for membership in Texas All-State Bands.

We hope you will get actively involved in ATSSB - or at least communicate your desires and suggestions to the State Board of Directors through your Region Coordinator (or directly to the Executive Committee).

We expect another banner year for ATSSB as we grow together as unified small-school band directors and we want you to be a part of it. We finished the 2003-04 membership year with more than 95% of the small schools in Texas that have band programs as members of ATSSB. Thank you for your continued support of small-school bands in Texas.

It's time for a fresh start. Another summer has ended and the year has just started at most schools across the state. Put your teaching skills back in order. Sort out the music, find the

ensemble books and make another marching chart for your color guard members. Oh yes, don't forget to pay your dues to ATSSB (www.atssb.org/execsec/App.pdf) & TMEA (www.tmea.org/010_Membership/MemForm_2005.pdf) prior to entering any competition. See links to applications at the end of this column. Jazz ensemble auditions are early, so if your students are going to enter, you will need to pay your dues quickly. This is Year D for the etudes (www.atssb.org/auditions.asp). Kenneth has placed a

few low brass etudes in the Smart Music format (www.atssb.org/execsec). I have heard numerous schools that have achieved great results using this method for their UIL solos.

The TMEA/ATSSB Dialogue Committee meetings this summer produced an alignment agreement that is most favorable to our association (www.atssb.org/execsec/alignmentagreement.pdf). This is the first time that TMEA will provide legal assistance in writing should litigation arise from an audition so long as we

follow the established rules, procedures and guidelines. Gary Robbins, Steven Moore, Kenneth Griffin and I met with Jeff Laird, Kerry Taylor, Steven Andre, Mike Ware, Bob Floyd, and Frank Coachman. They asked us to consider various options in regards to performing in the convention center. TMEA offered us a performance space for our all-state ensembles in Ballroom A. Our state board declined this offer at this time. We will continue to hold our ATSSB business meetings at the convention center for

our general membership. More discussions will follow to reach a performance agreement in the future. Both divisions understand the quality control needed for any expansion of groups at the state level. Thank you TBA for allowing our State OPS competition to be held at your convention. Last year we asked if our award results could also be given out during the luncheon and that request was graciously met this summer when our OPS results were announced by Don Thoede, OPS state chair. Thank you Charlie Munsell and Gary Robbins for a great convention.

Thank you Frank Coachman, TMEA deputy director, for presenting to us an updated workshop on the FileMaker Pro software at our state board meeting. Remember as you enter your students in the competition this year to

check off if they are going the 4A/5A track or the ATSSB track. Don't forget before you can enter any names, you must have your ATSSB membership number and TMEA membership number. Ask your region coordinator if you are having problems with the system. Try to keep your computer systems clean of bugs from the internet. You don't want to miss your deadlines if your computer systems are down.

I want to thank Steven Henry for a great workshop that he provided and was sponsored by ATSSB and Smart Music. If you didn't get to attend, you missed a treat. On other projects our ATSSB brochure is still in the developmental stages. The committee members need to continue working on the details for a polished report due by TMEA.

I am looking forward to my last state

convention as President of ATSSB. These past two years have gone by in a flash. Remember as you start a new year, to give thanks to your local staff for allowing you to attend TBA, TMEA & ATSSB events. We have a great group of clinicians for this year's state performance. Anthony Maiello from George Mason University will be our symphonic band clinician. Fred J. Allen from Stephen F. Austin State University will be our concert band clinician. And finally, H. David Caffey from California State Polytechnical University will be our jazz ensemble clinician. Don't forget that our student hotel cost will be \$135 for three nights while our directors will cost \$384 for three nights or \$128 per night. We will hold these concerts in the Scottish Rite Auditorium again this year.

It is time for a

fresh start at your school. Remember to praise your students, pay your fees and watch your deadlines. Don't forget that the UIL judges will be busy with the new descriptor forms (www.uil.utexas.edu/mus/march_desc04.pdf). Make sure you know what is expected at marching contest. Lets continue to excel and promote our students and schools in the state. We have a fine group of officers working to help you get your job done. Make sure you communicate your ATSSB guidelines and procedures to your students so that they will have a fair chance of earning a position in one of our all-state concert bands or the jazz ensemble. Remember we are here to help you grow musically.

ELECTIONS

We will be electing Class C/CC, Class 2A Representatives to the State Board of Directors, and President-Elect in February. Each region had the opportunity to nominate someone which did not have to be from their own region for each office. Nominees who accept the nominations will be presented in the December Newsletter along with a picture and biography. Newsletters are only published on-line now except for this issue (which is of course also published online). We print and mail this issue

first class to each eligible high school to ensure everyone gets the very important PAL Update each year. So keep an eye out for the December edition online. An email will be sent to all members of record reminding them of its availability.

EMAIL UPDATE

Speaking of email addresses, **please** keep me informed of new or changed email addresses, telephone numbers or mailing addresses. I continue to have returned emails from members whose email addresses either changed or the servers did not accept the email because of policy restrictions (usually at your school email address - the ESC ones are the usual culprits). If you do not want me to send you these quarterly reminders, just omit your email address from the membership application or renewal (or tell me to keep it private so I will not use it or publish it on-line). If you know you have a legitimate email address but do not

get these reminders, check with your tech person to see if the ATSSB emails are blocked.

HOMESCHOOLERS

In accordance with our alignment with TMEA, we are also obligated to accept homeschoolers in the audition process. If there is a homeschooled student wishing to participate in the all-region process, they must meet the following guidelines:

1) They must audition in the region/area track based on their home district classification. If they live in a public school district that has a class 3A or lower school, they may participate in ATSSB and/or auditions; but if they live in a public school district that has a class 4A or higher school, they may **not** participate in ATSSB auditions at any level unless they are certified by an ATSSB-member director as a participating member of their school band. In other words, they meet regularly in rehearsals and participate in performances and

competitions as permitted under current UIL/TMEA eligibility guidelines.

2) They are sponsored by a paid member of ATSSB and TMEA. Their parent or private teacher must join ATSSB and TMEA to sponsor their participation.

3) They maintain eligibility under current TEA eligibility guidelines pertaining to extracurricular participation. If you have any additional questions regarding homeschoolers, feel free to give me a call or contact.

TMEA ALIGNMENT

TMEA and ATSSB have approved revisions to the Alignment Agreement (see copy in this Newsletter). The two associations reached the original agreement in 1998 to align audition procedures leading to membership in a Texas all-state band. The revisions clean up some ambiguous language in the original agreement and tighten legal obligations on TMEA's part. It also

 clarifies procedures for changing any of the configurations of all-state ensembles. TMEA approved all of the negotiated agreements early this summer. The ATSSB membership voted its overwhelming approval of the revisions in a ballot ending August 31 (95.7% for, 4.3% against). Voting was done using technology this time: An email ballot was sent to all members with a registered email address in the 2003-04 database; members whose email was returned as undeliverable and members who had no email address listed were mailed a postcard ballot with instructions to return by August 31. This saved a lot of postage. However, I was personally still dismayed to note that only 17.96% of the eligible voting membership bothered to vote. Why are we all so apathetic? **Please** respond to calls for votes or input regarding ATSSB activities in the future.

JAZZ ENSEMBLE AND AUDITION TRACKS

As you send in entries to ATSSB all-region auditions this year, remember that it is assumed that students from schools in class 1A, 2A and 3A are auditioning in the ATSSB track to All-

TMEA/ATSSB Joint Agreement July 26, 2004



1. All-State Bands

- a. Bands administered by TMEA shall be:
 - i. 5A Symphonic Band - open to all school classifications.
 - ii. 5A Concert Band - open to all school classifications.
 - iii. 4A Symphonic Band - open to only 4A, 3A, 2A, and 1A classifications.
 - iv. TMEA Jazz Ensemble - open to all school classifications.
- b. Band administered by ATSSB (in affiliation with TMEA) shall be:
 - i. ATSSB Symphonic Band - open to only 3A, 2A and 1A classifications.
 - ii. ATSSB Concert Band - open to only 3A, 2A and 1A classifications.
 - iii. ATSSB Jazz Ensemble - open to only 3A, 2A and 1A classifications.

2. Auditions

- a. TMEA Eligibility Rules will be applicable to all Texas All-State Bands.
- b. Auditions for the ATSSB All-State Bands will follow TMEA audition procedures. ATSSB will use its own Prescribed Audition List.
- c. The Entry Cover Sheet filed with the All-State Band entries must include proof of the director's current TMEA membership.
- d. Students auditioning at the Area level for any of the All-State Bands administered by TMEA may not audition at the Area level for any of the All-State Bands administered by ATSSB. Students auditioning at the Area level for All-State Bands administered by ATSSB may not audition at the Area level for any of the All-State Bands administered by TMEA (See Item No. 1 above).
- e. ATSSB appeals will follow the ATSSB Appeals Process. If necessary, appeals may then be referred to the TMEA Presidents Committee for final disposition.
- f. Should ATSSB need legal defense when following established rules, procedures and guidelines as outlined above, TMEA will provide legal representation.

3. Financing

- a. The ATSSB All-State Bands will be financed and administered by ATSSB.
- b. TMEA will provide exhibit hall privileges and a one-year *Southwestern Musician* subscription to the ATSSB All-State students.

4. Publications

- a. Special announcements from ATSSB will be included in the Band Division Column of the *Southwestern Musician* and on the TMEA website as needed.
- b. TMEA and ATSSB will provide a link to the other's website from their own.
- c. ATSSB will continue to publish its own newsletter.
- d. ATSSB All-State students shall be listed in all publications or listings of All-State students.

5. Reciprocal Invitations

- a. The ATSSB President shall be invited to all TMEA Band Chair Meetings.
- b. The TMEA Band Vice-President shall be invited to all ATSSB State Board meetings.
- c. Dialogue Committee: The ATSSB Presidents Committee (Immediate Past-President, President, President-Elect, and Executive Secretary), the TMEA Band Vice-President and the TMEA Presidents Committee shall meet at least once annually providing direct communications between the organizations.

6. Amendment/Review

- a. Any changes in configuration of existing ATSSB ensembles must be reviewed by the TMEA Executive Board in collaboration with the ATSSB Presidents Committee.
- b. Any addition of an ensemble by either TMEA or ATSSB must be approved by the TMEA State Board. The following will be considered for the addition of an ensemble:
 - i. There is a need for the ensemble based on the total number of entries versus the percentage of All-State members with respect to classification and division.
 - ii. The overall quality of the new ensemble will meet or exceed that of the current All-State ensembles.
 - iii. The quality of existing All-State ensembles will not be adversely affected.
- c. This alignment agreement shall be reviewed by TMEA and ATSSB for possible revision and/or amendment each year during the Dialogue Committee meeting.

7. New Teacher Recruitment and Retention

- a. TMEA pledges support for ATSSB activities as related to music educator recruitment and retention for small classification schools.
- b. ATSSB pledges support for TMEA as the advocate for fine arts in Texas.

A Short Note from the ATSSB All-State Jazz Coordinator

Your Region should be kicking up the all-region jazz ensemble auditions very soon. Yes jazz amongst all of the wonderful marching band charts you rare working on like the Hey Song and Land of a 1000 Dances. Your region jazz ensemble is important because that is the route to the second All State Jazz Ensemble for ATSSB. Last year was the first and this year will be even better. The audition process is described in detail on the ATSSB web site at <http://www.atssb.org/auditions.asp>.

Those audition procedures will be followed to the letter. Make sure you read the requirements for the ballad and the especially the percussion. Remember that all recordings are to be made with instrument and the cd minus that specific instrument. You must follow the guidelines. Also, the chart for Cuban Fire Ant has specific audition requirements that are listed on the conductor score and the parts. The piece was designed for you to have a playable piece of music in addition to an audition piece.

I also need volunteers for auditions on November 6th to be held at Wills Point High School. We are approximately 30 miles east of Mesquite off I-20 and on Hwy 80. There is a small stipend involved.

Change ARTICLE V

from: **SECTION 5. STATE BOARD OF DIRECTORS.** The State Board of Directors shall be composed of the President, President-Elect, the Immediate Past-President, Executive Secretary, At-Large Representatives, Founding Members, and Region Coordinators who are currently in good standing with the Association. It shall also include Past-Presidents as ex-officio members. The Executive Committee shall be composed of the President, President-Elect, the Immediate Past-President, Executive Secretary, and At-Large Representatives.

It shall be responsible for: 1) the business management and operation of ATSSB and for the management and control of funds thereof; (2) fixing the time and place of meetings and cooperating with the President in planning details of such meetings; (3) adopting annual budgets as needed; (4) approving Presidential appointments filling vacancies as they occur; (5) fixing the amount of dues for memberships; (6) fixing Regional and Area boundaries; (7) interpreting the Constitution and By-Laws; and (8) having the authority to pass upon all matters referred to it by the membership in Business Sessions and by the President. The Executive Committee shall be composed of the President, President-Elect, the Immediate Past-President, Executive Secretary, and At-Large Representatives. It shall be responsible for hearing appeals in the prescribed Appeal Process and for carrying on the business of the Association when it is impractical to convene the State Board of Directors or when expediency is required.

Rationale: *Founding Members who become ineligible to continue as Regular Members due to a move to 4A or 5A and who are still interested in an ongoing relationship with ATSSB as Associate Members should still be able to attend State Board of Director meetings, albeit as ex-officio members. The Presidents Committee is already functioning as a liaison between ATSSB and TMEA in Dialogue Committee meetings; it just needs official constitutional standing.*

Change SECTION 2.(a) of ARTICLE II of the By-Laws

from: **SECTION 2.(a). DUTIES OF THE PRESIDENT-ELECT.** The President-Elect shall preside at ATSSB meetings and at meetings of the State Board of Directors in the absence of the President. He shall appoint special committees necessary to the operation of his duties and shall be chairman of the State Audition Review Committee which is charged with the continuous review of the 5-year rotating Prescribed Music List.

to: **SECTION 2.(a). DUTIES OF THE PRESIDENT-ELECT.** The President-Elect shall preside at ATSSB meetings and at meetings of the State Board of Directors in the absence of the President. He shall appoint special committees necessary to the operation of his duties and shall be chairman of the State Audition Review Committee which is charged with the continuous review of the 5-year rotating Prescribed **Music Audition** List.

Minutes of the State Board of Directors Meeting

State Board of Directors Meeting

July 24, 2004

The State Board of Directors of the Association of Texas Small School Bands met in the Renaissance Room of the Menger Hotel in San Antonio on July 24, 2004. In attendance were Region 11 Coordinator Daniel Alemán, Founding Charter Member Rick Ball, Region 3/20 Coordinator Brandon Brewer, Region 12 Coordinator Sandy Brown, Region 8 Coordinator John Canfield, Executive Secretary Kenneth Griffin, Region 13 Coordinator Stephen Henry, Class A Representative Randy Hunsaker, Class AA Representative Carl Idlebird, Class AAA Representative Jim Jones, Bruce Kenner (proxy for Region 9/23), President Ed Lowes, Founding Charter Member Mike Marsh, Region 15 Coordinator Juan Jose Meave, Region 5/24 Coordinator Cindy Mikel, Region 2 and Area North Coordinator Greg Miller, Region 21 Coordinator Mike Miller, President-Elect Steven Moore, Region 18 Coordinator Perry Morris, James Nance (proxy for Region 1), Region 16 Coordinator John Odom, Immediate Past-President Gary Robbins, Founding Charter Member Elmer Schenk, Region 10 and Area East Coordinator Don Stockton, Region 6 Coordinator Daniel Todd, and Region 7 and Area Central Coordinator Robert Vetter. Also in attendance were TMEA Deputy Director Frank Coachman, TMEA Immediate Past-President Jeff Laird, TMEA President-Elect Kerry Taylor, Area West Coordinator Jimmie Exline, OPS State Chair Don Thoede, and Founding Charter Member Jennifer Willison. Absent were Region 4 Coordinator Mike Barnes, Founding Charter Member Mike Bendiksen, Region 17/19 Coordinator Cory Buckley, Founding Charter Member Jim Gibson, Past-President Ronnie Page, Past-President and Founding Charter Member Fred Pankratz, Class C/CC Representative Sherry Poteet, Region 14 Coordinator Jim Powell, Founding Charter Member Louis Thornton, and invited guests TMEA Band Division Vice-President Steve Andre and Area South Coordinator Eric Winterbottom.

The meeting was called to order by President Ed Lowes at 7:35 a.m. The invocation was given by Mr. Lowes.

Mr. Lowes suspended the agenda to allow TMEA Deputy Director Frank Coachman to bring those present up to date regarding the on-line entry process and modifications to the FileMaker Pro software.

He continued the suspension to consider the proposed TMEA/ATSSB Alignment Agreement since TMEA Immediate Past-President Jeff Laird and TMEA President-Elect Kerry Taylor were present to answer questions regarding the agreement. Brandon Brewer moved and John Odom seconded that we approve the alignment agreement. Stephen Henry questioned the wording regarding the addition of an all-state ensemble and Mr. Laird answered that the TMEA Executive Board felt that if they were going to be required to provide legal representation in litigation concerning an ATSSB audition, there should be some accountability on our part regarding the all-state structure. John Canfield noted that the agreement was the right thing to do at the right time. Gary Robbins noted that the ATSSB Presidents Committee had worked with TMEA regarding the agreement and felt it was what was needed at this time. Steven Moore observed that TMEA was not asking anything of ATSSB that they were not requiring of any other division. Mr. Lowes noted that the Dialogue Committee meetings were very productive and amicable and recommended the adoption of the document. After the question was called, the motion to approve the agreement and pass it on to the membership for approval at the General Session passed unanimously.

On resumption of the agenda, the SBOD minutes of the February meeting were approved as printed in the March Newsletter after a motion by John Odom and a second by Greg Miller.

Under reports from special committees, George Strickland gave a report from the UIL office, noting changes for the coming year.

Under reports of standing committees:

Steven Moore reported on the SARC meeting. A survey to determine interest in adding an A-AA All-State Band was inconclusive in that only half of the surveys sent were returned and, of those returned, only half were in favor. Therefore, the SARC had no recommendations for the Board.

Don Stockton reported from the Past-President Committee on Gary Robbins' behalf (he had to leave to introduce clinicians in his role as TBA Sergeant-at-Arms). The committee moved to raise dues \$10 beginning in 2005-06 to \$35 (\$60 if after October 1). The motion was seconded by Bob Vetter. Brandon Brewer asked if the increase was needed and Mr. Griffin answered in the affirmative. Motion carried.

Don Thoede then gave an OPS report and asked Region and Area Coordinators to be more diligent in following procedures. Brandon Brewer moved and Evan Richardson seconded that scores be used in the OPS process. After discussion, the question was called and the motion failed with 6 votes for and 18 against.

In the President's Report:

Ed Lowes thanked Coordinators for their work with ATSSB.

He asked that everyone check everything twice before posting results from any audition or adjudication.

He asked that everyone in attendance complete the form he gave them regarding clinicians and commissioned composers at the region level for dissemination to others - a reference list for clinicians and composers from which everyone could draw made available on-line.

He noted that a committee to develop an ATSSB Brochure was still working.

In the Executive Secretary's Report:

Kenneth Griffin told Region Coordinators to place patch orders soon so the full order can be placed by September 1.

He noted that several regions lacked submission of an Employer Identification Number and some others still lacked posting or submitting region rules.

He referred the Board to a list of suggested clinicians and noted that we would be selecting a Jazz Ensemble clinician later in the meeting.

There being no old business, Mr. Lowes moved on to New Business.

Under New Business:

After Mr. Lowes related a TMEA offer of performance space for our All-State ensembles in Ballroom A of the Convention Center. Stephen Henry voiced concern that the audience would not be able to see the band students from the ballroom floor. Daniel Alemán expressed similar concerns and Brandon Brewer expressed concerns about setup and tear-down, logistics of moving from the Scottish Rite, but did not want to miss an opportunity to get the ensembles into the Convention Center for the convenience of our members. Greg Miller noted that the offer was appreciated, but did not see practical use at this time. Steven Moore reported that TMEA would provide an equipment truck if and unloading at the Convention Center if ATSSB would load it at the Scottish Rite. After more discussion, Brandon Brewer moved and Stephen Henry seconded that we respectfully decline the offer at this time but will continue discussions on determining possible future use. Motion carried.

Mr. Griffin asked Region Coordinators to make sure vendors operating at ATSSB functions are Licensees paying a royalty into the Scholarship Fund.

(SBOD Minutes, Continued)

After considering submitted bids, the audio recording contract was awarded to Probst Audio after a motion by John Odom and second by Brandon Brewer. Motion carried.

A discussion regarding clinicians resulted in the selection of Rick Stitzel for the 2006 All-State Jazz Ensemble.

Mr. Griffin reported that a financial bond with \$150,000 coverage for the Executive Secretary had been secured and letters of audit were shared with the board.

Rising hotel rates were discussed but no action was taken.

The use of OPS CDs was discussed and Stephen Henry moved with Brandon Brewer seconding that we give the CD to member schools with the September Newsletter beginning in 2005. Motion carried.

Kenneth Griffin moved and Brandon Brewer seconded that we pay Stephen Henry a \$200 honorarium for his clinic at TBA. Motion carried.

Kenneth Griffin raised the issue of small numbers participating in ATSSB activities from Region 22 and posed the possible merge of Region 22 with Region 6. After considerable discussion and input from Region 22 member Forrest Perry from Van Horn, no action was taken.

Stephen Henry made a motion to create an A-AA All-State Band in 2005-06 using ATSSB audition music. After a second by James Nance, motion failed with 8 for and 14 against.

Stephen Henry moved that ATSSB name a committee to study the needs and promotion of class A bands chaired by the ATSSB Class A Representative with the philosophy being that if we are not going to have an A-AA All-State Band, we need to help class A directors support their students. After a second by John Odom, motion carried.

Rick Ball asked that the Executive Committee get information regarding the 6-hour GT update directors will need each year and how we can provide our members with more opportunities to get the credits needed at TBA and TMEA. Mr. Lowes names Mr. Ball as chair of a committee to study this proposal and Mr. Griffin noted that he would be in contact with Mr. Ball to see how he could help.
