STUDENT CODE OF CONDUCT

Students are responsible for all of their own property at all times (it is best to mark all personal belongings). While reasonable care is taken for all personal property, liability for the loss of property either by fire, theft or vandalism is limited to the individual involved. Hotel reservations and payment of rooms is the responsibility of the student. Students must remain reasonably quiet at all times in the hotel. Televisions and electronic devices must be played at low volume levels so as to not disturb regular hotel guests. No practicing or playing of instruments in the hotel after 8:00 PM. Hotel doors should remain closed and locked at all times. Males are not allowed to visit in females' rooms; females are not allowed to visit in males' rooms. Should an exception be necessary, a chaperone must be present. When outside the hotel rooms, students must wear their ATSSB clinic badge in plain sight, visible from the front, on or above the waist, and below the neck. The badge will have the student's designated chaperone's name, hotel and cell phone number on the back. Curfew for students is 12:00 midnight. The curfew means that students must be in their rooms and may not leave them after this time for any reason. No possession or use of alcoholic beverages, pornographic material, incense, or controlled substances (drugs or illegal materials) will be tolerated. Students are expected to behave in a mannerly and respectful fashion to each other and to all hotel employees and guests and ATSSB officials at all times. Should it prove necessary, access to student's room and baggage must be provided to a designated ATSSB officer.

It is expressly understood by students, parents, administrators, and directors that any infraction of the above rules of conduct may constitute grounds for dismissal from ATSSB activities. For minor offenses, the student may be removed from housing and placed under the care of the Designated Chaperone (who will either find appropriate local housing or send the student home). When removal of All-State students must occur, a supervised designated area will be made available for the students until the director, sponsors or parents are able to appear in person to take charge of the students. The students will not be allowed to be under their own supervision during this time nor will they be placed in a situation where they will be unsupervised. For major offenses, police will be called and parents notified to provide immediate transportation home (if released by the authorities).

Percussionists selected to the All-State Band may be required to furnish the percussion equipment needed for the rehearsals and performance as assigned by the respective All-State Band Percussion Organizer regardless of which band the student is a member.
