### REGION ENTRIES:

No entries will be accepted unless you are a member of TMEA and ATSSB. Get this done on September 1.

Region entries are \$9.00 a person. Deadlines are 14 days before the contest. You can enter kids up to 7 days before but will have a \$9.00 late fee. All fees must be paid or supported by a school purchase order prior to the start of auditions.

Entries are done at the TMEA website. If you need help, please call me. Be sure you are on time.

From the Stateboard:

1. All Contest deadlines will be 14 days prior to the audition
2. The late and final online student entry will be 7 days prior to the day of audition
3. Correction to an existing student entry may be made between 13 and 7 days prior the audition without penalty, but any student entry added less than 14 days but more than 7 days prior to the contest will result in an additional 100% of the late fee.
4. Entries begun less than 14 but more than 7 days prior to the contest will be assessed a 50 percent additional CAMPUS fee charge and 100% student fee charge.
5. A campus entry created less than 14 days prior to the contest will be subject to the TMEA Grievance Process.

If on the day of the try-outs and you put a student on the wrong instrument or forgot to add a student. This can be fixed but you must pay \$18.00 for it. It can only be fixed with a new entry

Your entire staff must be available to judge on HS All-Region try-out day as well as Your MS Zone all-region try-out. If you or someone from your staff cannot be there, you must send a comparable person and you are responsible for the paying them.

If you registered students for region try-outs, you and your staff must be available to judge. Even if you DNA them and or decide not to bring them.

Remember, when entering All-Region info – be careful to spell names correctly and select the correct track.
