Happy summer! Congratulations on surviving another year of evaluations, auditions, contests, festivals, concerts, etc.! I am 100% positive we are the busiest people on our campuses. I recently helped plan my 40th High School Class Reunion. When we went to set a date for the event, my fellow planning committee members asked me to pick a date that would work for me since they knew no one else in our class would have as hectic a calendar! Our job is a never-ending cycle of activities and planning for the next activity.

That said, the older I get, the more I look forward to the chance to reflect, reorganize, and recharge. These last few weeks of school have been especially tough in our district. In April, a young man in our freshman class took his own life. While I didn't know him well, he was active in sports & FFA and an excellent student. The shock waves from that event affected everyone in our district in ways I couldn't have ever predicted. It was a harsh reminder that we do not know what many of our students are going through. Even though things can look fine on the surface, our kids fight battles we don't see.



The first few days after it happened, I was reminded that band is much more than contests and ratings. We often speak about our band "family," but this was played out in real-time on our campus. That first day, our high school administration allowed students to move throughout the building as they needed to grieve. After students were told what had happened, somber silence permeated the building. But after an hour or so, my band hall became full of students. Kids wanted to be in places they felt safe and normal. Many wanted to sit in my office and talk, but as the day went on, the practice rooms started filling up with kids playing their instruments. It's probably the one class of the day on our campus that went through its normal routine with a full band rehearsal. I wish I could articulate the emotions I felt seeing students using music to cope and get through that day. I'm still processing it myself, but what a blessing we have in this profession, sharing these bonds with our students and seeing the power of music. It can be a heavy load in some circumstances, but what a gift we have been given!

I did not intend to make this an emotion-filled newsletter article, but here we are! Anyone who knows me knows I'm not one to hide my feelings! Again, take some time this summer to do your reflections, and as I always tell you before an extended break, take time to recharge—whatever that looks like for you! I am a phone call, text, or email away, so never hesitate to reach out if you need me!

I leave you with one of the best pieces of advice I have ever received about being a better band director, teacher, husband, and dad. Find that director from an older generation who has had the program you desire, the numbers, the success, the fun. Take that director for a Coke and just let them talk. Soak it in!!! Their knowledge of the trenches might be just what you need to be able to go home and be the difference maker in your program and to your kids.

I look forward to seeing you (hopefully at TBA), but I am closing this letter to get "all of the things" done so I can spend some much-needed time with my wife. Remember, all of our students will graduate, move on, and create lives of their own, but you have people who will be with you forever. Take some time with them this summer. Your membership expires on July 31, so if you plan to enter students into jazz auditions, which are always early, be sure to join for 2024-25 as soon as you can to avoid errors while entering students. If you are not yet a member for next year, fill out the application online: <https://www.atssb.org/atssb-membership-application-form/>

You need only list name and school and any changes - we already have the other posted data in the database. Then send payment when your school budget year begins - or go ahead and send in the check or school Purchase Order now while you are thinking about it. Dues for Active Members are \$50, but remember that after October 1, the dues increase to \$75 unless you are joining as an Associate Member or College Division Member (everything is the same; you just cannot run for office, vote, or enter students in any ATSSB competition). Retirees who retire as an Active Member retain their Active Membership, but dues are reduced to \$25 per year. A cover page showing your ATSSB and TMEA membership card should be sent with the initial entry forms for the first audition entered (ATSSB or TMEA).



Remember that if you enter students in the Jazz Ensemble competitions, audition deadlines are EARLY, so take care of your ATSSB and TMEA dues as soon as possible. I email a copy of your card as soon as I receive payment of dues, so be sure we have an accurate email address for you and that your school does not block mail from this office (attachments trigger spam guards, so make sure we are allowed). While you are at it, go ahead and join TBA for July. Be sure to check this link to see the region to which your ISD is assigned: https://align.tmea.org/align_2426/index.php

If you are new to ATSSB, check out our secure website (<https://www.atssb.org>). If you are having difficulty finding the forms or data you need, you can always check out the link at the top of the home page, "ATSSB A-Z," which can help you find what you are looking for. If you have suggestions on how we can improve the site's usefulness, send them to our Webmaster, Marc Nicholson (mnichelson@atssb.org). Also, let us know if any links are not working so we can keep this huge trove of data up to date.

In your fall region meetings, you must nominate a President-Elect, a Class 1C Representative, a Class 1 Representative, and a Class 3A Representative to the State Board of Directors. An electronic ballot will be cast in January if an office has more than two candidates to reduce the final ballot to no more than two candidates per office. The election will be held at the General Session tentatively scheduled for Friday of the convention.

This coming year, Dr. J. Eric Wilson (Baylor University) will be the clinician for the Symphonic Band. We have commissioned Julie Giroux to write a piece for the Symphonic Band this year. Dustin Seifert (Eastern New Mexico University)) will be the Concert Band clinician. Ronald Wilkins (Shires Trombone Artist and New York Musician) will be the clinician for the Jazz Ensemble. The Jazz Ensemble will premier a piece by Mr. Wilkins commissioned by ATSSB.

Numerous commercial audio and videos of the ATSSB Area etudes are available for purchase. Jordan Sound Productions (JordanSP@aol.com) sells audio files, and Dallas Winds sells a complete audition year of videos (121 videos) at <https://dallaswinds.org/atssb/>. There may be other options for audio or video files of the Year D offered, but please look for an official affiliation with ATSSB before using them. We have had numerous issues with universities that do not become official ATSSB Licensees who take liberties with the editions, altering excerpts beyond what the Prescribed Audition List allows.

Your ATSSB State Board of Directors will meet in July. The Board includes all elected state officers, all Region Coordinators, all Founding Charter Members, past presidents, and invited guests. If you would like to have input on matters relating to ATSSB policies and procedures, I suggest calling or writing your Region Coordinator (or any state officer) and telling them of your concerns so they can advise the full Board.

I hope you all have a great summer, and I get to visit with many of you in San Antonio at TBA.

OUTSTANDING PERFORMANCE SERIES

The 2024 Outstanding Performance Series competition is gaining momentum with record-high entries! This year, we are thrilled to have a total of 906 pieces to be heard, a significant increase from 878 last year. The number of competing organizations has also seen a rise, from 320 to 326. We are particularly excited about the increased participation of Non-Varsity ensembles, who have submitted entries to be a part of the Non-Varsity pilot competitions.

While the contest is not having some of the same hiccups as it did in 2023 because of a DropBox issue, there is one primary concern that everyone needs to understand. The OPS webpage is the official source for all things regarding the Outstanding Performance Series. Reading the OPS webpage would have easily remedied a lot of the confusion about entries this year. I am always available to answer questions; however, once entries start coming in, I get around 500-600 emails just as I upload receipts, and your email may get buried amidst all of those. However, I am typically a phone call away if you have a pressing matter.

All adjudication deadlines and certification of advancement dates are clearly listed on the OPS webpage. A comprehensive matrix of all adjudications is also available, showing which regions will be judging your entries. Following each level of adjudication, a Certification of Advancement form will be emailed by the OPS State Chair, indicating which entries have advanced from region to area and then to the state OPS contest. This form will also be accessible on the OPS web page for your reference.

Should you get a call from this number, 903-390-3271, during the summer, be sure to respond, as I may have questions regarding your entries or may be calling to hire you as a judge for the state-level contest at TBA.

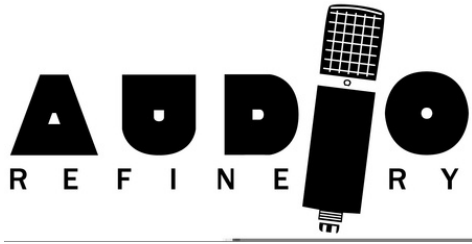
