I hope the ATSSB audition process went well for all of you at the region level and that you are looking forward to Area January 7. This year when you go to Area, you just have to make sure you have paid the \$20 Area fee (most regions collect that and send one check) - no forms to take! Students selected to State will receive a login from TMEA (through their band director) after Area with which they download the Medical Release (needing signatures and a Notary Public) and a Code of Conduct (2 copies - each needing signatures) that they must bring (signed and notarized!) to registration on Wednesday of the clinic. Be sure you make hotel reservations for your students that make the All-State Band (including the students selected to the 2012 ATSSB All-State Jazz Ensemble), and that you make housing plans for their Designated



Chaperones using the housing worksheet provided. One director per room will go online on Monday or Tuesday to reserve the rooms for all students and their Designated Chaperones (who must stay at the same hotel).

I would like to take this opportunity to thank Carroll Rhodes for his service to ATSSB the last two years as Class A Representative to the ATSSB State Board of Directors. Also, Jim Cude graciously agreed to complete the term of Class AAA Representative when John Young was elected President-Elect. It is a time-consuming but necessary role that Carroll and Jim played on the Executive Committee as it has tried to accommodate the needs of students and their directors in the interim between State Board of Director meetings.

You will find a schedule of rehearsals and performances for our All-State groups in this newsletter. Please notice that the schedule is subject to change and will be kept up to date at http://www.atssb.org/2012Rehearsals.pdf

Please make an effort not only to thank our Licensees for their support, but also to use their services. These companies have paid a fee and are under contract to use the ATSSB logo and marks on their products. They pay a portion of their receipts to the ATSSB All-State Band Scholarship. Please consider using them before any other companies offering the same or similar products. See the list elsewhere in this Newsletter.

Remember that All-State students are required to bring their own wire stands to San Antonio. Music stands will not be provided in chair auditions or in rehearsals (there will be music stands in the Lila Cockrell Theatre and Ballroom B for the concerts on Saturday).

A reminder about piccolo and E_{\flat} clarinet: If your flute or clarinet player makes the All-State Band at the Area auditions January 7 and would like to play piccolo (flutes) or E_{\flat} Soprano Clarinet (clarinets), have them bring these instruments to San Antonio. After regular chair auditions are completed for flute/clarinet, we will hold separate auditions for these two instruments for each band from among those students interested in it that were selected for their respective bands. One piccolo

and one Eb soprano clarinet may be selected from among the Symphonic flutes and clarinets: also, one piccolo and one soprano clarinet may be selected from among the Concert flutes and clarinets. A notice concerning this policy will be placed in the flute and clarinet packets they will receive at Area this year if they are selected for the All-State Band.

The clinician for the Concert Band has asked that alto clarinets bring a regular clarinet for those pieces that do not have a specific alto clarinet part. A notice regarding that issue is also inserted into the alto clarinet state folders they receive at Area. If they neglect to bring a clarinet, they will sit during those pieces for which an alto clarinet is not published.

Remember that we will be using the TMEA housing forms and reservation procedures at Area. Look over the Housing Notes from Frank Coachman enclosed with this Newsletter and make yourself familiar with the requirements. It is pretty simple, really. If you have a student (or students) make the All-State Band at Area (or already have an All-State Jazz Ensemble student), go to the housing table and get with other directors to fill out a room worksheet, putting four students to a room where possible (TMEA will combine others that are incomplete after Area). Make sure you also put a Designated Chaperone in a room at the bottom of the worksheet for each student listed. Decide who will go online on Monday or Tuesday to reserve the room, using a credit card to make the reservation (you can pay individually using a school check at checkin). We hope this process goes smoothly for you, but feel free to ask questions at Area if you are uncomfortable with any of the procedures. If you have already made reservations at another hotel and must stay at the Hyatt Regency as a Designated Chaperone, you can cancel the other reservation (there will be no cancellation fee if you reserved the room through the TMEA housing process and you cancel the other reservation by January 17).

We plan to hold our ATSSB Business Session in the Convention Center (CC207) at 3:30 p.m. on Thursday, February 10. Elections for Class A and Class AAA Representatives to the State Board of Directors will be held at this meeting. I hope you can make plans to attend during the busy activities in San Antonio. Remember that proxies are not allowed in these elections. A short biographical sketch and picture of each candidate for state office who have accepted their nominations and submitted documentation can be found in this Newsletter. If any are missing, check back because biographies and/or pictures will be added if and when the candidates who have accepted nominations have submitted the information to this office.

When you get a chance, be sure to thank our Region and Area Coordinators for their efforts in securing audition sites, hosts, audition chairmen, computer equipment and logistics, etc. Also, let's not forget to thank our State Chair Audition Coordinator (Eric Gray of Gilmer) and all of his helpers and judging panels in advance of the work facing them as the two bands are seated; also Collin Anderson from Groesbeck and Bryant Harris from Iraan are serving in the State Chair Auditions Office this year. Our All-State Symphonic Band Organizer (William Foster of Caldwell), All-State Symphonic Band Percussion Organizer (John Perrin of Liberty Hill), All-State Concert Band Organizer (Kyle White of Grand Saline), All-State Concert Band Percussion Organizer (Don Garcia of Skidmore-Tynan), and All-State Jazz Ensemble Organizer (John Nutt of Crandall) still

have a job ahead of them. The convention-clinic and concerts will take a LOT of preparation, advanced planning and organization. Rehearsal and performance space has been arranged for all three organizations, chair audition rooms arranged with screens, tables and chairs before chair auditions begin on Wednesday night, programs have to be completed, badges for the students have to be secured and sorted, entertainment for All-State students prior to the general meeting arranged - not to mention many other activities taking place in the background as we prepare for the clinic. All of the people involved give so much of their time to make it a success. It would not be possible if it weren't for their dedication to the profession and the students in the All-State Bands who benefit from their efforts. I would like to give a personal THANK YOU to TMEA Deputy Director Frank Coachman for his untiring efforts on behalf of all Texas musicians. He has been an invaluable friend to ATSSB for many years now. We are all fortunate to have him as a colleague and friend as we strive to better our students musically.

Since this will be our last communication before San Antonio, let me address those of you who will have students in the All-State Band for the first time. Please remember that many are in the "big city" for the first time. They will need frequent contact with you to allay their fears and keep them focused on their role as they represent not only ATSSB, but also their bands, school and community. Drop by rehearsals often, especially at breaks, to see that they have a place to go and that they know what they may do in their free time. It also helps to have directors observing rehearsals at all times. Not only do we learn good rehearsal techniques from our fine clinicians, but also we can act as a restraining presence to students who might otherwise allow their attention to drift during rehearsals. There is certainly nothing wrong with leaning over a student with a cap on and quietly asking him or her to remove it - or watching a section and noticing a student talking in a distracting manner and quietly asking them to stop. Our Organizers are with the band almost constantly, but we cannot expect them to be there every minute nor expect them to see every infraction of rehearsal protocol. Try to drop by and give a listen - and a hand.

Our corporate supporters are so consistent in their desire to help provide shoulder patches and "breakout" refreshments for the all-state students. They will be recognized in the all-state programs, but I just wanted to say an additional "Thank You" to them in advance for their contributions to the continued success of the ATSSB All-State Band. The Elmer and Anita Schenk Family Trust has made a donation to ATSSB to provide the all-state programs. The donation has been invested and the interest will be used to pay for the programs. Thank you, Founding Charter Member Elmer Schenk, for your thoughtful gift to ATSSB.

Be sure to visit with your Region Coordinators about issues you wish addressed at the State Board meeting coming up. Make your opinions about issues confronting ATSSB known to your representatives to the State Board so they can be discussed with a consensus from the membership.

Thanks all of you for your continued diligence and hard work on behalf of the students in our small school programs. Keep up the great work.

Chris Conway is the head director for Tenaha High School in Region 21. He is graduate of Northwestern State University, where he earned a Bachelor of Music Education Degree as well as a Master of Music.

Mr. Conway has been teaching for 15

years. While in Tenaha, his bands have won OPS in the march category, advanced to the Class A State Marching Contest, as well as earning the Sweepstakes Award. His other duties are as an administrator for the district. Prior to Tenaha, he was at Elysian Fields High School and helped them earn their first Sweepstakes Award in 10 years. Before that, he was earning multiple Sweepstakes Awards as the 7th grade band director for Carthage ISD.

In 2008, he was named a Distinguished Teacher by the Carthage Education Foundation. In 2009, he was awarded an outstanding performance award from the school board of Elysian Fields ISD. In 2011, he was awarded The Annice Knight Award by Tenaha ISD. Also in 2011, he was awarded first place at the state level of the ATSSB Outstanding Performance Series for Tenaha's performance of Peacemaker march. As a trombone player, he has performed professionally with the Bill Causey Orchestra, The Sounds of Swing, and the Centenary Summer Band. Mr. Conway's professional affiliations include Texas Music Educators Association, Association of Texas Small School Bands, Texas Music Adjudicator's Association, and American Federation of Musicians.

He is married to his wife Tamesa and has a step son Matt.

"I am honored to be nominated for the Class A Representative. Having taught at the 3A, 2A and 1A level, I feel I could make our voice heard and understood. I would do my best and work hard. Thank you for the opportunity."

Priscilla Gibson is the band director at Archer City High School in Region 2. She has been a band director in region 2 for 22 years. Of those years she spent 4 years teaching K-12, 11years teaching 5 – 12, and 7years teaching 6-12.



Chuck Miller is the band director at De Leon High School in Region 7. He graduated from Rosebud-Lott High School in 1986 and attended Blinn Jr. College from 1986-1988, transferred to Stephen F. Austin in 1988 and graduated with an All-Level Music Degree in 1991. He

received his Masters of Education from Sul Ross State University this past August. He was an assistant band director in Yorktown for three years and has taught at De Leon since 1993. He has been married for 21 years to his high school sweetheart and they have two children. Their son is a freshman and their daughter is a fourth grader.

In 1993, De Leon had 12 students in the band. Since then they have had success in ATSSB and UIL, receiving First divisions in marching, concert, and sight-reading as well as sweepstakes, and a trip to the area marching contest. His students

have competed on the district, region, area, and all-state levels of ATSSB and have competed at TSSEC for the past ten years.

He is the host and organizer of the Bring Your Own Band Marching clinic and contest. This contest is geared towards small school bands the first week in October to help them prepare for UIL Marching contest.

After marching season to keep the students involved in the community, he teaches Karate classes in the evenings three days a week. He is a second-degree black belt in Ching Sai Do combat karate and is a certified teacher through Black Belts of the Faith in Berkley California. He is also president of the little league sports association that governs the youth sports Kindergarten through 6th grade in De Leon.

Carroll Rhodes is

the band director at Tahoka High School. He was born and raised in Abilene, Texas, graduating from Abilene High in 1965. He attended Hardin-Simmons University where he earned his BM in Music Education and Music Theory



and Composition in 1971 and his MM in Music Theory and Composition in 1975, during which time he was graduate assistant to "Prof" Marion B. McClure.

After teaching band at Cross Plains from '72-76 and at Shamrock from '76-78, Carroll left the band business to serve 16 years as a Minister of Music and Youth, serving churches in Muleshoe, Tahoka, & Ruidoso. He returned to band directing in 1994,

taking over the band director's job at Lockney in November of 1994. After earning a Sweepstakes that spring, Carroll returned to Tahoka where he is presently in his 17th year as band director.

When they finally earned a Sweepstakes in '01, it was only the second one in school history with the first being in 1951. Since 2001, the band has earned 13 consecutive I's in concert, 12 consecutive I's in sightreading, 10 consecutive I's in marching, and 9 consecutive sweepstakes, plus placing 3rd in the 2009 TMEA 1A Honor Band Competition and 2nd in 2010. In addition they made it to the State Marching Contest in 2007 as a 2A and in 2011 as a 1A. In spite of being a poor school district with no ready financial resources other than dry land cotton, Tahoka has succeeded at a high standard with students making the ATSSB All-State Band, plus having several performances make the state finals of OPS. Support for the band is phenomenal with 200-300 people attending marching contests each year.

The past two years Carroll has served as the ATSSB 1A State Representative and has worked with others in seeking to establish a 1A-2A All State Band, which he hopes he can continue to do.

He is in his nineteenth year of teaching and has taught in Oklahoma and Arkansas as well as Texas. In addition to teaching, Mike serves as ATSSB Region 3 coordinator and state board member and is a member of the ATSSB State Audition Review Committee.

Bands under Mr. Bartley's direction have been consistent UIL sweepstakes winners. He is a member of ATSSB, the Texas Music Educators Association, the Texas Bandmasters Association and the Texas Music Adjudicators Association. He is active as a judge of concert, marching, and solo/ ensemble competitions.

Mike and his wife, Jenny, who is also a music educator, have been married for nineteen years and reside in Canton. They have two children. Daniel, age 9, is a fourth grader at Canton Intermediate School, and Matthew, age 6, is a first grader at Canton Elementary School.

ATSSB All-State Housing

TMEA is proud to host the online housing system for the directors and members of the TMEA/ ATSSB All-State Bands for 2012. All ATSSB All-State members and their designated chaperons will be assigned to the Hyatt Regency Hotel. All three ATSSB All-State organizations will rehearse in the Hyatt Regency. The Symphonic Band will use Regency East Ballroom, the Concert Band the Regency West, and the Jazz Ensemble the Rio Grande Ballroom.

The housing system will open the Monday after Area auditions in January. It will be imperative that all five ATSSB Area hosts send their respective FileMaker Pro tabulation results file to TMEA and ATSSB via email on the Saturday evening of the area audition date.

The process for registering students and chaperons for ATSSB All-State housing is:

Room Planning — Complete on January 7!

1. Once All-State students are selected at Area auditions, use the worksheets provided by the Area Chair/Host and work with other directors to plan rooms with four students **before leaving the audition site**.

2. Decide which director will be responsible for entering these rooms on Jan 9–10, who the Designated Chaperon will be for each student and take the worksheet(s) home to complete the entries.

3. Log in Jan. 9 to enter hotel choices, billing, and to enter these students into rooms.

The housing system will allow you to select students assigned to you, or, from your campus, your district, Region, or Area. To select students other than yours, obtain agreement from their directors (their contact information will be listed with their students in the housing system).

Online Entry: Jan. 9-10, 2012 ONLY The system will close at 4 pm on January 10th

2. Enter Billing Information/The hotel choice is set to Hyatt Regency Enter your credit card information for your student and chaperon rooms.
