Executive Secretary's Column by Kenneth L. Griffin



Your membership expires on July 31 this year, so if you plan to enter students into jazz auditions which are always early, be sure to join for 2016-17 as soon as you can to avoid errors while entering students. Check the Directory in the left sidebar of the website to see if you are a member for 2016-17. You must have a 2016-17 ATSSB ID to see the Directory (TMEA will not allow you to view the Directory unless you are an ATSSB member for 2016-17). If you are not yet a member for next year, fill out the application online: (http://www.123contactform.com/form-661949/Contact-

Form) with the changes (you need only list name and school and any changes - we already have the other posted data in the database) and then send payment when your school budget year begins - or go ahead and send in the check or school Purchase Order now while you are thinking about it. Dues for Active Members are \$50, but remember that after October 1, the dues increase to \$75 unless you are joining as an Associate Member or College Division Member (everything is the same, you just cannot run for office, vote, or enter students in any ATSSB competition). Retirees who retire as an Active Member retain their Active Membership but dues are reduced to \$25 per year. A cover page showing your ATSSB and TMEA membership card must be sent with the initial entry forms for the first audition entered (ATSSB or TMEA). Don't forget that if you enter students in the Jazz Ensemble competitions that audition deadlines are EARLY, so get your ATSSB and TMEA dues taken care of as soon as possible. I email a copy of your card as soon as I receive payment of dues, so be sure we have an accurate email address for you and that your school does not block mail from this office (attachments trigger spamguards, so make sure we are allowed).

Don't forget, a lot of schools are now in new regions due to the realignment, so check this link to see the region to which your ISD is assigned (ATSSB has organized the 33 UIL regions into 22 ATSSB regions): http://align.tmea.org/index. php. See the following link to see how ATSSB is organized into 22 regions and five areas: http://www.atssb.org/execsec/ATSSB_Area_Alignment_2016-18.pdf.

In your fall region meetings, you need to nominate a Class 1C/2C Representative and a Class 3A Representative to the State Board of Directors along with a President-Elect. The election will be held at the General Session tentatively

scheduled for Thursday, February 9, 2017, at 3:30 p.m. in Room 202 of the Convention Center. After nominees have accepted their nominations, their pictures and biographies (if submitted) will appear in the online December Newsletter, so keep an eye out for that issue. Please get involved in the district, region, and area activities of ATSSB - and seek state office if you would like to serve at that level. It is a lot of work, requires a lot of time and effort, and entails constant contact with fellow officers, but the end results are very worthwhile (and obviously beneficial to our students and ATSSB in general).

The Prescribed Audition List Update (Use Year A) is now available online: http://www.atssb.org/execsec/YearAUpdate.17.pdf. We do not mail a copy of the Update to all high school band directors and members with the September Newsletter (the ATSSB Website is the official document of ATSSB). The September Newsletter will be mailed, but only to include a free copy of the 2016 OPS winners CD as a reference tool for our directors. All Newsletters are now available online as a pdf file. If you have lost or misplaced your PAL, you will have to download the page(s) you need from the website.

This coming year, Joseph P. Missal (Oklahoma State University) will be the clinician for the Symphonic Band. The Symphonic Band will play a piece commissioned by ATSSB from Johnnie Vinson. Ellen Rowe (University of Michigan) will be the clinician for the Jazz Ensemble. Jeff Gershman (Capitol University, Columbus, Ohio) will be the Concert Band clinician.

Good luck as you begin another year with your students, especially if you are at a new school (be sure to let us know your new address).

Outstanding Performance Series

The deadline for entering the 2016 OPS competition was May 20th. Since that time I have already had Region Coordinators calling to let me know that some of our directors did not follow the entry instructions shown on page 4 of the OPS forms. The instructions for entering are very clear. I wish I could do what is necessary to make our membership understand the importance of reading instructions! I have already had to disqualify several entries due to fact that the directors simply did not follow the instructions. The last thing that the Region Coordinators and I want to do is to disqualify a band director's entry. Please take the time to make sure that you use the correct form for each entry, and listen to the CDs before you mail them to make sure the name of your school is not announced (like

they sometimes do at UIL contest) right before the band starts playing.

The date for the State Adjudication for the 2016 Outstanding Performance Series is Thursday, July 21st, in the San Antonio Convention Center. The judges' meeting will be held in room CC 007 at 8:00 AM. Please be punctual! The Class 1C bands will be heard in room CC 004 at 8:30 AM, and the Class 3A bands will be heard in the same room beginning at 11:00 AM. The Class 2C bands will be heard at 8:30 AM in room CC 005 followed by the 1A/2A bands in the same room at 11:00 AM. The Class 4A bands will be heard in room CC 007 at 8:30 AM followed by the SARC Committee meeting. You are all cordially invited to attend these sessions. I know you will hear some very fine bands.

I hope every Region Coordinator took the time to listen to every CD before advancing them to the Area level! In some cases, every classification does not have enough entries for a try-out so the CDs are just simply sent to the next level without having been heard. Please do not do that. I have had to disqualify some entries in the past because when heard at the Area level, the school's name was heard at the beginning. This is one of those times that the CD should have been disqualified at the Region level, not the Area level.

I will soon be contacting directors and asking them to judge/monitor at the State Adjudication. I want to put one judge from each Area on every panel. I always call the directors with the most experience first. Also, if you judged at the State level last year, I will not be calling you this year. All judges and monitors will receive a \$75.00 honorarium for their service.

I wish you the best of luck in this year's OPS competition, and I hope you have a restful summer! See you at TBA!
