

I know many of you are probably anxious about the new alignment and what it means to you and your program. Please rest assured that much thought went into the alignment by many parties. Dick Floyd and George Strickland obviously spent much time and effort balancing bands in all classes for UIL purposes - all the while attempting to satisfy TMEA that the alignment meets its desires to balance bands in its region and areas. The ATSSB leadership met with Mr. Floyd and Mr. Strickland in La Grange over supper and a meeting to go over the proposal. They were seeking our input to see how it might affect ATSSB. I appreciate their concerns and willingness to listen to our suggestions. Lets give the alignment a year to se how it really works for all of us. You may be going to UIL contests in one region but auditioning for ATSSB All-Region in another (combined regions).



Be sure to attend your spring region meetings - especially in the new alignments - to elect new Region Coordinators where needed and set up your auditions for next year (sites, dates, clinics, suggested clinicians, etc.).

Interesting fact about the 2006 All-State Bands: The membership included 17 freshmen (up from 11 last year), 36 sophomores (down from 47 last year), 98 juniors (up from 89 last year), and 109 seniors (down from 113 last year).

**HOUSING** - Susan Scott did a fantastic job as the Floor Monitor Coordinator this year. Organizing the hotel checkin and making sure the kids were safe in the hotel is very important to small-school band directors. We had zero problems with students this year. A lot of this was due to the efforts of Susan and the Floor Monitors, but also to you directors for preparing your students for the clinic. Thank you for a really smooth time this year.

**ORGANIZERS** - Eric Gray and his crew did a wonderful (and unusually quick) job with State Chair Auditions. It is no small task assembling all of those panels of volunteer judges and securing stands and screens and the forms and pencils necessary and the computers and printers. Thanks again, Eric, for all of your hard work, and to Mark Melton and Rami Purdum for serving as Office Managers for the auditions - manning the computers and checking all that math. And thanks to all of the directors who volunteered their time to sit on judging panels, monitor, run errands, etc., to make the auditions run smoothly. Bruce Kenner and David De Luca had to give up most of their convention to serve as Band Organizers as did Ray Schneider and Bob McClure as Percussion Organizers. I especially want to thank Bob Vetter for volunteering for the second year in a row to stay up late on Wednesday night helping me proofread the roster of bands for the programs.

Interesting facts about the 2006 All-State Bands: Canyon, Port Isabel, and Rio Hondo had 7 students make All-State; Kountze, Midland Greenwood, and Wills Point each had 6; Brownfield and Argyle each had 5; Canton, Glen Rose, Needville, Reagan County, Shiner, and Spring Hill each had 4. Twelve schools had 3 students make All-State. Twenty-seven schools had 2 students and ninety-seven other schools had 1 student make All-State. In all, 150 different schools were represented in the ATSSB All-State Bands.

**OPS** - The **Outstanding Performance Series** was once again a great success in 2005 and the beautiful award the winners received in the General Session on Thursday is an enviable trophy to

be seen in band halls across the state. The runner-up plaque was beautiful also, befitting the great honor these bands received from their peers. Congratulations to the winners and runners-up. I look forward to this year's competition and hope many of you enter your band's performance(s) from a contest this year. Don Thoede, OPS State Chair, will tell you more about the 2006 OPS elsewhere in the Newsletter. Be sure to read his article carefully, as many changes have been made.

**DIRECTORY** - An ATSSB **Membership Directory** is available on the Website (http://www. atssb.org/execsec/Directory.06.htm). You can view it (it is arranged alphabetically) or copy and paste all of the information into an Excel spreadsheet so you can use the data as you see fit. Since the State Board has voted that the ATSSB Website is the official document, we no longer print the Directory (or anything else for mailout). All documents must be viewed/printed/downloaded from the Website in the future. By the way, the State Board decided that wee would keep the Directory available as is even though a few have expressed concerns about getting spam since your email address is listed in it (and some people can ferret out that information and sell it to spammers). If you do not want your email address listed in the Directory, be sure to let me know and I will take it off (then do not put that on the application when you rejoin next year).

Interesting facts about the 2006 All-State Band: The band had 121 females and 139 males.

**AREA FEE INCREASE** - The State Board voted to increase Area fees to \$20 beginning with the 2006-07 year to cover the increased cost of administering the auditions and the state clinic.

**HOTEL OCCUPANCY TAX EXEMPTION** - One more piece of paper is going to be required for state! If your student makes state and is going to stay in the Emily Morgan Hotel, you must submit a signed Hotel Occupancy Tax Exemption form along with payment of the Hotel Fee. Also, the State Board voted to charge schools a \$100 late fee if the hotel fee is not paid by check or school PO by the deadline./ We did not charge that fee this year (there would be a LOT of unhappy directors and business offices if we did), but might have to do so in the future if it continues to be a problem. Please get the paperwork filed on Monday after Area next year. Have the school fax a PO if they can't cut a check that day! An d be sure to attach the Hotel Occupancy Tax Exemption form that is completed and signed by your school.

**APPLICATION** - There is a **Membership Application** in this Newsletter and on the Website that you can download and use or give to your assistants or to share with neighbors. Membership renewal reminders will not be sent this summer, so use the one available online or linked here to join as soon as you can in the new budget year (although we surely do appreciate all of the scholarship contributions you make when you join after October 1!). There is also a College Division Membership application available here and online. Give one to your senior bandsmen that might be considering music as a major or minor in college.

**PAL** - The Prescribed Audition List includes all known (and SARC-approved) errata to date on each of the etude pages. Be sure you are using the current data from the Website since an Update will not be mailed or passed out at TBA like we usually do (remember that the Website is the official document). We will be using YEAR A in the PAL for auditions in 2006-07. Watch the Website for the Year A Update.

Interesting facts about the 2006 All-State Bands: Of the 260 students in the bands, 25 were from class A schools (9.62% of the bands - up from 13 last year), 82 from class AA schools (31.54% - up from 81 last year), and 153 from class AAA schools (58.84% - down from 166 last year), all representing 150 different schools (up from 145 last year).

The **recording** of the All-State concerts is available on compact disc. You may still order plaques and T-shirts from the event. Use the order forms here or online to get yours today.

Use your contacts at colleges and universities across Texas (and beyond) to make sure that they give scholarships (all expenses paid) to ATSSB All-State students and tuition scholarships to ATSSB Area students for their **summer band camps** like some colleges do. Check out what the camp offers and then encourage your students to go where they are wanted. Several colleges have already contacted me wanting the All-State list so our students can be contacted about scholarship opportunities. More and more colleges are interested in our seniors each year. As you learn of colleges that provide scholarships for our All-State students, let me know so I can inform the membership.

Interesting facts about the 2006 All-State Bands: Of the 260 members, each of the 20 regions had an average of 13 students in the band. One region had 28 (the most) and two regions had none (the least).

Please let me know if you need to **replace a Region Coordinator** in your Spring Meeting. I need to have their name as soon as possible for our plans for 2006-07 (call me at 713-874-1151 and leave a message). Your Region Coordinator is your region's representative on the State Board of Directors which makes all of the decisions for you regarding ATSSB matters. Make sure he/she or a proxy attends each SBOD meeting. It would also be nice if each Region Coordinator brought a mandate of opinion from region members so votes could be representative of each region of the state.

ATSSB gave \$16,500 in scholarships this year. Michelle Eilers from Schulenburg, Elyse Kahler from Canyon, Kevin Nance from Brownfield, Dylan Thomas form Kountze , and Stephanie Vogler from Needville each received the **\$2000 ATSSB All-State Band Scholarship for making the band for four consecutive years**. Sara Curtis from Carlisle, Matthew DeFriend from Fairfield, Belyn Fowler from Mt. Vernon, Stephanie Gonzales from Canyon, Devon Hendrix from Sabine, Timothy Huck from Sweetwater, Nick Moore from Van, Casey Porter from Bellville, Natalie Sanders from Llano, Zachary Sims from Charlotte, Allison Smith from Clarksville, Joseph Tawney from Wimberley, Dale White from Port Isabel each were seniors that received the **\$500 ATSSB All-State Band Scholarship for making the band for three years**. All of these students were given a plaque in a brief ceremony during the concert. This makes forty-nine students who have received the fouryear scholarship to be given).

The large **10" ATSSB All-State Band patches** for the All-State Band members are still available should your student have neglected to purchase one at state. Send \$10 for each 10" patch to: ATSSB; 2117 Morse Street; Houston, TX 77019. Be sure to enclose name and address where you want them sent. We no longer have **OPS CD sets** available. You must order these from a secondary vendor as long as the limited supply holds out (that order form is also available here and online). Please be aware that we will no longer produce OPS CDs for sale. We will produce CDs in sufficient quantities to send one free CD to each eligible ATSSB school in Texas in September of each year. The State Board felt that this reference CD should be in every band hall in Texas.

Interesting facts about the 2006 ATSSB All-State Band: Over the last fourteen years, 3,046 students have been awarded All-State honors by ATSSB. Crane has had the most in All-State (76) followed by Brownfield (74) in Class AAA. In Class AA, Argyle has had 24 and El Dorado has had 21. In Class A, Overton has had 19.

My thanks to all of you for what you have done to make ATSSB what it is today.

# **Outstanding Performance Series** by Don Thoede, OPS State Chair



There have been some very important changes for the 2006 Outstanding Performance Series competition, and I recommend that you take the time to read this article very carefully, and also read the OPS instructions found in the OPS link on this website.

Most of you will be sending your CDs to a different Region Coordinator again this year. The SBOD feels that sending the CDs to a different Region Coordinator, called the Designated Region Coordinator, every year or two will prevent regions from judging the same bands year after year and in addition allow band directors the opportunity to hear bands from all over the

state. Personally, I think this is a good idea. Keeping that in mind, be sure you read the instructions carefully in the OPS pages. It states very clearly in the instructions where you send your CDs. After you mail your CDs, be sure you call your Designated Region Coordinator a few days later to make sure the CDs were received.

Over the years band directors have been making mistakes on the entry forms. In some cases, entry forms were incomplete, not signed by administrators, or information on the forms was incorrect. This has caused many problems for the Region Coordinators. To help eliminate these problems, the Region Coordinators have been instructed to DISQUALIFY all entries that are inaccurate, incomplete, not signed by administrators, etc., unless the corrected entry forms can be received by the Designated Coordinator prior to the CD adjudication. Sometimes this will be possible and sometimes it won't! Put yourself in the place of a Region Coordinator for just a moment. You have just received entry forms and CDs from sixty band directors. Your CD adjudication is two days away. You check the forms for accuracy and find that eight directors have not followed the instructions. You email those directors, if you can find their email addresses, or you try to call them on the phone to inform them that their entry forms have not been signed. If you are lucky, you reach all eight of the directors. Now the directors go into a mild panic trying to get new forms, and trying to find their Principals or Superintendents to sign the forms, and fax the forms back to their Designated Region Coordinators. In the mean time, the CD adjudication is about to commence two hundred miles away. I could continue with this scenario, but I think you get the point. The main idea here is to be sure you take the necessary time to read the instructions and follow them exactly as written. Make sure that you put the correct information on the CD, not the CD case! There is a picture of a CD showing the information that needs to be put on the CD in the OPS instructions. Be sure your look at that carefully! Again, if you don't put the information on the CD, it is highly likely that your entries will be disqualified! I don't know how to be more emphatic. To make

it even worse, your entry fees will not be refunded! The deadline for entries is still May 20<sup>th</sup>. Be sure you mail your entries prior to that deadline, if possible. The more time the Designated Region Coordinators have to check the entries, the more time you have to get them corrected, if necessary. My suggestion to you is to do it correctly the first time.

All OPS judges this year may be given a \$60.00 honorarium. This is up from \$35.00 last year. I know it is not as much as it should be, but we are trying. In addition, all Region and Area Coordinators may be paid a \$75.00 honorarium. A big "thank you" is in order for all of you who will give up your time to judge these events in May, June, and July. OPS would not be possible without the band directors that judge these region, area, and state competitions, and without the Region and Area Coordinators who host the events.

I want to remind everyone about the "Non-UIL Contest Approval Form". If you plan on entering a CD that was recorded at a non-UIL contest, you must submit that form to the State Chair on or before May 1, 2006. You will find the form in the OPS section on this website along with a list of festivals that are already approved. If the festival you plan on entering is on the approved list, you will not need to send me a form.

I hope all of you have a very successful spring, especially at UIL Contest. As always, if you need assistance, email me or call me and I will be happy to help you.

# State Jazz Coordinator Column by Ellis Kilgore

My name is Ellis Kilgore, the current Head Band Director in Malakoff. I will be serving as the ATSSB State Jazz Chairman for the 2006-2007 school. First of all, allow me to thank John Young of Wills Point for doing such a wonderful job with the 2005-2006 ATSSB All-State Jazz Band. The concert was a roaring success and played to a "packed house" at the Scottish Rite Auditorium.

One thing I want directors to realize is that you do not have to have a background in jazz in order to have your kids participate in the Region/State jazz experience. You're not even required to have a jazz band in your own school! The ATSSB jazz auditions are for anyone who can play saxophone, trumpet, trombone, or rhythm instruments. It is an excellent way for students to experience the Region Band clinic and concert, even if they do not qualify for the All-Region Concert band. It's also another avenue for your better students to qualify for All-State.

The trick to being successful for the ATSSB jazz auditions is to get the music early! If you get the music to your kids as soon as possible after UIL Concert and Sightreading this Spring, you can work the audition music with them before the end of school, then send them off for the summer where they can work on their own at home! The kids who want to be in the All-Region (or All-State) jazz band will be willing to practice at home IF they have the music (and it helps their marching band "chops" if they've been playing through the summer). This year's music will be will be Set A, and the first mailing will be sent in early April. The order form is currently up and receiving orders at http://www.matteimusicservices.com.

Each instrument on the CD will be able to play along with the full Jazz band minus their specific instrument, for practice purposes. The quality is superb and should be a great help to all musicians involved. Please make sure that you understand the expectations of the recorded audition CD. Any CD that does not meet the requirements will be disqualified for the 2006–2007 school year. If you have any questions on this, do not hesitate to contact me. I'll be happy to help in any way I can.

There are some very important procedures that you need to understand before auditions happen in your Region on the Area level:

1. Remember that this year is Set A.

2. After selection to the area level of the All-State Jazz Band audition you must follow the rules and guidelines of the PAL. There are suggested recording recommendations

for the recording of AREA student audition CD's.

3. Please familiarize yourself with the rules and guidelines(http://www.atssb.org/ execsec/JazzRules07.pdf). All audition material MUST BE performed as instructed in the PAL.

4. More detailed information will be available as we get closer to summer.

Region Coordinators are the most important link to a successful All State Jazz Band auditions. The preparation for recording the Area students will be the responsibility of the region. - Meeting **called to order** at 7:30 a.m.
- **Invocation** by Mike Miller of Rusk. **Oath of Office** administered by Kenneth Griffin.
- **Minutes** of the SBOD meeting July 23, 2005 were approved as printed in the September Newsletter after a motion by John Odom and a second by Fred Angerstein.
- There were no reports of **Special Committees**
- Heard reports of **Standing Committees**:
  - President-Elect and SARC Chair Rob Toups thanked his committee members for their work and reported State Audition Review Committee motions:
    - Increase **jazz trumpet and trombone entries** by one so that up to three trumpets and up to three trombones may advance to Area.
    - Change the wording of the Jazz Year E audition chart No. 2 "High Line Bossa" to read: for audition: play from beginning through the end of measure 56.
    - Clarify timpani auditions so that students who audition on timpani have one minute to tune before each etude with pedals lowered to the floor after each etude is performed.
    - Motion by committee, second by Jim Jones. Motion carried.
  - There was no report from the Past-President Committee.
- In the **OPS Report** by Don Thoede, he asked for direction regarding accuracy of entry procedures. The consensus of the State Board was as follows:
  - If the band director of the entering school does not follow the instructions for entering the OPS competition completely and accurately, including writing the correct information on the CD, that school will be disqualified if all corrections by the band director are not made prior to the start of the CD adjudication.
  - OPS entry fees will not be refunded after disqualification.
- **President's Report** by Steven Moore:
  - Updated the Board on appointments he had made: Area East Coordinator Mark Melton, Area North Coordinator John Mayo, State Jazz Coordinator Ellis Kilgore of Malakoff, and State Jazz Ensemble Organizer Tim Schodowsky of Quitman.
- **Executive Secretary's Report** by Kenneth Griffin:
  - He reminded Region Coordinators who still owed for **region patches** to please get accounts current.
  - Gave a **Scholarship Report** in which it was determined that one student who was listed as a threeyear recipient was only a junior. Mr. Griffin researched the issue and found that to be true so a correction was made in the number of \$500 scholarships being given this year.

- He noted that the \$100 late fee for those not paying the hotel fee on time was not enforced this year due to the high volume of schools that did not make the deadline. Suggestions as to how to expedite the process would be most appreciated.
- There was no old business.
- Under new business:
  - After much discussion, Kenneth Griffin moved and Brandon Brewer seconded that the **jazz ensemble CD adjudication entry** be increased to \$40 and the Area fee increased to \$20 with Area reimbursement limited to \$5 per student. Motion carried.
  - After much discussion, the Region and Area alignment for 2006-07 was approved as submitted (see attached) on a motion by Fred Angerstein and a second by John Odom.
  - After a discussion regarding email addresses in the Directory on the website, it was determined that the Directory was a useful tool and should remain as it is and that Mr. Griffin should just remove the email addresses of those who complain.
  - After a discussion regarding entry fees, Brandon Brewer moved and Stephen Henry seconded that entry fees must be paid for students entered and certified in the entry process at any level and that fees are not refundable. Motion carried.
  - Dr. Ray Garza asked about the rehearsal attendance policy at state as it applies to the Rodeo and Stock Show. The students sign a form noting that rehearsals may not be missed to attend an extra-curricular event (playoff game or stock show, etc.). However, if the student will miss no more than one hour of rehearsals to attend an event of this nature, permission may be granted on a case-by-case basis.
  - Tie-breaking procedures were questioned by Dr. Garza. Mr. Griffin responded that the software program breaks ties correctly and that the Prescribed Audition List shows a discrepancy in the procedure due to the inadvertent use of the term "judges' preference" at one point. He stated that the PAL would be corrected through the SARC.
  - Dr. Garza raised the question of an A/AA All-State Band once again which led to a spirited discussion. The issue was remanded to the SARC on a motion by Brandon Brewer and a second by Greg Miller.
  - Jim Jones raised the possibility of moving the all-state clinic/concert to the convention center. It was noted that through the ATSSB/TMEA Dialogue Committee, TMEA offered a ballroom for ATSSB to use for its all-state performance, but the State Board respectfully declined the offer. It was noted that, due to construction of the hotel next to the convention center, even TMEA will have restricted use of the Lila Cockrell Theater soon. No action was taken regarding this issue, although it was noted that we should be aiming in that direction.
  - Jim Jones detailed how the UIL State Executive Board (made up of superintendents) deliberated issues with help and clarification from George Strickland. It was suggested that we try to get ATSSB representation on the Technical Advisory Committee. Mr. Strickland suggested that we might see better success if we go through the various region committees to get to the Technical Advisory Committee.
  - On a motion by John Odom and a second by Jim Jones, the General Session was set for Thursday, February 16, 2006, at 12:30 p.m. in CC Ballroom C1. Motion carried.

#### Minutes of the February ATSSB General Session

The General Session of ATSSB met in the Convention Center Ballroom C-1 on Thursday, February 16, 2006, with approximately 200 in attendance. President Steven Moore called the meeting to order at **12:38 p.m**.

Ben Davis from Lindale gave the invocation.

Mr. Moore introduced TMEA President **Kerry Taylor**. Mr. Taylor gave words of welcome to ATSSB from TMEA, speaking of the importance and influence ATSSB has had and continues to have on TMEA activities.

Mr. Moore also introduced TMEA President-Elect Jo Scurlock-Dillard and Band Division Vice-President Steve Andre.

For the office of TMEA President-Elect, Fred Pankratz spoke for Mike Watts and Bruce Kenner spoke for J.D. Janda.

Mr. Moore explained that Jim Jones had been elected ATSSB President Pro Tem and that his name was to be removed from the ballot for Class AAA Representative. He the introduced the nominees for Class A Representative (E. Zane Polson and Charles Sander) and asked for nominations from the floor. Hearing none, he introduced the nominees for Class AAA Representative (Rodney Bennett, Mike Sheffield, Bobby Richardson, Steven Smith, and John Young) and asked for nominations from the floor. Mr. Moore reported positions he had recently filled: Ellis Kilgore as State Jazz Coordinator for 2006-07, Tim Schodowski as State Jazz Ensemble Organizer for the 2007 Clinic, Mark Melton as Area East Coordinator, and John Mayo as Area West Coordinator. He reported on State Board of Directors action, including increasing the Area fee to \$20, increasing the Jazz CD Adjudication fee to \$40, Region and Area alignment for 2006-07, making entry fees due and non-refundable at entry, the approval of ATSSBsponsored clinics at TBA, and the election of President Pro Tem Jim Jones. He thanked the members for his time of service and received an ovation from the membership.

Mr. Moore then announced the results of the **election**: **E. Zane Polson** was elected Class A Representative and **John Young** was elected Class AAA Representative.

In the Executive Secretary's report, Kenneth Griffin thanked Fruhauf Uniforms for providing the All-State Band shoulder patches for the students and all of the coordinators at every level of the audition process for the dedication and hard work to make the all-state band come to pass. He reported on all-state statistics: Rio Hondo, Port Isabel and Canyon had 7 students in all-state, Wills Point, Kountze and Greenwood each had 6, Brownfield and Argyle each had 5, Spring Hill, Shiner, Reagan County, Need-ville, Glen Rose, and Canton each had 4, 12 schools had 3, 27 schools had 2, and 97 school each had 1 in all-state for a total of 150 different schools represented in all-state. There are 121 females and 139 males. There are 17 freshmen, 36 sophomores, 987 juniors, and 109 seniors. There are 25 Class A, 82 Class AA and 153 Class AAA schools represented in all-state.

Mr. Moore then presented a plaque of appreciation to **Randy Hunsaker** and **Jim Jones** for their two years of service as Class A and AAA Representatives to the SBOD.

There being no old or new business, Mr. Moore adjourned the meeting on a motion by Sean Hill and a second by Mark Melton.

In Memoriam

Ed Lowes retired in 2005 after being diagnosed with cancer. He fought the disease courageously for a year, passing away Sunday, March 5, 2006. He taught for thirty years at La Grange High School, a class AAA school in Region XVIII in central Texas. He was a member of ATSSB, TMEA, TBA, TMAA, Phi Mu Alpha Sinfonia and TSTA. He was also the Emergency "ham radio" Communications Officer for the city of La Grange and Fayette County. He served as organist for 15 years at St. Paul Lutheran Church in La Grange and as the sub organist at Swiss Alp Lutheran Church.

Mr. Lowes was recognized for leadership and positively influencing the character of hundreds of young people while taking part in various church and civic activities by the La Grange Rotary Club. He was the recipient of the 1996-97 UIL Denius Sponsor

Excellence Award by La Grange High School. The high school bands at La Grange earned numerous superior first division ratings, Sweepstakes Awards, advancement to the area marching finals and placed in the top three positions at the Blinn College Marching Festival for a number of years. His 1998 concert band placed 3rd at TMEA area honor band competitions. His concert bands also placed in the ATSSB Outstanding Performance Series. He served at numerous TMAA concert band-judging events in the State of Texas.

Mr. Lowes earned a Bachelor of Music Degree in Piano Performance from Southwest Texas State University in 1972. He also earned a Master of Music degree from SWT in 1986. He was a student of Ken Turner at Highlands High School in San Antonio from 1963-67.

Mr. Lowes served Region XVIII as band division secretary, A, 2A, 3A UIL organizer, TMEA region band organizer from the early 80's and continued as ATSSB region coordinator and area central coordinator. He assisted in selecting and acquiring all the UIL marching, concert & sight-reading judges for Class C/CC/A/AA/AAA bands in region eighteen as well as all the clinicians for the middle school and high school region bands. Under his sponsorship, the region bands have had nationally known composers and conductors.

Mr. Lowes's wife Ann was the assistant band director at La Grange High School for twenty years. She worked for a time as an assistant director in Bastrop but resigned to take his position as band director at La Grange High School after his retirement. Ed leaves behind his wife Ann and four children: Harold, Catherine, Christopher, and Donnie.
