We need to thank Richard Floyd and George Strickland, from the UIL Music Office, for nominating Kenneth for this award.

The Class A Honor Band was Carlisle High School, Scott Rhame, director. They played a fantastic concert that was very impressive. Aubrey High School was the Class AA Honor Band. The Aubrey band is under the direction of Ron Chapman and they too played a great concert. I applaud each of these groups and their directors on this outstanding accomplishment.

We had many new challenges this year. The check-in at the Hyatt will be addressed. It would help if directors pay for their hotel room in advance. This way, the Hyatt will have packets with keys ready upon arrival. We are working with the hotel to make check-in a much smoother process. Please let your students know they will get a free breakfast again next year. The hotel had a Continental Breakfast set-up each morning at 6:30 a.m. This was located immediately outside of the rehearsal rooms.

The Texas Ballroom at the new Grand Hyatt was a spectacular venue for our concerts. The acoustics were much better and the room was magnificent. Until we can get into the theater, this is a very good site for our final concerts.

At the State Board Meeting, we looked at many issues that impact our young people and the All State process. A subject that has been discussed for many years is the formation of a 1A-2A All State Band. To look at the feasibility of this, I have named a committee to research and report back to the State Board at our meeting in July. This committee will look at all aspects including current participation from each classification.

The committee includes our three High School State Class Representatives: Carroll Rhodes, Tahoka (1A); David Rollins, Denver City (2A); and John Young, Wills Point (3A). Also serving are Brad Walker, Bovina (1A), Mike Marsh, Founding Father and first President of ATSSB, Howe (2A) and Steve Sanchez, Pearsall (3A). Our President-Elect, Brandon Brewer, will chair this committee. George Strickland from the UIL office has volunteered to provide technical data.

As we look at the possibilities, we must be cognizant of our relationship with TMEA. Anything we do must be justifiable with concrete numbers that will show a true need. There are other divisions that would like to see additional groups. We are not alone in our quest for what we feel is best for our students.

As I finish this article, it is hard to imagine that in six days my group goes to UIL. I hope each of you has a wonderful concert season. Keep making music and good luck! /

Executive Secretary's Column

TMEA was able to book the entire Hyatt Regency Hotel this year and not only offered ATSSB rehearsal space for all of its ensembles, but also to house all students and their designated chaperones. The ATSSB State Board accepted TMEA's gracious offer. While there were noticeable problems checking in (we will work with them to make it easier) and the elevators were slow (probably not as slow as the OTHER hotel!), it was great to be able to visit all three ensembles in rehearsal without walking all over town. The concert in the Grand Hyatt Texas Ballroom was also a pleasure in that the acoustics were noticeably better than Ballroom A and standing-room-only crowds showed the great interest the ensembles attract. We ran out of the 2200 programs that were printed for the concerts if that gives you an indication of attendance figures. We appreciate Bob Floyd, Frank Coachman and the TMEA Executive Board for their generous offers to ATSSB over the past few years. Both associations are



enjoying a professional affiliation due to the diligence and sincerity of their respective leaders. Interesting fact about the 2010 All-State Bands: The membership included 13 freshmen (up 2 from last year), 40 sophomores (same as last year), 79 juniors (down 11 from last year), and 128 seniors (up 7 from last year).

HOUSING - To make housing easier next year, be sure to send payment for your rooms early so when you arrive you can simply pick up your room keys. If you must bring a PO or check with you to San Antonio, plan to spend time in line checking in, especially if you have multiple students/chaperones with whom you are dealing.

ORGANIZERS - Eric Gray from Gilmer and his crew did another incredible job with State Chair Auditions. It is no small task assembling all of those panels of volunteer judges and screens and the forms and pencils necessary and the computers and printers. Thanks again, Eric, for all of your hard work, and to Collin Anderson from Groesbeck and Bryant Harris from Iraan for serving in the Auditions Office - manning the computers and checking all that math. And thanks to all of the directors who volunteered their time to sit on judging panels, monitor, run errands, etc., to make the auditions run smoothly. Kyle White from Grand Saline, Nathan Templeton from Gladewater and Jason Steele from White Oak (along with Organizer Apprentice Aaron Handorf) had to give up most of their convention to serve as Band Organizers as did Daniel Curry from Kaufman and Bobby Halamicek from Brady as Percussion Organizers. I also want to thank Brandon Brewer for volunteering to stay up late on Wednesday night helping me proofread the roster of bands for the programs.

Interesting facts about the 2010 All-State Bands: Greenwood had 12 (tying the record with Argyle who had 12 in 2008); Port Isabel had 9 students make All-State; Palestine had 8; Argyle had 6; Commerce, Fredericksburg, Hidalgo, Howe, and Rio Hondo each had 5; Brownsboro, Crane, Kennedale, and Kountze had 4. Ten schools had 3 students make All-State. Thirty-one schools had 2 students and eighty-seven other schools had 1 student make All-State. In all, 142 different schools were represented in the ATSSB All-State Bands.

ALL-STATE STUDENT MEETING - I enjoyed the Texas A&M University-Commerce Trombone Choir and their performance for the assembling All-State students. TAMU-Commerce Director of Instrumental Activities introduced the Choir, led by Jimmy Clark. I was a member of the Trombone

Choir "back in the days" under Neil Humfeld. That choir was good, but has come a long way since I was in it! We appreciate their giving of their time and talent to entertain our students prior to their meeting.

OPS - The **Outstanding Performance Series** was once again a great success in 2009 and the beautiful award the winners received in the General Session on Thursday is an enviable trophy to be seen in band halls across the state. The runner-up plaque was beautiful also, befitting the great honor these bands received from their peers. Congratulations to the winners and runners-up. I look forward to this year's competition and hope many of you enter your band's performance(s) from a contest this year. Don Thoede, OPS State Chair, will tell you more about the 2010 OPS elsewhere in the Newsletter. Be sure to read his article carefully, as many changes have been made - especially in where your CD entries are to be sent.

Please be aware that we no longer produce OPS CDs for sale. We produce CDs in sufficient quantities to send one free CD to each eligible ATSSB school in Texas in September of each year. The State Board felt that this reference CD should be in every band hall in Texas.

DIRECTORY - An ATSSB **Membership Directory** is available on the Website (http://www.atssb. org/execsec/Directory.10.htm). You can view it (it is arranged alphabetically) or copy and paste all of the information into an Excel spreadsheet so you can use the data as you see fit. Since the State Board has voted that the ATSSB Website is the official document, we no longer print the Directory (or anything else for mailout). All documents must be viewed/printed/downloaded from the Website. By the way, the State Board decided that we would keep the Directory available as is even though a few have expressed concerns about getting spam since your email address is listed in it (and some people can ferret out that information and sell it to spammers). If you do not want your email address listed in the Directory, be sure to let me know and I will take it off (then do not put that on the application when you rejoin next year).

Interesting facts about the 2010 All-State Band: The band had 101 females and 159 males.

APPLICATION - There is a **Membership Application** in this Newsletter and on the Website that you can download and use or give to your assistants or to share with neighbors. Membership renewal reminders are not sent, so use the one available online or linked here to join as soon as you can in the new budget year (although we surely do appreciate all of the scholarship contributions you make when you join after October 1!). There is also a College Division Membership application available here and online. Give one to your senior bandsmen that might be considering music as a major or minor in college.

PAL - The Prescribed Audition List includes all known (and SARC-approved) errata to date on each of the etude pages. Be sure you are using the current data from the Website since an Update will not be mailed or passed out at TBA like we used to do (remember that the Website is the official document). We will be using YEAR E in the PAL for auditions in 2010-11. Watch the Website for the Year E Update - and remember that percussion auditions are unified.

Interesting facts about the 2010 All-State Bands: Of the 260 students in the bands, 13 were from class A schools (5.00% - down from 20 last year), 64 from class AA schools (24.62% - down from 73 last year), and 183 from class AAA schools (70.38% - up from 183 last year).

The **recording** of the All-State concerts is available on compact disc. Mark Custom Recording made a DVD of each performance. You may still order plaques and t-shirts from the event through Pepwear. You may also order the large 10" All-State patch from this office (\$10 each includes shipping). Use the order forms here or online to get yours today.

Use your contacts at colleges and universities across Texas (and beyond) to make sure that they

give scholarships (all expenses paid) to ATSSB All-State students and tuition scholarships to ATSSB Area students for their **summer band camps** like some colleges do. Check out what the camp offers and then encourage your students to go where they are wanted. Several colleges have already contacted me wanting the All-State list so our students can be contacted about scholarship opportunities. More and more colleges are interested in our seniors each year. As you learn of colleges that provide scholarships for our All-State students, let me know so I can inform the membership.

Interesting facts about the 2010 All-State Bands: Of the 260 members, each of the 20 regions had an average of 13 students in the band. One region had 29 (the most) and one region had two (the least).

Remember that Region Officers serve a two-year term, so if elections need to be held in your regions, go through the process in place to elect them. Then be sure to let me know if you **replaced a Region Coordinator** in your Spring Meeting. I need to have their name as soon as possible for our plans for 2010-11 (call me at 713-874-1151 and leave a message). Your Region Coordinator is your region's representative on the State Board of Directors which makes all of the decisions for you regarding ATSSB matters. Make sure he/she or a proxy attends each SBOD meeting. It would also be nice if each Region Coordinator brought a mandate of opinion from region members so votes could be representative of each region of the state. It would also be nice if each region kept their region webpage on the ATSSB website updated. Keep an eye on your region's page and volunteer to help keep it up to date if you are into web publishing and would like to help. The ATSSB State Board will send each Region a Fall Agenda, listing items each Region needs to address, so watch for those items.

ATSSB gave \$21,500 in scholarships this year. Seniors Elizabeth Baker from Greenwood (Flute), Jose Barrera from Hidalgo (Jazz Drums), Bobby Fabian from Monahans (Bass Clarinet), Leighandra Guenther from Kermit (Clarinet), Zach McCullough from Kaufer (Tuba), Colin Minkler from Port Isabel (Alto Saxophone) and Marissa Ruehle from Bellville (Clarinet) each received the \$2000 ATSSB All-State Band Scholarship for making the band for four consecutive years. Jose Aguilar from Hidalgo (Clarinet), Keaton Box from Gilmer (Unified Percussion), Zane Brown from Memphis (Trumpet), Maricruz Bustamante from Crystal City (Clarinet), Jonathan Chapman from Greenwood (Trumpet), Taylor Cook from Howe (French Horn), Zack Crosby from Prosper (Jazz Alto Sax), Dylan Drake from Anahuac (Jazz Trumpet), Cameron Edwards from North Hills (Trumpet), Christi Haines from Palestine (Clarinet), Tevin Harris from Pittsburg (Tuba), Dylan Janak from Canyon Lake (Trumpet), Jacob Medeiros from Rio Hondo (Unified Percussion), and Liset Najera from Crane (Bass Clarinet) each were seniors that received the \$500 ATSSB All-State Band Scholarship for making the band for three years. Priscilla Garcia from St. Joseph Academy in Brownsville also received the \$500 ATSSB All-State Band Scholarship for making the band her freshman, sophomore and junior years (she missed her senior year). All of these students were given a plaque in a brief ceremony during the concert. This makes seventy-three students who have received the four-year scholarship (the first twenty-three received a \$1000 scholarship until 2003 when the three-year \$500 scholarships were started and the four-year award was raised to \$2000) and one hundred thirty-four who have received the three-year scholarship (this is the eighth year for the three-year scholarship to be given). Since 1992, \$190,000 in scholarships have been awarded.

Interesting facts about the 2010 ATSSB All-State Band: Over the last nineteen years, 4,088 students have been awarded All-State honors by ATSSB. Midland Greenwood has had the most in All-State (96) followed by Crane (94) and Rio Hondo (66).

My thanks to all of you for what you have done to make ATSSB what it is today.

Outstanding Performance Series

The 2010 Outstanding Performance Series competition is just around the corner so be sure that you get your entries in on or before May 20, 2010! I hope you all do well at your UIL Concert & Sightreading Contests and that you get really good recordings to submit for competition in the 2010 Outstanding Performance Series.

Last year we had the fewest problems we have ever had due to the fact that all of you read and followed the instructions very carefully. I thank you for that. Remember that our Region and Area Coordinators have the authority to disqualify any entry that is late or incomplete, so please be thorough. Take a good look at "Page 5" in the OPS section on the ATSSB website and you will see a picture of a CD showing exactly how to put your school's information on the CD, not the case.



No one wants to be disqualified for not following instructions, so be very careful when filling out those forms.

A change has been made in how honorariums are determined for our judges. All judges and monitors will still receive a \$75.00 honorarium for judging up to 35 CDs. However, all judges and monitors will receive an additional \$2.50 for each CD judged over 35. For example, if you judge 50 CDs, your honorarium will be \$112.50. ($$75.00 + 15 \times $2.50 = 112.50) This will help make it more equitable around the state.

The information that follows is extremely important, and therefore I ask that all Region and Area Coordinators check the information carefully and make sure the information is accurate.

The General Session of ATSSB met in the Convention Center Ballroom C-202 on Thursday, February 11, 2010, with approximately 200 in attendance. President Bob Vetter called the meeting to order at 3:35 p.m.

Mark Melton from Union Grove gave the invocation.

Mr. Vetter introduced TMEA officers in attendance, then candidates for TMEA President-Elect were introduced. Ross Boothman spoke for himself and David Rollins spoke on behalf of Jimmy Evans.

The minutes of the General Session July 27, 2009, were approved as printed in the September Newsletter after a motion by Mark Melton from Union Grove and a second by Sean Hill from Grandview.

Mr. Vetter then introduced the candidates for the office of Class A Representative to the State Board of Directors: Brian Beeson from Windthorst, Stephen Krupicka from Shiner, Elizabeth Kriczky from Holland, Ken McSperitt from Cross Roads, and Carroll Rhodes from Tahoka. He asked for nominations from the floor and, hearing none, he declared nominations closed. He introduced the candidates for the office of Class AAA Representative to the State Board of Directors: Jacques Brown from Taylor, Doug Fulwood from Decatur, Steve Sanchez from Pearsall, and John Young from Wills Point. Mr. Vetter then asked for nominations from the floor and, hearing none, he declared the nominations closed. He asked for speakers for the candidates to step forward:

Rodney Bennett spoke for Brian Beeson, Colin Chichurka spoke for Stephen Krupicka, Elizabeth Kriczky spoke for herself, Mike Bartley spoke for Ken McSperitt, Matt Knight spoke for Carroll Rhodes, Wayne King spoke for Jacques Brown, J.B. Perry spoke for Doug Fulwood, Robert Gonzales spoke for Steve Sanchez, and John Young spoke for himself.

Kenneth Griffin instructed the membership on how to cast their ballots. Election Committee Chair Daniel Todd and his committee collected the ballots and counted them while the meeting continued.

George Strickland gave a UIL report, reminding the membership that TSSEC would be in Pflugerville at Henderson High School with one level, lots of room and lots of parking. He also noted that the PML will be going exclusively online in 2011 with annual updates (the Leaguer is already published online exclusively).

It was noted that the Composition Competition had been dissolved by the State Board of Directors since TMEA had partnered with State Farm to provide substantial rewards in a composition contest next year which includes a small-school category.

In the SARC report, Brandon Brewer thanked the SARC members for their work on the Committee and reported on action by the SARC that was approved by the SBOD: region rules online are to reflect the minimum amount of music that will be heard for region auditions; timpani tuning requirements were aligned; percussion warmups were aligned with winds, a policy for dealing with an ill judge was adopted, jazz ensemble auditions for bass were amended toad "acoustic" to the allowed instrument s for auditions; the SARC recommended that the ATSSB President name a committee to study the implementation of a 1A/2A All-State Band.

Immediate Past-President Rob Toups was unable to attend. Brandon Brewer noted that the committee would be working on a suggestion by George Strickland regarding a clinic which would include a performing ensemble and invited guest clinician. They would be investigating possible funding and logistics.

OPS State Chair Don Thoede presented the 2009 OPS winners and runners-up with their awards.

A thank-you note from the family of Louis Thornton was read by Mr. Vetter, noting that the All-State programs would have a section honoring Louis in Memoriam.

Mr. Vetter reported on action by the State Board of Directors.

Kenneth Griffin noted that it was nice to have lodging, chair auditions and rehearsals all in the same location, but recognized there were bumps in the process.

Mr. Vetter then presented a plaque of appreciation to E. Zane Polson and John Young for their service as Class A and AAA Representatives to the SBOD. Mr. Vetter then announced the results of the election: Carroll Rhodes was elected Class A Representative and John Young was re-elected Class AAA Representative.

There being no old or new business, Mr. Vetter adjourned the meeting at 4:34 p.m. on a motion by Mark Melton.

- Invocation by Bob Vetter. Oath of Office administered by Kenneth Griffin.
- **Minutes** of the SBOD meeting July 27, 2009 as printed in the September Newsletter were approved after a motion by Rod Rodiguez and a second by Matt Knight.
- Heard reports of Standing Committees:
 - President-Elect and SARC Chair Brandon Brewer thanked his committee members for their work (Bob McClure from Princeton, Greg Miller from Iowa Park, Mel Hadderton from Holliday, Carol Turner from Krum, Trey Singleton from McCamey, Carl Idlebird from Somerville, Chuck Moon from Ranchview, and Sean Hill from Grandview. He then presented State Audition Review Committee motions:
 - All regions will have in their region rules the **minimum amount of material** to hear in their region auditions. Motion by committee, second by Gehrig Blankenship. Motion carried.
 - **Remove** the sentence "Each student will be given one minute to tune the timpani" from Section IV.c.v. and move the next sentence "Timing will be done by the monitor." to iv., eliminating v. Motion by committee, second by Steve Sanchez. Motion carried.
 - Unify in both the Procedures and the Percussion Guidelines the statement regarding Percussion warm-up at Area for all three rounds: "If the individual student wishes to warm-up, they may play anything they wish for 15 seconds (timed by the monitor)." Motion by committee, second by Rod Rodriguez. Motion carried.
 - Add the phrase "an acoustic" to "1 Bass may be an electric bass guitar or an acoustic bass (also know as double bass or upright bass)." Motion by committee, second by Matt

Knight. Motion carried.

- Add to III.G. "If a judge becomes ill during the course of auditions, the judge should try to finish the current round. The ill judge will then be replaced by another director (reviewing the ill judge's ranks and ratings). If this is not possible, replace the judge, review judges ranks and ratings, then complete auditions." Motion by committee, second by Forrester Halamicek. Motion carried.
- The SARC voted to suggest that President Vetter appoint a committee to study the creation and implementation of a **1A/2A ATSSB All-State Band** and to bring a recommendation to the State Board of Directors for approval to send to the ATSSB membership for a vote. Mr. Vetter said he would include all classes and all areas of the state on the committee.
- Rob Toups, chair of the Past-President Committee, was absent due to personal circumstances. Brandon Brewer reported for him that the Past-President Committee would be working on a proposal from George Strickland regarding **sponsoring a clinic** using a performing ensemble and visiting director-clinician. Logistics and financing would have to be prepared.
- In the absence of Jennifer Willison, Composition Competition chair, Kenneth Griffin moved and Fred Pankratz seconded that the **competition be dissolved**. TMEA has partnered with State Farm to sponsor a funded composition contest that will provide substantial monetary rewards and will include a category for small schools. Motion carried. Mr. Griffin noted that he would pen a letter thanking Ms. Willison for her dedication and hard work making the ATSSB Composition Competition a success.
- In the **OPS Report** by Don Thoede, OPS State Chair, he asked that UPS addresses be corrected as soon as possible because they will be posted in the March Newsletter for where OPS entries will be sent. He suggested a new honorarium schedule for OPS adjudications: \$75 for judging up to 35 CDs and \$2.50 for each additional CD adjudicated. Mike Hardy moved that we accept the new schedule, seconded by Daniel Todd. Motion carried.
- **President's Report** by Bob Vetter:
 - He asked that if members have concerns regarding ATSSB activities that they be encouraged to submit proposals and plans for addressing the concerns, not just complain. He noted the adoption of the unified percussion procedures came about because of careful preparation and suggested implementation procedures along with a careful statistical study presented to the SARC. He also complimented Brad Walker for his presentation to the SARC regarding the 1A/2A All-State Band.

 - He asked that packages or mail addressed to him have signatures waived (use tracking or Delivery Confirmation if needed).

 - Gave a Scholarship Report which showed \$59,898.25 in the Scholarship Fund and that ATSSB would be awarding 17 \$500 and 7 \$2000 scholarships this year for a total of \$22,500. \$188,500 has been awarded to 207 students (135 3-year and 72 4-year). ATSSB Licensees have contributed \$97,683.76 to the Scholarship Fund over the years.
