### **Executive Secretary's Column** by Kenneth L. Griffin

I would like to encourage each of you to approach your superintendent with your own version of the resolution I used here in Van that recognizes ATSSB at the local level so your students can participate in ATSSB activities this year (see page 20). In past years, the Commissioner of Education kept a list of approved organizations (UIL, ATSSB, TMEA, etc.) that were allowed to utilize school days for competitions, etc. within the 10-day rule (with extensions for allstate activities). While each local board is allowed to adopt the list from past years, THEY DO NOT HAVE TO, so you need to make an effort to get ATSSB sanctioned by your local board of trustees by resolution.

Please look over any materials you receive from your Region Coordinators regarding auditions. The region auditions determine the Area Candidates from each of the regions in the state. Be sure you are aware of eligibility requirements and that you have taken care of all of the necessary paperwork (ATSSB membership, region entry fees, forms completed, etc.) in advance of auditions.

If you have students who are selected to audition at the ATSSB Area auditions January 11, make sure each one brings Form 11 and Form 15 properly completed and signed to the audition. Otherwise, they will not be allowed to audition at the Area level. These forms will be given you either at the Region audition or sent to those involved by the Area Coordinator when sending Area audition information.

Hotel space is at a premium of course in San Antonio, especially since we are housing twice the number of students this year, so make sure that you fill out Form 14 at Area securing space in the Ramada Emily Morgan Hotel for the clinic in San Antonio if you have a student selected for All-State. You may use Form 14 at Area to reserve a room for you (and others if you wish to share) at the same hotel as long as the rooms last.

Our ATSSB 4-Year All-State Scholarship is doing well now as contributions are continuing to come in (see the report elsewhere in the Newsletter). We have received donations from Regions 2, 3, 4, 5, 7, 11, 14, 16, and 19 along with a donation from an individual band

their performance, and they place a colored mark in the appropriate box beside their name. As you can imagine, the students who are prepared and confident will show up first. The others will not come until compelled. The students who come in early will almost all make I's. Even if we have to correct some minor flaws we will give them a I. Having these students very close to perfection early will make them much easier to polish in rehearsal. If they need a little more work, we give them a II and expect them to come back and raise it to a I! If the problems only happen in a certain place, we make a note on the back of their part and only hear that part on their return.

OK - what about the rest of the band? When I feel as though I've gotten all of the easy ones (Ha!) I merely set a deadline. At this point, the judging standards are tightened a little also. It is with this group that we begin to see more II's and III's. A II means minor memory or accuracy troubles, a III, more of the same.

Now, what about that last bunch - the reluctant seventh and eighth graders, those last chair children just enjoying being part, and the occasional capable player that just flat procrastinates? This is the group that will not even show up for the deadline! Now that I have a part-time assistant, he will pull these during band class until each is heard. This is often where IV's and V's unfortunately appear on our chart.

Once we've "charted" each band member, the real work begins. We focus two ways. For those students that have II's or III's, we keep them coming back again and again, pulling them up to their highest potential. in numerous activities, so the Executive Committee had directed Don Stockton to write a letter to the UIL suggesting the Area format and offering ATSSB's assistance should it be needed since it is already set up in Area configurations. It was suggested that the Area competition include medium ensembles and that it be held in late March.

Fred Pankratz questioned the date availability because of UIL conflicts and reserved dates, but it was decided that there was an available weekend in late March for the event to take place. sectional is as hard as convincing your superintendent you need that fourth new sousaphone!

We at Overton have been blessed with some success these last several years, and if I had to pinpoint the one tool I use to make it happen, I would point to the "Play-off Chart"(the chart is reproduced on page 19). Following is an explanation of how I use the chart. I hope it will help some of you overcome the small inconvenience we face of not being able to schedule sectionals. Scheduling a single student for 5 to 10 minutes is always possible, though sometimes requiring a little creativity.

My overall goal is to give every student a private lesson (or series of lessons if needed) to prepare their individual parts, checking both accuracy and memory. We are a military style marching band, and usually our drill will consist of two complete quickstep marches and half of a third. When we begin summer band, I attempt to narrow the list as to what we will play as quickly as possible. (I assume most corps style bands have an idea of music for their show even sooner, which is an advantage). As soon as I decide on the first march, I assign it to be played off, and place it on the 'chart'. The chart has each studentis name on the left side (usually sorted by grade, but some years in score order). Beside each name are three wide columns, and the name of the first march is listed at the top of the first column. The second and third marches are added as they are decided. Each column is divided into 5 sub-columns, with headings of I, II, III, IV, and V at the top. The whole chart looks like a big grid.

As the students play off, they are given a rating on

If your region has any discretionary funds - or if any individuals would like to contribute to this tax-exempt scholarship fund, please send your checks to me at the state office with the designation on the check that it is for the "ATSSB 4-Year All-State Band Scholarship Fund". Don't forget that this tax exemption also applies to estates - so you can even will your estates to it! We only have one student eligible to receive this scholarship this coming year (assuming the student makes it again!), but in coming years the number should increase with larger numbers selected to All-State. So please keep the scholarship in mind each year as you end up with any fund balances your region feels it can contribute to this worthy cause.

A personal word about the proposed changes to the Constitution These changes come to the membership with the approval of the State Board of Directors. As you can easily read, the rationale for the changes involves the possibility of using a retired band director for the position and placing the responsibility on the State Board of Directors for securing this person's service. Although the position would not be an elected one in the future, it is my intention to continue as your Executive Secretary. However, events occurring in my professional life might change my professional status (as close as I can say it at this time!). I have always said that the position is anyone's if the membership would like a change, but no one has ever come forward with the desire to serve in this capacity. We have many capable members who could do the job (many could do it better than I), but I am flattered that you think I am doing well enough that you would not desire a change at the present time. Thank you for your support of my efforts on behalf of ATSSB, but thank you also for your dedication to the profession and the Association -without you and the very strong leadership we have had at all levels, we would have floundered in the first few critical years.

higher rating. For those students who earned the lowest ratings, we do the same, realizing their highest potential may be just learning a few of the fingerings! We try to set realistic goals for each, then are firm in our demands that they meet them. At some point, I try to assess our progress and define the minimum overall rating required to be assured a spot in the contest drill. Only those students who have met their minimum goals will miss school to attend contest - a good incentive. Our concert contest play-off chart follows much the same guideline, but as you can well imagine, is not as traumatic for the student (or the director!).

Those of you teaching by yourselves are asking how to accomplish this? Let the kids schedule themselves, then expect them to show up! I did it for years by myself. I readily admit an assistant takes a big load off, but it can be done in a one director situation. We listen before school, during lunch, break time, any time. Our lessons never last over five to ten minutes, It is always possible to schedule time with an individual if you are creative enough.

Over time, this method has been accepted and is expected by the band members. I usually feel by the time we attend contest I am getting all I can from each individual. I go home most days soon after the last bell rings, my chart a little more complete and the kids happily involved somewhere else on campus!

SNARE DRUM: The snare drum rudiment page involved so many corrections we felt it essential to reproduce it entirely to make the changes clearly understood (see back of cover page). Please use the reproduction to make sure you comprehend the following changes: Rudimental roll should be played as a 17-stroke roll. Tempo on 5-stroke roll should be 132. Tempo on Flam Parradiddle should be 116-126. Tempo on Double Paradiddle should be 116-126, with accent added on the first note. Lesson 25 - the sticking should not alternate, and an accent should be added to the last note. All rudiments should be played closed and repeated as instructed by the judging panel.

doing some interesting things in which the rest of us would be interested. Please take a few minutes and write down your ideas and solutions to share with our ATSSB membership.

The All Region try outs are upon us. Make sure that you are using the current list that was approved last February. We are using year A from the five year rotating list for AREA try outs. Be sure to pay close attention to the news letters for any errata to the current list. Remember that at AREA the scales can be played using music. I must commend Ronnie Page for his long hours of work on the SARC committee. He did a fantastic job! Thanks Ronnie! We have so many dedicated directors that spend many hours helping make ATSSB a great success. I would like to take this space to say that I appreciate each of you!

I always feel like that I need to share some little trick that has helped me through the years. Do you start beginners on horn? If you ever have, did you notice that the first few lessons were either too high or too low for the student? There is a solution to this problem. I start horn students but give them TRUMPET books. There are two real advantages to this practice. The student is able to play in a practical range and from the beginning learns to hear a 5th. The first time that I heard of this practice I thought that it was crazy. After I tried it, I discovered that the 5th was not a distraction and the horn players began from the beginning listening for the 5th of the chord. Try it, I think you will like it.

Listening to the 5th of the chord reminds me of my experience this past year at the State Solo Contest. One of my students was struggling to tune to the piano. We tried F and then we tried Bb with little success. The judge suggested that the piano play Bb while the student play F. Wow! What a difference! Why haven't I been doing this for the last 28 years? Because until last May, no one pointed it out to me. The judge said that we hear a 5th easier than a unison. After having tried it, I agree. No wonder the 'Horn on Trumpet' book trick works.
