
you will not want to miss.

During the summer convention, the State Board met and voted on several items. One item was to keep Kenneth Griffin as Executive Secretary of ATSSB. Kenneth has done an outstanding job serving the association. He is the one big reason that ATSSB has grown to its current level.

I would like to express an item of concern. ATSSB has a general membership meeting at both the TMEA Convention and the TBA Convention. At these meetings we must have a quorum in order to conduct business. There is no problem getting a quorum at TMEA but we have not been able to conduct business at the last two TBA meetings. Be aware that we need you present at these meetings in order to conduct business and we usually have one or two items that need a general membership vote. Please make every effort to attend these meetings and be involved in the business of the association.

Finally I would like to let you know that there is a possibility that I will have to resign the Presidency at the end of the convention in February. As you know, I am Director of Bands at Lindale High School which is a growing community north of Tyler and west of Dallas on I-20. TRAINING SESSION

Region and Area Coordinators (or their computer gurus) attended a training session in San Antonio before TBA to learn how to use the new FileMaker Pro software to enter students and run auditions. The training was given by TMEA Deputy Director Frank Coachman. We are indebted to Frank and TMEA for this training. Auditions and the entry process run much more smoothly because of Frank's hard work and expertise.

REALIGNMENT

As you probably already know, the realignment for 2006-07 has been announced

and there is much angst and concern regarding new region and area assignments. After careful study, it appears that the realignment was done mainly to accommodate large school growth and to achieve some semblance of parity for large schools while leaving room for projected growth in the metropolitan areas and the Rio Grande Valley. While some regions and areas are certainly impacted by these changes, the ATSSB

region/area alignment will remain essentially unchanged (with some notable exceptions). The new regions (26, 27, and 28) will simply be combined with the regions from which they were carved. The State Board will visit these alignment assignments in February: Area West (Regions 1,6,16,22), Area North (Regions 2,3/20/25,5/24), Area East (Regions 4,10,17/19,21), Area Central (Regions 7,8,9/23/27,18/26), and

Area South (Regions 11,12,13,14,15/28). We are continuing to study the numbers, but we still have small-school parity with this alignment. While there is a great deal of cooperation between UIL, TMEA and ATSSB regarding this alignment, there might come a time when a school will compete in ATSSB and UIL activities in one region, but TMEA honor band (and/or region auditions if taking the TMEA track) in another under this new alignment. UIL has said they will be open to adjustments, but TMEA seems to want to keep the new alignment static for a few years to see how it works for them.

AUDITIONS

As you send in entries to ATSSB all-region auditions this year, remember that it is assumed that students from schools in class A, AA and AAA are auditioning in the ATSSB track to All-State. <u>If you have a</u> <u>student who wishes to</u> <u>take the 4A or 5A track,</u> <u>they **MUST** submit a</u> Track Selection Form with their first audition entry (whether it is to ATSSB or TMEA). Also, please realize that since we are aligned with TMEA regarding auditions, directors will be held accountable regarding the policies and procedures in effect for TMEA and ATSSB which include an obligation to judge at region and area auditions.

The region auditions determine the Area Candidates from each of the regions in the state. Be sure you are aware of eligibility requirements and that you have taken care of all of the necessary paperwork (ATSSB membership, TMEA membership, region entry fees, forms completed, etc.) in advance of auditions. Please see the updated ATSSB Officers and Organizers in this Newsletter (and keep up with changes online) and contact your Region Coordinator if you have any questions regarding auditions. If you are already a member of ATSSB for 2005-06, your name and address is in your Region Coordinator's

database and you will be receiving mailouts regarding these auditions. If you have students who are selected to audition at the ATSSB Area auditions January 7. 2006, make sure each one brings Form 11 and Form 15 properly completed and signed and notarized to the audition. Otherwise, they will not be allowed to audition at the Area level. These forms will be given you either at the Region audition or sent to those involved by the Area Coordinator when sending Area audition information. A copy of these two forms is available in Spanish should anyone need this. Be sure to request a copy if you think it might help - or download them (or any other ATSSB form) off the website at **http://** www.atssb.org/ or contact the state office

HOUSING

Hotel space is at a premium of course in San Antonio - and gets more expensive each year. Make sure that you fill out Form 14 at Area securing space in the Ramada Emily Morgan Hotel for the clinic in San Antonio if you have a student selected for All-State. You may use Form 14 at Area to reserve a room for vourself (and others if you wish to share) at the same hotel as long as the rooms last. There are also a limited number of rooms with King or Queen beds for directors who would like a room at the Emily Morgan. The student hotel fee remains \$135 for this vear. This includes all three nights at the Emily Morgan Hotel and includes all taxes and fees. We had a couple of All-State students elect to stay elsewhere this past year and that is perfectly fine

Best wishes for a successful marching season. Please let me know if there is anything ATSSB can do to help you in your task. We are blessed with an abundance of fine band directors in small schools in Texas!

State Jazz Ensemble

We are very excited about the improved accompaniment CD for your students to play along with. I hope you like the changes made and if you have any suggestions please do not hesitate to send them to me. Each instrument on the CD will play along with the full Jazz band minus their specific instrument. There is a separate audition track to be recorded. The quality is superb and should be a great help to all musicians involved. The biggest problems last year came from confusion on the Solo ad-lib section. I have outlined the concerns that have been mentioned. Please make sure that you understand the expectations of the recorded audition CD. Any CD that does not meet the requirements will be disqualified for the 2005– 2006 school year and the entry fee will not be refunded per established rules and procedures.



JOHN YOUNG STATE JAZZ COORDINATOR

There are some very important procedures that you need to understand before auditions happen in your Region on the Area level.

- 1. Remember that it is Set E.
- 2. After selection to the area level of the All-State Jazz Band audition you will need to follow the rules and guidelines of the PAL. There are suggested recording recommendations for the recording of AREA student audition CD's.
- 3. Each CD has the audition cut on it for the Area Audition to be recorded with. Please follow the directions. On each piece of music it states what is to be used for the audition. Any deviation from this will result in a disqualification.
- 4. All tonal instruments, which include guitar, bass, piano and all wind instruments will perform their solo ad lib to the Funkus Improvitus. Each instrument will play the changes three times. First time the student will play the solo as written. Second and third time the student will ad-lib on the changes. <u>You</u> <u>must play the first time as written</u>. Students may not use a prewritten solo when they improvise.
- 5. On Drum Set the student will play in time with the Funkus Improvitus track for first time, second time the student will improvise on the solo, then the third time, the student will catch all written figures timed with synchronization kicks and fills.
- 6. The other audition material is performed as instructed in the PAL. Please read the score and parts as to exactly what is to be recorded for audition purposes.

Region Coordinators are the most important link to a successful All State Jazz Band auditions. The preparation for recording the Area students will be the responsibility of the region. If you have any questions about recording please consult the PAL. If you have any questions you may email me at jyoun_wp@yahoo.com and I will search for the correct answer for you.

I look forward to a smooth All-State Jazz Ensemble audition this year.

PROPOSED CHANGES TO THE CONSTITUTION

Change SECTION 2 of ARTICLE VI

to: SECTION 2. REGION OFFICERS. Each Region shall elect a Region Coordinator who shall assume duties as set forth in the By-Laws. The Region Coordinator shall be concurrently employed as a band director or assistant director in a Class A, AA or AAA high school in Texas, or a current director or assistant director of a junior high or middle school band which feeds a class A, AA or AAA high school band in Texas as defined by the University Interscholastic League, or a current director or assistant director of a private middle school through the eighth grade, or anyone who has retired from any of these positions as an Active Member.

Change SECTION 2 of ARTICLE III of the By-Laws

from: **SECTION 2. REGION COORDINATORS** shall be elected by the membership of ATSSB in regional meetings to be held annually to conduct the local business of ATSSB. He shall be a member of the State Board of Directors and shall call meetings, appoint committees as he may deem necessary and perform other duties pertaining to the presiding office. He shall encourage, solicit and enlist members within his region.

to: SECTION 2. REGION COORDINATORS shall be elected by the membership of ATSSB in regional meetings to be held annually to conduct the local business of ATSSB. The Region Coordinator shall be concurrently employed as a band director or assistant director in a Class A, AA or AAA high school in Texas, or a current director or assistant director of a junior high or middle school band which feeds a class A, AA or AAA high school band in Texas as defined by the University Interscholastic League, or a current director or assistant director of a private middle school through the eighth grade, or anyone who has retired from any of these positions as an Active Member. He shall be a member of the State Board of Directors and shall call meetings, appoint committees as he may deem necessary and perform other duties pertaining to the presiding office. He shall encourage, solicit and enlist members within his region.

Rationale: Eligibility requirements for election to region office should remain consistent with state elected offices.

- Meeting called to order at 7:37 a.m.
- Invocation by Mike Miller. Oath of Office administered by Kenneth Griffin.
- Minutes of the SBOD meeting February 10, 2005, were approved as printed in the September Newsletter after a motion by John Odom and a second by Brandon Brewer.
- Heard report of Special Committees:
 - Brent Cannon, Chair of the Clinician/Commission Committee, submitted a report recommending possible contacts for clinicians and/or composers for future all-state groups. Committee members were Brent Cannon, Mike Barnes, Carl Idlebird, Jonathan Kelly, David Lambert, Mike Marsh, Elmer Schenk, and Mike Sheffield. The committee moved that the Executive Secretary be given discretion in contacting and securing commitments for as many years in advance as possible with the commissioned composer being considered as Concert Band clinician in the year of the commission. Second by Jim Jones. Motion carried.
- Heard reports of **Standing Committees:**
 - President-Elect and SARC Chair Rob Toups reported State Audition Review Committee motions:
 - Change the beat note of the second etude (#II) of Year C Mallets in the Suggested Audition List (for middle schools) from a quarter note to a dotted quarter note. Second by Brandon Brewer. Motion passed
 - There was no report from the Past-President Committee.
- In the **OPS Report** by Don Thoede, he thanked all participants and Region and Area Coordinators for their participation. He announced the winners of the 2005 OPS competition, noting that the 2005 OPS CD will be sent free of charge to all eligible ATSSB-member high schools with the September Newsletter. He encouraged Region and Area Coordinators to comply with all procedures regarding the OPS process. This led to a spirited discussion regarding incorrect or incomplete entries at the region level with several motions made, seconded, amended, then withdrawn after it was determined that Don Thoede would bring a proposal from the OPS Steering Committee to the SBOD at the February meeting to address these concerns. He presented a motion from the Steering Committee to pay OPS judges a flat \$60 honorarium with no meal allotment and Region Coordinators a \$75 honorarium for OPS beginning in 2006. Jorge Lozano seconded. John Odom moved and Brandon Brewer seconded that we also pay Area Coordinators the \$75 honorarium. After the Steering Committee accepted the amendment to his motion, motion passed. He then made several requests to the Region and Area Coordinators regarding OPS procedures.
- President's Report by Steven Moore:
 - Reported on discussions with TMEA regarding alignment. He said he was investigating the possibility of TMEA allowing ATSSB to hold its concerts in the Lila Cockrell Theater. These were exploratory discussions and had no official sanction from TMEA. The only time at present would be at 9:00 on Saturday morning, but that would be during the TMEA Second General Session (and the orchestra and choir were rehearsing in the Cockrell Theater at that time), so he was unsure as to the future of any discussions of this type but would continue a dialogue. Daniel Aléman suggested ATSSB move all its activities a day earlier, come in on Tuesday, and have the concert on Friday night. He also noted that we as directors do not schedule band rehearsals on Wednesday night so students do not have to make a choice between band rehearsals and church activities, so he does not think it a good idea to schedule our All-State concerts during the TMEA Second General Session for the same reason. Mr. Moore noted that this was a sensitive issue and would continue to look into it.
 - Reminded Region Coordinators that the Executive Committee must approve variances and that Mr. Griffin would be putting a list of all approved variances online soon.
 - He thanked Region and Area Coordinators and computer technicians for attendance at the Training Session held July 21 at the Menger Hotel and noted that they would be receiving a certificate of attendance they might be able to use for in-service credit with their respective districts.
 - He also thanked Rob Toups (SARC Chair), Brent Cannon (Clinician/Commission Committee Chair), and Don Thoede (OPS State Chair) for their work this year.
 - He congratulated OPS State Finalists and recognized Honor Band winners.
 - He read a UIL update from George Strickland (who had to leave to attend another meeting): 1) PML will be online soon and searchable; 2) region Executive Secretaries for the new regions will hired in the fall and trained in the spring; 3) 10 class I solos for each instrument will be designated for students to use music at region and TSSEC performances; 4) The Music Advisory Committee will meet Monday at 11:00 a,m, in the Convention Center.
 - He informed the board that it was almost assured that his school (Lindale) would be going 4A in 2006-07. The reclassifications will be posted the first of February, and if Lindale does go 4A, he plans to announce his resignation as President effective at the end of the 2006

All-State clinic and that a President pro tem would need to be elected from the SBOD and asked them to be thinking about that possibility. **Executive Secretary's Report** by Kenneth Griffin:

- Thanked Steven Moore for planning for the realignment and reclassification and how it might impact ATSSB.
- Asked Region Coordinators to turn in patch orders before September 1.
- Noted that the 2006 Jazz Ensemble will stay in the Emily Morgan room downstairs through Friday night when it moves to the Scottish Rite (to keep from having to move twice more to the Presbyterian Church).
- Reported on problems with the Emily Morgan and Scottish Rite and how we might deal with them in the future.
- Noted that a \$180,000 bond had been secured on the Executive Secretary to protect the Association.
- Reported that the Scholarship Fund balance was just over \$39,000 with \$12,000 owed to current scholarship recipients (with three that had failed to claim past scholarships).
- He noted that it was TMEA policy and so ATSSB's that region band instrumentation is to be set before auditions and not lessened after auditions (chairs may be added, but none may be removed). In other words, all sections must be filled if possible.
- He noted that region and area alignments for 2006-07 would be set by the SBOD at the February meeting. He detailed the studies regarding the new alignment and noted that ATSSB should not be negatively impacted regarding parity in the five Areas when the new regions were incorporated into the existing regions (like 17/19 and 9/23, etc.).
- There was no old business, although Brandon Brewer asked if current region variances were going to be placed on the website. He was assured they would.
- Under new business:
 - Kenneth Griffin was asked to leave the room and Mr. Moore opened the floor for discussion regarding the evaluation of the Executive Secretary (required every two years). Brandon Brewer moved to renew the appointment of Kenneth Griffin for the next two years and increase his stipend \$1000. After a second by Stephen Henry, motion carried. Mr. Griffin was asked to return and was given a standing ovation by the SBOD.
 - Kenneth Griffin moved and Cindy Mikel seconded that the bid for recording the 2006 All-State concert be awarded to Probst Audio. Motion passed.
 - Brandon Brewer moved and Mike Marsh seconded that we approve the recommended changed to the Snare Drum etudes effective in 2006-07. The consensus of the SBOD was to implement the changes for 2005-06 and the motion was amended to reflect that. Motion carried with 2 against.
 - Kenneth Griffin moved and Jim Jones seconded that the proposed Constitutional Amendment regarding criteria for Region Coordinator elections be supported by the SBOD. Motion carried.
 - In other new business:
 - Stephen Henry expressed dissatisfaction with the realignment and asked for clarifications regarding the impact it will have on ATSSB. He noted that he had not received any data or assurances from TMEA, UIL or ATSSB. A discussion included the impact it will have on regions 12, 13 and 5/24 and Mr. Griffin asked those Region Coordinators who felt they were being negatively impacted to send him details regarding their concerns.

Minutes of the July 2005 ATSSB General Session

The General Session of ATSSB met in the Convention Center CC-214 on Sunday, July 24, 2005, with approximately 90 in attendance. President Steven Moore called the meeting to order at **2:03 p.m**.

Rob Toups gave the invocation.

Mr. Moore noted that there was not a quorum, so the meeting would be unofficial and informational in nature and that the business planned (approval of minutes and consideration of a Constitutional Amendment) would be deferred to the February meeting. Mr. Moore noted that there were no special committee reports.

Under standing committees, he reported that the SARC made only one errata report regarding the beat note in Year C mallets. There was no Past-President report. He noted that the Past-Presidents met at a luncheon on Saturday at which all Past-Presidents but Ronnie Page were in attendance, including Ed Lowes who was making progress with his battle with cancer. Mr. Moore asked members to keep in touch with Ed and keep him in their prayers for a quick and complete recovery.

OPS State Chair **Don Thoede** announced the winners of the 2005 OPS. He then noted that the total results would be posted on the website soon.

Mr. Moore reported on SBOD action taken earlier:

The Clinician/Commission Committee chaired by Brent Cannon presented a report of possible clinicians and composers and recommended the Executive Secretary be given discretion in contacting and securing commitments for as many years in advance as possible with the commissioned composer being considered as Concert Band clinician in the year of the commission.

OPS judges will receive a \$60 honorarium and Region and Area Coordinators a \$75 honorarium with no meal allotment in 2006.

The position of Executive Secretary was evaluated and Mr. Griffin reappointed for another two-year term. Mr. Griffin received an ovation from those in attendance for his work with the Association.

Probst Audio was awarded the contract for recording the 2006 All-State Bands.

Snare Drum etudes were changed by deleting one of the Whaley etudes and replacing it with one from the Cirone <u>Portraits in Rhythm</u>. This change takes place this year, so members are encouraged to check the Website for the change and the updated Snare Drum etude page.

Mr. Moore thanked Don Thoede (State OPS Chair), Brent Cannon (Clinician/Commission Committee Chair), and Rob Toups (SARC Chair) for their work for the Association.

He then recognized TMEA Honor Band Finalists and Winners in Class A and AA.

In the Executive Secretary's report, Kenneth Griffin noted that we have over \$39,000 in the Scholarship Fund with about \$12,000 committed to scholarships already awarded but not yet claimed. He encouraged all regions and individuals to consider donating to the fund to keep it viable. He reminded those present that dues had increased to \$35. Since the Website is now the official document of ATSSB, he encouraged everyone to keep tabs on new developments often and that the Prescribed Audition List is now available only online. He also asked that if anyone has clinician or commission suggestions to email Mr. Moore or him.

OPS State Chair Don Thoede reminded everyone that OPS procedures would undergo more changes for 2006 and asked that the members read and follow the procedures carefully.

Mr. Moore then adjourned the meeting.
