If you are the director of an ATSSB-eligible school and you do not receive a copy within a week or so, contact the Executive Secretary (atssb@att.net) and he will send you a CD.

ATSSB enjoyed another exciting and productive year in 2012-13. It was evident from the number of members (1112) we had in our twenty-second year and from the quality of the 2013 ATSSB All-State Bands that our organization has maintained our original goal to be "sensitive to the needs and interests of A, AA and AAA band programs in Texas." Most small schools in Texas that have band programs are participating members of the Association.

If you wish to have students participate in ATSSB activities this year, you must also become a member of TMEA (http://www.tmea.org) because the two organizations have unified the audition procedure for membership in Texas All-State Bands.

The clinician for this year's All-State Jazz Band is Charles Owen from the University of South Florida. An alumnus of University of North Texas and California State University-Northridge, Mr. Owen has been at USF for 22 years as a director of jazz studies, composition and the jazz ensemble. We are excited to have him work with our students!

Notes regarding this year's auditions:

1) Don't have an all-region jazz band in your region, but you have students interested in the all-state band? Talk to your region coordinator about how to submit a CD for the state adjudication. Ask about entry deadlines!

2) Don't have a jazz band at your school, but you have students interested in auditioning? Enter them! Ask your region coordinator for details, and order the music and accompaniment CD from Buddy Mattei ASAP!

3) There is no vibes part for this year's audition music. (It reappears next year.)

4) Errata for Set C music:

Chart #2 - «Every Now and Zen», Alto Sax part - page 2, meas. 45: The first note (F) should be a half note instead of the eighth note printed. There is no tie from that note. This will be corrected in all sets ordered on or after July 18th. The error is in the part only, not the score. A corrected copy of that page will be posted on the jazz webpage.

Chart #3 "Sweat Zoot"; tempo indication should be quarter note equals 180, not 80 as shown on older versions.

Chart #4 "B-flat Blues for Improv"; did not have an actual audition part for Drum Set in previous versions. Correct copy of this page is on the jazz webpage.

5) Region coordinators - remember to add a 5th track to the area CDs that includes the student's name, school and instrument. This track is added to the *end* of the CD. Also, be sure to check the recording quality of the submitted CDs.

Executive Secretary's Column

LOST CARD?

If you have misplaced your ATSSB membership card, you can now go online to retrieve it and your receipt. Just replace the XXXX in the following URL with your last name and last four digits of your Social Security number, then paste it into your browser: http://www.atssb.org/Cards.14/XXXX.pdf

You will get a pdf file of your card and receipt. Should you have any problem accessing it, email me (atssb@att.net) and I will get it to you promptly.

ONLINE ENTRY

Remember that entries for all-region band auditions (jazz, middle school or high school) must be done online. Go to the TMEA website, click on DIVISION, then BAND, then AUDITION ENTRY PROCESS. LOG IN AS DIRECTOR, then follow the prompts. You should end up on your profile page which will also list available competitions in which you are eligible to enter students. If a contest is not listed,

contact your Region Coordinator to see why not (or when it will be available). TMEA Deputy Director Frank Coachman and TMEA IT Administrator Andrew Denman have done an amazing job of utilizing the TMEA servers and FileMaker Pro to come up with this system. We are indebted to them and TMEA for their tireless work on behalf of music education in Texas. **CAUTION: there are penalties for late entries!**

AUDITIONS

As you send in entries to ATSSB all-region auditions this year, remember that students from schools in class A and AA are auditioning in the 2A Track to All-State and students in class AAA are auditioning in the 3A Track. If you have a class A or AA student who wishes to take the 3A Track - or any student wishing to take the 4A or 5A track, they **MUST** submit a Track Selection Form with their first audition entry (whether it is to ATSSB or TMEA). Also, please realize that since we are aligned with TMEA regarding auditions, directors will be held accountable regarding the policies and procedures in effect for TMEA and ATSSB which include an obligation to judge at region and area auditions.

Auditions at the region level may possibly be unchanged for many of you. The only difference will be the resulting chair posting. Students advancing to Area will be designated by the Track they selected (3A or 2A). The number allowed to advance in each Track is listed elsewhere in this Newsletter as "All-State Band Profile". The region auditions determine the Area Candidates from each of the regions in the state. Be sure you are aware of eligibility requirements and that you have taken care of all of the necessary paperwork (ATSSB membership, TMEA membership, region entry fees, forms completed, etc.) in advance of auditions. Please see the updated ATSSB Officers and Organizers in this Newsletter (and keep up with changes online) and contact your Region Coordinator if you have any questions regarding auditions. If you are already a member of ATSSB for 2013-14, your name and address is in your Region Coordinator's database and you will be receiving emails and/or mailouts regarding these auditions.

If you have students who are selected to audition at the ATSSB Area auditions January 11, 2014, be sure to pay the \$20 Area fee (in advance or at the door) or they will not be allowed to audition at the Area level. No forms are necessary at Area. If you have a student make State, you will receive a username and password with which your student can access the TMEA website to download the Medical Release and Student Code of Conduct which they must bring to San Antonio signed and notarized. Area auditions will be a little different this year. There will be separate auditions for 2A Track and 3A Track (but only one for the Color Instrument Open Class). One panel will

hear 2A Track, then immediately hear the 3A Track. Flute, clarinet and trumpet (possibly percussion) will be heard by separate panels - one panel for 2A Track flutes and a separate panel for 3A Track flutes, both panels running at the same time, so there will be separate holding rooms for 2A Track and 3A Track flutes, etc.

ELECTRONIC MEDIA

The State Board has voted to allow the use of electronic media in lieu of printed music in auditions (a book will still be provided on the stand for all students who wish to use it). The media is for the music only and may not be used as a tuner or metronome during the live audition.

HOUSING

We will once again utilize the Hyatt Regency for all ATSSB activities until the concerts. If at Area you have a student selected to the ATSSB All-State Band, you will need to sign them up for a room and include the Designated Chaperone (who must also stay at the same hotel as the student). Much has already been written regarding these procedures - and more clarification will come. Please keep your eye on the website for updates and policy clarifications. TMEA legal counsel has advised their Executive Board that if there is an incident of any kind at the convention involving a student, the liability rests with the designated chaperone and the school district, not on TMEA or ATSSB. Based on that opinion, it is highly recommended that you sign up as your student's designated chaperone and plan to stay in the Hyatt Regency where your student(s) will be housed.

To be sure, there is a LOT of paperwork involved in any organized activity, but it can all be taken care of if planned properly in advance. Use the Director's Checklist available to you online that should help with keeping it all in perspective and to help you navigate all the "red tape" used in the audition process:

The website is a treasure trove of information and forms needed for all aspects of the ATSSB audition and competition experience, so check it out and keep track of all updates as they are announced, especially the catch-all page (http://www.atssb.org/AtoZ.asp).

Constitutional Amendment

We will vote in the General Session on a proposed Constitutional Amendment that reflects the change the UIL will make in 2014-15 regarding school classifications. Current class 1A schools that play 6-man football will stay 1A, but current class 1A schools that play 11-man football will become 2A. Current class 2A schools will become 3A; current class 3A schools will become 4A; current class 4A schools will become 5A; and current class 5A schools will become 6A. Enrollment numbers may also change, but the only thing really changing is the name. Class 1A and 2A schools will compete in the same conference at UIL marching, Concert and Signtreading contests - 1A/2A.

Best wishes for a successful marching season. Please let me know if there is anything ATSSB can do to help you in your task.

The directors who judged the Class CC bands were Gina Muela, Chris Burk, Josh King, Robert Vetter, and Stacy L. Clark. Michelle King served as monitor. The judges for the Class C bands were Gerardo Loya, Marilyn Bennett, Donnie Barrier, Kevin Heckaman, and Randy Marble. Katherine Barrier was the monitor.

Of course, none of this at the state level could be possible without the hard work of our Region and Area coordinators. They have to hire judges, plan the adjudication sessions, and send advancing CDs to the next level of competition. They really deserve a round of applause for their efforts!

We had something happen at the state adjudication this year that has never happened before. We had one school whose CDs, both the primary and the back-up, would not play in our professional CD players! In 2001, we switched from cassette tapes to compact discs, and never have we had a school whose CDs would not play at the state level. Yes, we have had several years when we had to play the back-up CD because the primary would not play, but the back-up always worked. This year nothing we tried would get the CDs to play. We tried a different machine but to no avail. I had to instruct the judges to put that school in last place. There was no other option. I asked the director of that school if he had the CDs professionally made, and he told me that he made them on his computer. In years past, I have strongly suggested that directors get their CDs professional mastered for that very reason. It is something to think about.

At this time I am looking into the possibility of getting rid of the compact disc and using only mp3 files. I admit that I have a lot of research to do in order to make that happen, but it is definitely something that needs to be considered. It is possible that we could use "Dropbox" in some way. The most difficult task that I would have would be writing specific step by step "Director Instructions" so everyone would send in their entries exactly the same way. I would appreciate any input you can give me in order to accomplish this. I know there are several ways this can be done, but we have to be able to maintain anonymity at all levels and have computers with good sound systems at all levels to play them on (we would need three computers with one back-up at the state level). All ideas are needed and appreciated. If I can get enough of you to contact me with some ideas as to how you think we can do this, I might be able to come up with a very good and acceptable way to get this done. A phone call will work best for me. That allows me to ask you questions so I can fully understand your ideas. I feel certain we will have to go with CDs for one more year, but using mp3 files in the spring of 2015 is definitely feasible. I need your help in order to get this done so call me, please!

I hope you all have a very successful fall semester, particularly the Class 1A and Class 2A high schools that compete in UIL Marching Contest. Good luck!

All-State Band Profile

This year, the ATSSB All-State Concert Band will be restricted to 1A and 2A students only (with the exception of color instruments). It will be assumed that students in class 1A or 2A schools will be taking the 2A Track to the ATSSB All-State Concert Band. Should you desire your 1A or 2A student to audition for the Symphonic Band, you must select the 3A Track at the time of student registration in the Region Band Audition process.

The Band will follow all established audition procedures. The Instrumentation for the bands is listed below.

Color Instruments will be auditioned in the 3A Track. One of each color instrument will be selected at Area to be in the ATSSB All-State Band regardless of classification. Chair auditions at State will determine band placement with the top three in the Symphonic Band and the remaining two in the Concert Band. The following instruments are considered Color Instruments: Oboe, Bassoon, Alto Clarinet, Contrabass Clarinet, Tenor Saxophone, Baritone Saxophone, and Bass Trombone.

Due to tracking there is a very good possibility that a student does not make the Region Band but will qualify for Area Auditions.

Proposed Constitutional Amendment

February 13, 2014

RATIONALE: With the UIL realignment beginning in 2014-15, current Class A schools will be split into 6-man football schools (Class 1A) and 11-man football schools (Class 2A). Current Class 2A schools will become Class 3A, current Class 3A will become 4A, current Class 4A will become 5A, and current Class 5A will become 6A. Since there is no real change in classes by enrollment, we need to reword the Constitution to reflect the new nomenclature.

Change Article III from:

ATSSB membership shall be defined according to the following categories:

ACTIVE - A current director or assistant director of a class A, AA or AAA high school band in Texas or a current director or assistant director of a junior high or middle school band which feeds a class A, AA or AAA high school band in Texas as defined by the University Interscholastic League by counting enrollment in grades 9-12 (or proportionate enrollment if the high school does not encompass grades 9-12; i.e.: if a high school has only one grade in it, its enrollment would be multiplied by 4; if two grades, its enrollment would be multiplied by two; and if only three grades, its enrollment would be multiplied by 1.333), or a current director or assistant director of a private middle school through the eighth grade, or anyone who has retired from any of these positions as an Active Member. These schools must be certified by the Texas Education Agency or an accrediting agency approved by the Texas Private School Accreditation Commission (TEPSAC).

ASSOCIATE - Any other interested person, including - although not restricted to - AAAA or AAAAA band directors, assistants or Fine Arts Directors, directors of other musical disciplines, institutions, other groups, and lay citizens.

to:

ATSSB membership shall be defined according to the following categories:

ACTIVE - A current director or assistant director of a Class 1A, 2A, 3A, or 4A high school band in Texas or a current director or assistant director of a junior high or middle school band which feeds a Class 1A, 2A, 3A, or 4A high school band in Texas as defined by the University Interscholastic League by counting enrollment in grades 9-12 (or proportionate enrollment if the high school does not encompass grades 9-12; i.e.: if a high school has only one grade in it, its enrollment would be multiplied by 4; if two grades, its enrollment would be multiplied by two; and if only three grades, its enrollment would be multiplied by 1.333), or a current director or assistant director of a private middle school through the eighth grade, or anyone who has retired from any of these positions as an Active Member. These schools must be certified by the Texas Education Agency or an accrediting agency approved by the Texas Private School Accreditation Commission (TEPSAC).

ASSOCIATE - Any other interested person, including - although not restricted to - 5A or 6A band directors, assistants or Fine Arts Directors, directors of other musical disciplines, institutions, other groups, and lay citizens.

Change Article V from:

SECTION 1. THE PRESIDENT. The President shall assume office in the manner prescribed in the By-Laws. The President shall be concurrently employed as a band director or assistant director in a Class A, AA or AAA high school in Texas. The President shall be the presiding officer at all official meetings of ATSSB and shall appoint committees as needed to service the needs of the Association.

SECTION 2. THE PRESIDENT-ELECT. The President-Elect shall assume office in the manner prescribed in the By-Laws. The President-Elect shall be concurrently employed as a director or assistant director in a Class A, AA or AAA high school in Texas. The President-Elect shall be chairman of the State Audition Review Committee.

SECTION 3. THE EXECUTIVE SECRETARY. The Executive Secretary shall assume office in the manner prescribed in the By-Laws. The Executive Secretary may be an Active or Associate Member of ATSSB.

SECTION 4. AT-LARGE REPRESENTATIVES. One representative from each class (C/CC, A, AA and AAA) shall assume office in the manner prescribed in the By-Laws. Each of the four representatives shall be voting members of the State Board of Directors.

to:

SECTION 1. THE PRESIDENT. The President shall assume office in the manner prescribed in the By-Laws. The President shall be concurrently employed as a band director or assistant director in a Class 1A, 2A, 3A, or 4A high school in Texas. The President shall be the presiding officer at all official meetings of ATSSB and shall appoint committees as needed to service the needs of the Association.

SECTION 2. THE PRESIDENT-ELECT. The President-Elect shall assume office in the manner prescribed in the By-Laws. The President-Elect shall be concurrently employed as a director or assistant director in a Class 1A, 2A, 3A, or 4A high school in Texas. The President-Elect shall be chairman of the State Audition Review Committee.

- Meeting called to order at 7:33 a.m. by John Young.
- Invocation was given by Bob Vetter.
- Minutes of the SBOD meeting February 14, 2013, as printed in the March Newsletter were approved after a motion by Byron Alsup and a second by Bob Vetter.
- Under the reports of Special Committees, John Young introduced George Strickland who gave a UIL report:
 - The UIL website safety training will go live on August 1 and he encouraged all directors and their assistant to take the course for compliance with UIL rules.
 - The Prescribed Music List will be updated online as of August 1 and that there were numerous new additions especially in percussion solos and ensembles.
 - There were no new rule changes
 - The Sightreading Committee was finished with their work and Mr. Strickland felt like Level 1 and 2 bands would be pleased with the pieces this year by a well-known and well-liked composer.
 - There will ne labels for school classes in 2015, driven by athletics (6-man and 11-man football Class A schools will be split into Class 1A (6-man football schools) and Class 2A (current 11-man football Class 1A schools). Each of the other classes will go up one level (highest being 6A).
 - Dr. Brad Kent will take over as Director of Music Activities September 1 with Dick Floyd serving as an Advisor for the year.
- Heard reports of Standing Committees:

•

- President-Elect and SARC Chair Jim Cude noted that the SBOD had received from the Executive Secretary a pdf file of the proposed changes in etude length for Year A, B, D and E (Year C etude length already approved by SBOD action in February), the motion to approve came from the committee with a second by Brandon Brewer. Motion passed unanimously.
- Brandon Brewer, chair of the Past-President Committee, had no report.
 - Bob McClure, Coordinator of the Composition Competition, thanked the judges who served on the two adjudication panels:
 - Preliminary Panel: David DeLuca from La Grange, Julie Cook from Howe, Jim Best from Aubrey, Kyle White from Grand Saline, and Chris Burk from Anna
 - Final Panel: David DeLuca from La Grange, Julie Cook from Howe, Brandon Brewer from Princeton, Byron Alsup from Holliday, and Willie Owens from FJH Music.

There were 28 entries. He asked that the rules be changed so that he could advance as few as 10 to the state finals. Byron Alsup moved the change and Carroll Rhodes seconded. Motion passed.

• Don Thoede, OPS State Chair, noted that this had been another good year for OPS. There were some issues when neither a submitted CD nor its backup CD would play in the equipment, but after discussing the issue with the submitting director, it was determined the CDs were made by the director on a computer (not a reliable method). He asked that Coordinators call him with any questions regarding the Series to avoid any possible issues in the future. He also asked that members be told to list movements played if the piece is a multi-movement work. He then read the list of winner and runners-up and received a round of applause for his work with the OPS.

- **President's Report** by John Young:
 - He said he was excited to serve as President and hopes everyone will work with him to make it a great year.
 - He recognized Steven Moss and Cameron Yoe High School for its selection as the TMEA Class 2A Honor Band.
 - He encouraged 1A and 2A directors to enter students this year to take advantage of the new 2A Track to All-State.
- **Executive Secretary's Report** by Kenneth Griffin:
 - He reminded Region Coordinators who still owed for region patches to please get accounts current.
 - He asked Region and Area Coordinators to check the patch order for 2014 to make sure data was accurate. Orders will go in September 1. He reminded them that the new 2A Track might mean the addition of another region band and to take that into account when ordering patches (they cost about \$1.25 each when ordering now but over \$4.30 each when ordered later!).
 - Gave a **Scholarship Report** which showed \$87,643.79 in the Scholarship Fund, with 22 \$500 and 1 \$2000 scholarships as yet unclaimed from 2013. Since 1995, ATSSB has awarded 294 individuals a total of \$257,500 in scholarships (not all were claimed).
 - He asked that regions get their accounts in order with an Employer Identification Number for each region on file with the state office (3 did not have one on file). He also reminded them that a 1099 must be filed with the IRS and to the individuals involved if any one person were paid more than \$599.99 for a fiscal year.
 - A question regarding region coordinator honoraria was asked and it was determined that most regions paid their coordinators an annual honorarium of \$500. Mr. Griffin stated he would poll the Coordinators to get an idea of who paid honoraria and how much was paid.
- There was no old business.
- Under new business:
 - Marilyn K. Bennett was confirmed as the C/CC Representative on a motion by Darin K. Johns and a second by Jim Jones. Motion carried.
 - Byron Alsup moved that the Fall Agenda for Region Coordinators be approved. After a second by Carroll Rhodes, it was decided that we should add that all staff of a school that has an Area candidate needs to be available to judge at Area. Motion carried.
 - Darin K. Johns moved that the bid to record the 2014 All-State concerts from Probst Audio be accepted. Matt Knight seconded and the motion carried.
 - A discussion revolved around the reclassifications coming for 2014-15 with no action taken.
 - A discussion regarding the possibility of having section rehearsals at State resulted in Mr. Young asking Eric Gray and Bob Vetter to devise a plan after ascertaining the availability of rooms and available time.
 - Area Coordinators and OPS State Chair Don Thoede were asked to leave the room. A discussion regarding their honoraria was started by Kenneth Griffin, who recommended that Area Coordinators' annual honoraria be raised to \$1000 from the current level of \$500 since there is no income associated with their positions. Kenneth Griffin made the motion to approve, seconded by Bob Vetter. Motion carried. Mr. Griffin then moved that the OPS State Chair's honorarium be raised to \$3000 from the current \$1000. After a second by Eric Gray, motion carried.
 - Mr. Griffin then left the room and asked the Area Coordinators and Mr. Thoede to return. While he was out, Mel Hadderton took minutes regarding a discussion of the position of Executive Secretary. George Strickland spoke in reference to how far ATSSB has come, that Mr. Griffin's stipend was small in the beginning and that he is now doing the work of 4 or 5 people. A discussion regarding increasing dues ensued. Don Thoede also spoke about Mr. Griffin's commitment to ATSSB and the countless hours he spends. Darin K. Johns moved that his stipend be raised to \$35,000. After a second by Byron Alsup, motion carried.
 - After Mr. Griffin's return to the room, he was asked if a \$15 increase in dues would see ATSSB through the foreseeable future. Mr. Griffin said it would, so Fred Angerstein moved that all dues be increased \$15. After a second by Darin K. Johns, motion carried. Dues will increase for 2014-15. Retire dues will be \$25, Active and Associate dues will be \$50. Late dues for Active members (after October 1) will be \$75 with \$25 continuing to go into the Scholarship Fund.
 - The ATSSB General Session was set for Tuesday, July 23, 2013, at 4:30 p.m. in CC210 after a motion by Byron Alsup and a second by Carroll Rhodes. Motion carried.
 - Brian Donnell, State Jazz Coordinator, asked to speak. He asked that regions check to see that Area jazz recordings are of good quality. There is errata listed on the website regarding Chart #2 "Every Now and Zen" on the alto sax part page 2, measure 45: the first note F should be a half note instead of an eighth note and there is no tie from that note. This will be corrected on all parts and sets ordered after July 18. The error is in the part only, not the score. A corrected copy of that page is posted on the jazz website. Also, on Chart #3 "Sweat Zoot" the tempo indication should be quarter note = 180 (not 80 as listed on older versions). Also, on Chart #4 "B-Flat Blues for Improv" there was not an audition part for drum set in previous versions; a correct copy of this part is on the jazz website. CD adjudication for state is Saturday, November 9. Designated regions were listed for area adjudication.

- SARC Committee Chair Jim Cude noted that Year C etude lengths had been changed as approved by the SBOD last February and Years A, B, D, and E were adjusted to match lengths and approved by the SBOD this morning the approved etude lengths should be online soon. He thanked his committee: Bonnie Anderson from Littlefield, Michael Childs from Stephenville, Julie Cook from Howe, Alan Gray from Whitesboro, Taylor Hutchison from Princeton, Michael Lemish from Argyle, and Randy Marble from West Columbia.
- OPS Chair Don Thoede read the winners and runners-up in the 2013 Outstanding Performance Series. He reminded the membership about reading instructions carefully, listing on the CD labels full names of composers and arrangers and specifying movements performed in a multi-movement work.

In the President's Report, Mr. Young encouraged 1A and 2A directors to work with their students to enter the audition process, taking advantage of the new 2A Track to All-State. He asked that schools who advance students to Area have their entire staff available to judge at Area because there will be more students and audition rooms under the new Tracking Procedures. He then recognized Steven Moss and the Cameron Yoe Band for their selection as the TMEA State 2A Honor Band. Mr. Young then reported State Board of Director Action: changed the Composition Competition rules to allow as few as 10 finalists in the process; approved the selection of Marilyn K. Bennett to complete the term of C/CC Representative; approved the fall agenda for region coordinators; accepted the bid of Probst Audio for the recording of the 2013 all-state bands; and voted to increase dues \$15 beginning in 2014-15 (Retiree and College dues will increase from \$10 to \$25; Active and Associate dues will increase from \$35 to \$50; and late dues after October 1 will increase from \$60 to \$75 with \$25 continuing to go to the Scholarship Fund).

Mr. Griffin gave a Scholarship report, noting that 294 individual students have been awarded \$257,500 in scholarships since the Fund's inception. With 22 \$500 and 1 \$2000 scholarships waiting to be claimed from 2013 and \$87,643.79 in the Scholarship Fund, he encouraged continued support of the fund with donations in the future.

There was no old business and no new business, so Mr. Young adjourned the meeting at 4:55.


