ATSSB enjoyed another exciting and productive year in 2013-14. State Jazz Coordinator's Column

This year's clinician is Robert Washut, Professor of Jazz Studies at University of Northern Iowa. Dr. Washut is an award-winning composer, arranger, performer and director. Our students will be fortunate to have him working with them during the All-State clinic. The concert will take place on Saturday, February 14 at 1:00 in Ballroom B.

If your region does not have an all-region jazz band, but you have students interested in auditioning, contact your region coordinator and learn how to submit a CD for the state adjudication. Be aware of all entry deadlines. This also applies to schools without a jazz band program. Any student from an ATSSB school is eligible!

As a result of last February's general session vote, the number of tenor trombones advancing from region to area has been reduced to 4. This puts tenor trombone numbers in line with trumpets.

Do you have a senior student who would like to submit a CD for scholarship or other auditions? Talk with your region coordinator about taking advantage of the area recording session to generate such a CD. It is the policy of ATSSB to not release the official audition CDs for any purpose, so this scholarship audition CD should be a separate audition, not a duplicate of the ATSSB area jazz CD.

It is imperative that directors work with the region coordinators to ensure the best possible recordings for the Area auditions! Make sure the recording engineer is using the correct CD accompaniment track (NO MIDI!) for each student, and is using the best recording levels.

Vibraphone is included in the drum set auditions for area and state. Some regions forgo the vibes audition for region auditions in order to increase the number of students auditioning, but vibes should be included in all CDs submitted for area auditions.

Deadline for submitting Area CDs to state is October 11. The date for CD adjudication for state is November 8. Contact Buddy Mattei for music and accompaniment CDs.

LOST CARD?

If you have misplaced your ATSSB membership card, you can now go online to retrieve it and your receipt. Just replace the XXXX in the following URL with your last name and last four digits of your Social Security number, then paste it into your browser: http://www.atssb.org/Cards.15/XXXX.pdf

You will get a pdf file of your card and receipt. Should you have any problem accessing it, email me (atssb@att.net) and I will get it to you promptly.

ONLINE ENTRY

Remember that entries for all-region band auditions (jazz, middle school or high school) must be done online. Go to the TMEA website, click on DIVISION, then BAND, then AUDITION ENTRY PROCESS. LOG IN

AS DIRECTOR, then follow the prompts. You should end up on your profile page which will also list available competitions in which you are eligible to enter students. If a contest is not listed, contact your Region Coordinator to see why not (or when it will be available). TMEA Deputy Director Frank Coachman and TMEA IT Administrator Andrew Denman have done an amazing job of utilizing the TMEA servers and FileMaker Pro to come up with this system. We are indebted to them and TMEA for their tireless work on behalf of music education in Texas. **CAUTION: there are penalties for late entries!** Also, when you enter your ATSSB number in the entry, just use the numbers alone.

AUDITIONS

As you send in entries to ATSSB all-region auditions this year, remember that students from schools in class 1A, 2A and 3A are auditioning in the 3A Track to All-State and students in class 4A are auditioning in the 4A Track. If you have a class 1A, 2A or 3A student who wishes to take the 4A Track - or any student wishing to take the 5A or 6A track, they **MUST** submit a Track Selection Form with their first audition entry (whether it is to ATSSB or TMEA). Also, please realize that since we are aligned with TMEA regarding auditions, directors will be held accountable regarding the policies and procedures in effect for TMEA and ATSSB which include an obligation to judge at region and area auditions.

Auditions at the region level may possibly be unchanged for many of you. The only difference will be the resulting chair posting. Students advancing to Area will be designated by the Track they selected (4A or 3A). The number allowed to advance in each Track is listed elsewhere in this Newsletter as "All-State Band Profile". The region auditions determine the Area Candidates from each of the regions in the state. Be sure you are aware of eligibility requirements and that you have taken care of all of the necessary paperwork (ATSSB membership, TMEA membership, region entry fees, forms completed, etc.) in advance of auditions. Please see the updated ATSSB Officers and Organizers in this Newsletter (and keep up with changes online) and contact your Region Coordinator if you have any questions regarding auditions. If you are already a member of ATSSB for 2014-15, your name and address is in your Region Coordinator's database and you will be receiving emails and/or mailouts regarding these auditions.

If you have students who are selected to audition at the ATSSB Area auditions January 10, 2015, be sure to pay the \$20 Area fee (in advance or at the door) or they will not be allowed to audition at the Area

level. No forms are necessary at Area. If you have a student make State, you will receive a username and password with which your student can access the TMEA website to download the Medical Release and Student Code of Conduct which they must bring to San Antonio signed and notarized. Area auditions will be a little different this year. There will be separate auditions for 3A Track and 4A Track (but only one for the Color Instrument Open Class). One panel will hear 3A Track, then immediately hear the 4A Track. Flute, clarinet and trumpet (possibly percussion) will be heard by separate panels - one panel for 3A Track flutes and a separate panel for 4A Track flutes, both panels running at the same time, so there will be separate holding rooms for 3A Track and 4A Track flutes, etc.

ELECTRONIC MEDIA

The State Board has voted to allow the use of electronic media in lieu of printed music in auditions (a book will still be provided on the stand for all students who wish to use it). The media is for the music only and may not be used as a tuner or metronome during the live audition.

HOUSING

We will once again utilize the Hyatt Regency for all ATSSB activities until the concerts. If at Area you have a student selected to the ATSSB All-State Band, you will need to sign them up for a room and include the Designated Chaperone (who must also stay at the same hotel as the student). Much has already been written regarding these procedures - and more clarification will come. Please keep your eye on the website for updates and policy clarifications. TMEA legal counsel has advised their Executive Board that if there is an incident of any kind at the convention involving a student, the liability rests with the designated chaperone and the school district, not on TMEA or ATSSB. Based on that opinion, it is highly recommended that you sign up as your student's designated chaperone and plan to stay in the Hyatt Regency where your student(s) will be housed.

To be sure, there is a LOT of paperwork involved in any organized activity, but it can all be taken care of if planned properly in advance. Use the Director's Checklist available to you online that should help with keeping it all in perspective and to help you navigate all the "red tape" used in the audition process:

All-State Band Profile

This year, the ATSSB All-State Concert Band will be restricted to 1A, 2A and 3A students only (with the exception of color instruments). It will be assumed that students in class 1A, 2A or 3A schools will be taking the 3A Track to the ATSSB All-State Concert Band. Should you desire your 1A, 2A or 3A student to audition for the Symphonic Band, you must select the 4A Track at the time of student registration in the Region Band Audition process.

The Band will follow all established audition procedures. The Instrumentation for the bands is listed below.

Color Instruments will be auditioned in the 4A Track. One of each color instrument will be selected at Area to be in the ATSSB All-State Band regardless of classification. Chair auditions at State will determine band placement with the top three in the Symphonic Band and the remaining two in the Concert Band. The following instruments are considered Color Instruments: Oboe, Bassoon, Alto Clarinet, Contrabass Clarinet, Tenor Saxophone, Baritone Saxophone, and Bass Trombone.

Due to tracking there is a very good possibility that a student who does not make the Region Band will qualify for Area Auditions.

to:

Fiscal Year and Special Funds

The Fiscal Year shall be from August 1 through July 31.

Rationale:

This will avoid confusion with the start of school when jazz entries must be made early in the semester using an ATSSB membership number that coincides with the coming school year. It will still allow OPS judges at TBA to be current Active Members during the OPS adjudication cycle.

Invocation was given by Jim Cude.

Minutes of the SBOD meeting February 13, 2014, as printed in the March Newsletter were approved after a motion by Matt Knight and a second by Brian Beeson.
 Under the reports of Special Committees, John Young introduced George Strickland who gave a UIL report:

Students in grades 11 & 12 in group piano classes may play a class 3 solo at Solo-Ensemble.

At Area and State Marching Contests, wording was tweaked to include them in wording regarding weather interventions to allow prelims to be considered finals.

At marching contests, only one wind player can be miked at a time for solos or front ensemble performances.

Be sure to complete online training for marching band personnel which is required by law. Marching Band entries this year will include a statement of compliance with copyright laws. The Marching Band committee is working and a full report will be given soon. Nothing is final until it passes through the music advisory committee and the technical advisory committee and the legislative council makes the final decision.

The Prescribed Music List will be updated online as of Thursday.

Heard reports of **Standing Committees**:

- President-Elect and SARC Chair Jim Cude had no report.
- **Brian Donnell**, State Jazz Coordinator, gave Region and Area Coordinators a handout (attached) with details regarding the coming jazz audition cycle:

- Check recording quality to make sure it is the best possible for students.
- The number of tenor trombones advancing from each region has been reduced from 4 to 3.
- Vibes are a part of the drum set auditions this year. A vibe demo is included on the CD from Mattei Music, replacing the flugelhorn demo on the old CDs.
- Make sure recordings are done with correct tracks. The best way to do this is to get a new CD from Mattei Music. It is also recommended that a director from the region be in the recording room to double check accuracy of recordings.
- o The CD deadline to Area is Saturday, October 11.
- o State CD adjudication is Saturday, November 8.
- o Regions 2,3,5,8,11,18 are the designated regions for jazz adjudications.
- Russ Rutherford interjected his encouragement of members to have students audition for drum set and not let the vibes requirement deter them, noting that their region had no drums record because of the vibe requirement.
- o Donnell noted that one of the pieces programmed this year calls on the bass trombone to play a tuba solo.
- Brandon Brewer, chair of the Past-President Committee, had no report.
- **Bob McClure**, Coordinator of the Composition Competition, noted that entries were now being accepted for the 2016 Competition, with a deadline for entry in May of 2015.
- Don Thoede, OPS State Chair, noted that this had been another good year for OPS. There were no hitches with the competition this year and all went smoothly at all levels. He thanked the Region and Area Coordinators for making his job so easy this year. He noted that he had received complaints from some Region Coordinators that they were having to complete entered forms because the individual directors were not following the instructions on the forms, but Thoede told them they could disqualify the entries and he would support them (while noting that most Coordinators still went ahead and did the work of the entering directors so they could continue in the competition). He wanted them to know he would support them in disqualifying entries not completed correctly. He then read the list of winner and runners-up and received a round of applause for his work with the OPS. He then reminded them that the competition will remain unchanged for 2015, but names of classes will reflect the new names: 1C, 2C, 1A/2A (combined), 3A, and 4A. He also stated that we would try to go all digital in 2015 (mp3 or wav files along with entry forms) if at all possible. Collin Anderson explained the options being investigated, including a dedicated server, using Dropbox, or our own ATSSB server for uploading the files and that we would be looking for consistency and access for all directors.
- President's Report by **John Young**:

He recognized Bob Vetter and Robinson High School for its selection as the TMEA Class 3A Honor Band.

He recognized Rob Toups for his retirement from Canton High School.

He encouraged 1A and 2A directors to enter students this year to take advantage of the 3A Track to All-State.

• Executive Secretary's Report by **Kenneth Griffin**:

After a short discussion, it was determined that Griffin would have ribbons at the ATSSB table at TBA for State Board members and guests to get on arrival. The TMEA ribbons will still be mailed since we have no table at TMEA.

He asked Region and Area Coordinators to check the patch order for 2015 to make sure data was accurate. Orders will go in September 1.

Gave a Scholarship Report which showed \$106,000 in the Scholarship Fund. Since 1995, ATSSB has awarded 307 individuals a total of \$271,500 in scholarships (not all were claimed). He asked that regions get their accounts in order with an Employer Identification Number for each region on file with the state office. He also reminded them that each region needed to have their Region Rules for 2014-15 in the state office before September 1 and that region web pages needed to show the date last updated and that they should show 2014 at least.

The minutes were approved as printed in the March Newsletter after a motion by **Trey Singleton** and a second by **Rodney Bennett**.

Mr. Young then called on **George Strickland** to give a UIL report:

Students in grades 11 & 12 in group piano classes may play a class 3 solo at Solo-Ensemble. At Area and State Marching Contests, wording was tweaked to include them in wording regarding weather interventions to allow prelims to be considered finals.

At marching contests, only one wind player can be miked at a time for solos or front ensemble performances.

Be sure to complete online training for marching band personnel which is required by law. Marching Band entries this year will include a statement of compliance with copyright laws. The Marching Band committee is working and a full report will be given soon. Nothing is final until it passes through the music advisory committee and the technical advisory committee and the legislative council makes the final decision.

The Prescribed Music List will be updated online as of Thursday.
