It was evident from the number of members (1218) we had in our twenty-eighth year (up from 1202 in the previous year) and from the quality of the 2019 ATSSB All-State Bands that our organization has maintained our original goal to be "sensitive to the needs and interests of small school band programs in Texas." Most small schools in Texas that have band programs are participating members of the Association.

The All-State Band Clinic was a positive one with Dr. John Cody Birdwell from the University of Kentucky conducting the Symphonic Band, premiering **Springerle** by Jack Stamp (commissioned by ATSSB). Dennis Johnson from Murray State University (Kentucky) led the Concert Band. Also, Christopher Bruya from Central Washington University led the All-State Jazz Ensemble in a wonderful performance in the Henry B. Gonzales Convention Center Hemisfair Ballroom 1.

We invite you to join ATSSB and hope that we can help you achieve your goals this year. You can download the application from the new ATSSB website (https://www.atssb.org/files/execsec/App.pdf). You can also open the application online and enter your data using your computer before printing it. Or you can use the online application process (https://www.atssb.org/atssb-membership-application-form/) to join and use your credit card to pay dues. A membership card and receipt will be emailed to you and your name added to the roster of your ATSSB Region Coordinator so you can be kept up to date on ATSSB activities. If you wish to have students participate in ATSSB activities this year, you must also become a member of TMEA(http://www.tmea.org) because the two organizations have unified the audition procedure for membership in Texas All-State Bands.

We hope you will get actively involved in ATSSB - or at least communicate your desires and suggestions to the State Board of Directors through your Region Coordinator (or directly to the Executive Committee).

We expect another banner year for ATSSB as we start our twenty-ninth year of service to small-school bands, growing together as unified small-school band directors, and we want you to be a part of it. Thank you for your continued support.

2019 OPS Winners As you all know, we ordinarily send the September Newsletter as a printed edition so we can include the CD of the OPS winners, but we no longer will be producing a CD. This year, each 2018-19 member will receive a link to download or listen to the 2019 OPS winners instead of the CD. Look for your link to the site.

LOST CARD? If you have misplaced your new ATSSB membership card, you can now go online to retrieve it and your receipt. Just go to https://www.atssb.org/membership/ to type in your last name, then the last four digits of your Social Security number. You will get a pdf file of your card and receipt. Should you have any problem accessing it, email me and I will get it to you promptly (atssb@att.net).

STATE OFFICERS Class 2C, 1A/2A and Class 4A Representatives are up for election in February. Nominations for these offices are open through your region meetings, so be thinking about your fellow directors and who would serve best in these positions.

Nominee biographies will be published online in the December Newsletter and elections will be held at the General Session in February. The meeting is tentatively scheduled for Thursday, February 13, 2020, at 1:00 p.m. in Room 225 of the Convention Center. Be sure to check the convention schedule to confirm the time and place.

Want to serve as an ATSSB officer? Many people have asked me over the years how they could get involved with ATSSB in a leadership capacity. Volunteer to help in region band auditions (as a judge, a clinic host, clinic organizer, etc.) and respond positively when asked to run for a region office. Your service will encourage members to nominate you for state office (Class Representative or President-Elect). If you would like to serve in an appointed leadership role (Area Coordinator, OPS State Chair, State Chair Audition Coordinator, State Jazz Coordinator, All-State Band Organizer, etc.), let the President know via email or other contact of your interest in the position. If you would like to be considered for the appointed position of Executive Secretary, notify the President who will inform the Executive Committee of your interest, then when the position is up for review (at TBA in odd years), your name will be submitted to the Executive Committee for consideration. Just so you know, the Executive Committee is charged with this review every two years, but is also charged with replacing the Executive Secretary in case of a vacancy for any reason.

ONLINE ENTRY Remember that entries for all-region band auditions (jazz, middle school or high school) must be done online. Go to the TMEA website (www.tmea.org), click on DIVISION, then BAND, then AUDITION ENTRY PROCESS. LOG IN AS DIRECTOR, then follow the prompts. You should end up on your profile page which will also list available competitions in which you are eligible to enter students. If a contest is not listed, contact your Region Coordinator to see why not (or when it will be available). We wish to thank TMEA Deputy Director Frank Coachman and TMEA IT Administrator Andrew Denman for allowing us to utilize the TMEA servers and for designing the FileMaker Pro audition entry and tabulation software. We are indebted to them and TMEA for their tireless work on behalf of music education in Texas. **CAUTION: there are penalties for late entries!** Remember, when you enter your ATSSB number in the entry, just use the numbers alone.

AUDITIONS As you send in entries to ATSSB all-region auditions, remember that students from schools in class 1A, 2A and 3A are auditioning in the 3A Track to All-State and students in class 4A are auditioning in the 4A Track. If you have a class 1A, 2A or 3A student who wishes to take the 4A Track - or any student wishing to take the 5A or 6A track - they **MUST** submit a Track Selection Form with their first audition entry (whether it is to ATSSB or TMEA). Also, please realize that since we are aligned with TMEA regarding auditions, directors will be held accountable regarding the policies and procedures in effect for TMEA and ATSSB which include an obligation to judge at region and area auditions.

TRACKING Students advancing to Area will be designated by the Track they selected (4A or 3A). The number allowed to advance in each Track is listed online as "All-State Band Profile". The region auditions determine the

Area Candidates from each of the regions in the state. Be sure you are aware of eligibility requirements and that you have taken care of all of the necessary paperwork (ATSSB membership, TMEA membership, region entry fees, forms completed, etc.) in advance of auditions. Please see the updated ATSSB Officers and Organizers in this Newsletter (and keep up with changes online) and contact your Region Coordinator if you have any questions regarding auditions. If you are already a member of ATSSB for 2019-20, your name and address is in your Region Coordinator's database and you will be receiving emails and/or mail-outs regarding these auditions.

JAZZ Students selected to advance to Area Jazz auditions will record their audition. The resulting recording will be uploaded to the TMEA servers and Area adjudications will use the audio files to select the 2020 ATSSB All-State Jazz Ensemble.

ADDANCING PAST REGION If you have students who are selected to audition at the ATSSB Area auditions January 11, 2020, be sure to pay the \$25 Area fee (in advance or at the door) or they will not be allowed to audition at the Area level. No forms are necessary at Area. If you have a student make State, TMEA will send you a username and password with which your student can access the TMEA website to download the Medical Release and Student Code of Conduct which they must bring to San Antonio signed and notarized. Area auditions will be like this past year. There will be separate auditions for 3A Track and 4A Track (but only one for the Color Instruments - all designated 4A Track for adjudication purposes). One panel will hear 3A Track, then immediately hear the 4A Track. Flute, clarinet and trumpet (possibly percussion) will be heard by separate panels - one panel for 3A Track flutes and a separate panel for 4A Track flutes, both panels running at the same time, so there will be separate holding rooms for 3A Track and 4A Track flutes, etc.

ELECTRONIC MEDIA The State Board has voted to allow the use of electronic media in lieu of printed music in auditions (a book will still be provided on the stand for all students who wish to use it). The media is for the music only and may not be used as a tuner or metronome during the live audition, although a non-audible metronome may be used to set the opening tempo then turned off before starting to play.

HOUSING We will once again utilize the Hyatt Regency for all ATSSB activities until the concerts. If at Area you have a student selected to the ATSSB All-State Band, you will need to sign them up for a room and include the Designated Chaperone (who must also stay at the same hotel as the student). Much has already been written regarding these procedures - and more clarification will come. Please keep your eye on the website for updates and policy clarifications. TMEA legal counsel has advised their Executive Board that if there is an incident of any kind at the convention involving a student, the liability rests with the designated chaperone and the school district, not on TMEA or ATSSB. Based on that opinion, it is highly recommended that you sign up as your student's designated chaperone and plan to stay in the Hyatt Regency where your student(s) will be housed. To be sure, there is a LOT of paperwork involved in any organized activity, but it can all be taken care of if planned properly in advance. Use the Director's Checklist available to you online that should help with keeping it all in perspective and to help you navigate all the "red tape" used in the audition process:

The Website has undergone a face-lift. The State Board of Directors voted to accept the committee's proposal to upgrade the ATSSB website (www.atssb.org). A consultant was hired to develop the site and it is now active, so take a look if you have not already done so (you need to anyway since it is the official document of ATSSB!). The website is a treasure trove of information and forms needed for all aspects of the ATSSB audition and competition experience, so check it out and keep track of all updates as they are announced, especially the catch-all page (https://www.atssb.org/executive-secretary/atssb-a-to-z/).

After 28 years, it is hard to remember what we did at the beginning, although the ATSSB History online helps. To clarify, I have posted a list of the **1991–92 membership** for you to see should you have any questions about who was a Founding Charter Member (was at the original founding meeting in Abilene on March 16, 1991 and paid \$100 dues to

Meeting called to order at 7:23 a.m. by Eric Gray.

The Invocation was given by Laurie Mollenkopf.

The **Oath of Office** was administered by Kenneth Griffin.

Mr. Gray suspended the agenda to allow OPS State Chair Collin Anderson to give his report so he could attend the OPS judges'

meeting:

Mr. Anderson noted OPS adjudication room changes (302, 303, 304 with 305 as office). He said that he had three items to report:

He reported that the OPS committee was looking at a separate non-varsity track but would not add it for 2020 because they were still investigating it.

The committee moved that a second monitor be paid if using two panels in adjudications. After a second by Robert Vetter, motion passed.

The committee approved adding recordings made at a TMEA Honor Band performance to the list of approved contests/festivals.

Minutes of the SBOD meeting February 14, 2019, as printed in the March Newsletter were approved as amended after a motion by Brian Beeson and a second by Laurie Mollenkopf.

Under the reports of Special Committees:

Mr. Gray introduced UIL Assistant Music Director Gabe Musella who gave a **UIL report**:

No Pass / No Play rule was implemented last spring. Local ISDs will decide whether to implement or not.

Under a new initiative, the solo & ensemble committee added more than 700 new Class I solos to the list with several new categories of ensembles. Class II & III will be addressed this year. He referred to the website to see who is on the committee.

New sightreading procedures have been approved with details on the TMAA website.

Class 1A, 3A and 5A will participate in the State Marching Contest November 4, 5 and 6 in the Alamodome in San Antonio. If 30-39 qualify for Area or State, 12 bands will advance. IF more than 40, 14 will advance.

Student physicals are required grades 9 and 11 for marching band participation with medical questionnaires required each year.

There is a study looking at holding the State Marching Contest for each classification each year beginning in the fall of 2020

Amplification on the marching field is under study (how many individuals can be amplified).

TMAA ad hoc committee is working on new Area/State adjudication sheets.

The Website Report was given by Marc Nichelson:

The new website is up. He asked everyone to reach out to him for login codes and he will help with WordPress. Be sure to request plugins through him.

Pictures submitted by members will rotate on the opening page soon.

The site can be accessed by mobile devices and can even be controlled using the WSordPress app on iPhones and iPads, etc.

Be sure to be prepared to use the site for ATSSB email accounts (use personal email for personal communications, but the ATSSB email account for anything to do with region/area/ATSSB business).

Christina Smith reported on the **Inclusion Committee**:

Since the SBOD had already received the report of the committee, motion was made by committee to adopt the report (attached) and add wording regarding inclusion to Section I.I. of the Student Entry and Registration Procedures of the Prescribed Audition List. After a second by Jason R. Smith, motion carried.

The Executive Committee met prior to the SBOD meeting and voted to move that the SBOD reappoint Kenneth Griffin to a two-year term as Executive Secretary and add \$2500 to his annual stipend. After a second by Russell Hopkins, motion carried,

Heard reports of Standing Committees:

President-Elect and **SARC** Chair Matt Knight had no report.

Ann Lowes Mueller, Coordinator of the **Composition Competition**, announced that the committee had reviewed thirteen entries and selected one winner with one Honorable Mention. Those will be named at the General Session on Friday. She noted that the oversight committee (Class Representatives) and she will be looking at rewriting the rules and procedures in preparation for the 2022 competition.

Mike Bartley reported on behalf of the **Past-President Committee** that he and Rob Toups would present a clinic at 1:00 sponsored by ATSSB regarding how to have a smooth transition in a successful program when the head director retires or moves.

State Jazz Coordinator Brian Donnell noted that the website was up and running and the jazz pages are updated. He

told Region and Area Coordinators to pick up the official accompaniment CD for this year from him.

President's Report by Eric Gray:

Mr. Gray reported that he and Matt Knight attended the TMEA Dialogue Series III this summer and were able to add perspective regarding effects on small schools. Special emphasis was made regarding the push for more technological courses and career training for marketable skills moving into lower grades, causing conflicts with fine arts selections. He noted that TMEA and UIL were very interested in ATSSB's opinions on these matters. He reported that Joe Munoz, TMEA Band Division Vice-President, told him that TMEA was adding an all-state percussion ensemble and mariachi band in 2021 and asked if ATSSB were considering the same. He thanked Marc Nichelson for the new website and noted that all volunteers and organizers were in place for 2020. He noted that he would be running the state chair auditions once again but thought it was time someone worked with him this year to take over that role in 2021.

Executive Secretary's Report by Kenneth Griffin:

Gave a **Scholarship Report** which showed a value of \$154,194.96 as of June 1, 2019, noting that we still lack paying 15 \$500 and 3 \$2000 scholarships. Noted that the **Kenner Scholarship Fund** was valued at \$14,031.22 as of June 1, 2019, and that 5 \$1000 scholarships had been awarded in the last 5 years. The **Program Fund** was valued at \$22,834.56 as of June 1, 2019 and that dividends from that fund have consistently paid for all-state programs since the fund was started with a donation from the Elmer and Anita Family Trust. Noted that a new brokerage account had been set up with \$10,525 for the **Commission Fund** from the additional \$5 Area fee added in 2019. Noted that we have under contract for coming years:

There was no old business.

Under new business:

Mr. Griffin reported that, after consultation with TMEA, **Licensees** will not be allowed to pay a royalty to individual regions in addition to the contracted royalty for the scholarship fund. They may pay up to \$300 for refreshments at region meetings but may not be allowed to give a sales pitch to the region.

Laurie Mollenkopf moved and Matt Knight seconded to approve the **Fall Agenda** to be sent to Region Coordinators for inclusion in their fall region meetings. Motion carried.

Brian Beeson moved and Mike Bartley seconded that the time and place of the **General Session** is to be set for 2:30 p.m. on Friday, July 26, 2019, in CC205. Motion passed.

There was no other new business.

There were no **Region reports**.

Mr. Gray **adjourned** the meeting at 8:18.

Minutes of the February ATSSB General Session

The General Session of ATSSB met in CC205 on Friday, July 26, 2019, with approximately 100 in attendance. President Eric Gray called the meeting to order at **2:30 p.m**.

Collin Anderson from Groesbeck gave the invocation.

Mr. Gray introduced the head table: himself, Executive Secretary **Kenneth Griffin**, Class 1C Representative **Gina Muela**, President-Elect **Matt Knight**, Class 4A Representative **Jason R. Smith**, 3A Representative **Angie Liss**, Class 2C Representative **Christina Smith**, Immediate Past-President **Mike Bartley**, and Class 1A/2A Representative **Brandon Garmon**.

The **minutes** of the General Session February 15, 2019, were approved as printed in the September Newsletter after a motion by **Brian Beeson** from Burkburnett and a second by **Kyle White** from Grand Saline.

Reports from Standing Committees:

Ann Lowes Mueller, Composition Competition Coordinator, announced the winner of the 2020 Composition Competition was Christopher Lowry for **Scherzito**, **after Gustav Holst**. Honorable Mention was awarded to Kelly Bennette for **Belt of Orion**.

OPS State Chair **Collin Anderson** announced the 2019 OPS winners and runners-up. He noted that there would no longer be CDs produced, but that winning files would be available to 2018-19 ATSSB members as a free PDD (Permanent Digital Download) on the new website when mechanical licenses had been procured.

In the **President's Report**, Mr. Gray reported on State Board of Director action: Kenneth Griffin was reappointed as Executive Secretary for a two-year term with \$2500 added to his stipend; Probst Audio's bid to record the 2020 All-State concerts was accepted; The TMEA Code of Ethics was adopted into the ATSSB Rules and Procedures. There was no old business and no new business.

The State Board moved for the adoption of the Constitutional Amendment regarding the refusal or removal of membership as needed. After a second by Don Summersgill, motion passed.

Mr. Gray then adjourned the meeting at 2:43 p.m. after a motion by Jason R. Smith and a second by Matt Knight.
