Greetings from ATSSB!

We have all seen unanticipated and troubling times over the past six months with the onset of COVID-19, the cancellation of school activities, the uncertainty of the opening of school and the role fine arts teachers will play in the new school year with the restrictions in place regarding social distancing, mask use, restricted group sizes, etc. It is especially troubling that surveys show that half of parents contacted said they would not feel comfortable allowing their children to return to the physical campus for fear of contracting the virus. That leaves band directors especially burdened with the expectation of teaching beginners, preparing a marching band show (uncertain if there will be bussing available or even football games or performance venues open for their presentation) - all amid restrictions regarding space restrictions, distancing, disinfections, lack of room and personnel to match the requirements, etc. No one really knows what will happen to this coming year, but we all have a stake in the future of fine arts in education. If you have a contact at the state level, make sure your voice is heard.

Even with all of the restrictions at the end of the year, ATSSB enjoyed another exciting and productive year in 2019-20. It was evident from the number of members we had in our twenty-ninth year (1237, up from 1218 in the previous year) and from the quality of the 2020 ATSSB All-State Bands that our organization has maintained our original goal to be "sensitive to the needs and interests of small school band programs in Texas." Most small schools in Texas that have band programs are participating members of the Association.

The All-State Band Clinic was a positive one with Eugene Corporon from the University of North Texas conducting the Symphonic Band. Dr. David F. Wilborn from Texas A&M University led the Concert Band, premiering **Scherzito**, **After Gustav Holst** by Christopher Lowe (winner of the 2020 ATSSB Composition Competition). Also, Paul Harshman from the University of Washington led the All-State Jazz Ensemble in a wonderful performance in the Henry B. Gonzales Convention Center Hemisfair Ballroom 1.

We invite you to join ATSSB and hope that we can help you achieve your goals this year. You can download the application from the ATSSB website (https://www.atssb.org/files/execsec/App.pdf). You can also open the application online and enter your data using your computer before printing it. Or you can use the online application process to join and use your credit card to pay dues (https://www.atssb.org/atssb-membership-application-form/). A membership card and receipt will be emailed to you and your name added to the roster of your ATSSB Region Coordinator so you can be kept up to date on ATSSB activities. If you wish to have students participate in ATSSB activities this year, you must also become a member of TMEA (http://www.tmea.org) because the two organizations have unified the audition procedure for membership in Texas All-State Bands. Since the TMEA Convention in February will be virtual this year, please see officer columns inside this Newsletter for details on how that will affect region/area/state auditions.

We hope you will get actively involved in ATSSB - or at least communicate your desires and suggestions to the State Board of Directors through your Region Coordinator (or directly to the Executive Committee).

We start our thirtieth year of service to small-school bands, growing together as unified small-school band directors, and we want you to be a part of it. Thank you for your continued support.

2020 OPS CANCELLED We had to cancel the 2020 Outstanding Performance Series due to the closing of schools and cancellation of contests and festivals. We look forward to some semblance of normalcy sometime in the coming year so we can revive this vital part of ATSSB.

2021 ALL-STATE BAND The TMEA Convention this year will be a virtual one like TBA was. That means that students auditioning for the All-State Band will be selected through the virtual audition process in place now all the way to State. Students selected to the ATSSB All-State Band or Jazz Ensemble will receive a shoulder patch and certificate this year.

KENNETH GRIFFIN LOST CARD? If you have misplaced your new ATSSB membership card, you can go online to retrieve it and your receipt. Just go to https://www.atssb.org/membership/ to type in your last name, then the last four digits of your Social Security number. You will get a pdf file of your card and receipt. Should you have any problem accessing it, email me and I will get it to you promptly (atssb@att.net).

STATE OFFICERS President-Elect along with Class 1C, and 3A Representatives are up for election in February. Nominations for these offices are open through your region meetings, so be thinking about your fellow directors and who would serve best in these positions. Nominee biographies will be published online in the December Newsletter and electronic voting will select the new officers in January. The General Session will still be help during the virtual TMEA Convention, but there will be no OPS awards given and no officer elections.

Want to serve as an ATSSB officer? Many people have asked me over the years how they could get involved with ATSSB in a leadership capacity. Volunteer to help in region band auditions (as a judge, a clinic host, clinic organizer, etc.) and respond positively when asked to run for a region office. Your service will encourage members to nominate you for state office (Class Representative or President-Elect). If you would like to serve in an appointed leadership role (Area Coordinator, OPS State Chair, State Chair Audition Coordinator, State Jazz Coordinator, All-State Band Organizer, etc.), let the President know via email or other contact of your interest in the position. If you would like to be considered for the appointed position of Executive Secretary, notify the President who will inform the Executive Committee of your interest, then when the position is up for review (at TBA in odd years), your name will be submitted to the Executive Committee for consideration. Just so you know, the Executive Committee is charged with this review every two years, but is also charged with replacing the Executive Secretary in case of a vacancy for any reason.

ONLINE ENTRY Remember that entries for all-region band auditions (jazz, middle school or high school) must be done online. Go to the TMEA website (www.tmea.org), click on DIVISION, then BAND, then AUDITION ENTRY, then DIRECTOR LOGIN, then follow the prompts. You should end up on your profile page which will also list available competitions in which you are eligible to enter students. If a contest is not listed, contact your Region Coordinator to see why not (or when it will be available). We wish to thank TMEA Deputy Director Frank Coachman and TMEA IT Administrator Andrew Denman for allowing us to utilize the TMEA servers and for designing the FileMaker Pro audition entry and tabulation software. We are indebted to them and TMEA for their tireless work on behalf of music education in Texas. **CAUTION DIRECTORS AND STUDENTS: Read all data regarding virtual entries!** There are three easy steps: 1) DIRECTOR enters students (be VERY careful to select the correct contest, track, instrument, etc.),

2) After the posted deadline on Friday, student have from Saturday until Wednesday to SUBMIT their recordings using MusicFirst, after which 3) DIRECTORS have until Friday to VERIFY the entries. Once the recorded file is **SUBMITTED** there is no recovery. Be careful that the scales and etudes are correct, the cuts are correct and the recording made is the one(s) you wish to enter, then click on SUBMIT. Directors, you must verify that the recording entered and submitted is made by the student in question by Friday. Also remember that when you enter your ATSSB number in the entry, just use the numbers alone. After that Friday, adjudications begin on Saturday. There are no late entries allowed this year and it will be difficult to make any changes after an entry has been submitted.

AUDITIONS As you send in entries to ATSSB all-region auditions, remember that students from schools in class 1A, 2A and 3A are auditioning in the 3A Track to All-State and students in class 4A and all color instruments are auditioning in the 4A Track. If you have a class 1A, 2A or 3A student who wishes to take the 4A Track on another instrument - or any student wishing to take the 5A or 6A track - they **MUST** submit a Track Selection Form with their first audition entry (whether it is to ATSSB or TMEA) - color instruments do not need to submit a Track Selection Form since all color instruments are adjudicated in the 4A Track. Also, please realize that since we are aligned with TMEA regarding auditions, directors will be held accountable regarding the policies and procedures which include an obligation to judge at region and area auditions.

TRACKING Students advancing to Area will be designated by the Track they selected (4A or 3A). The number allowed to advance in each Track is listed online as "All-State Band Profile". The region auditions determine the Area Candidates from each of the regions in the state. Be sure you are aware of eligibility requirements and that you have taken care of all of the necessary paperwork (ATSSB membership, TMEA membership, region entry fees, forms completed, etc.) in advance of auditions. Please see the updated ATSSB Officers and Organizers in this Newsletter (and keep up with changes online) and contact your Region Coordinator if you have any questions regarding auditions. If you are already a member of ATSSB for 2020-21, your name and address is in your Region Coordinator's database and you will be receiving emails and/or mailouts regarding these auditions.

JAZZ Students selected to advance to Area Jazz auditions are already used to recording their audition. The method may change somewhat this year since you will be using backtracks and must submit your own files if not able to do it from your band halls.

ADDANCING PAST REGION If you have students who are selected to audition at the ATSSB Area auditions January 9, 2021, be sure to pay the Area fee or their recorded audition file will not be adjudicated at the Area level. All students who have a file adjudicated at Area will receive an Area patch. No forms are necessary at the virtual Area auditions. If you have a student make State, ATSSB will send an All-State shoulder patch and certificate to recognize their accomplishment. Scholarship recipients will be announced on the ATSSB Website and in communications with members.

The Website has undergone a face-lift. Webmaster Marc Nichelson has done a great job managing the new website. It is a treasure trove of information and forms needed for all aspects of the ATSSB audition and competition experience, so check it out and keep track of all updates as they are announced, especially the catch-all page (https://www.atssb.org/executive-secretary/atssb-a-to-z/).

Best wishes for a successful fall semester - however you are teaching it (in-person, virtual or hybrid). Please let me know if there is anything ATSSB can do to help you in your task.

State Board of Directors Meeting July 7, 2020 2:00 p.m. ZOOM Meeting

36 Participants

Kenneth Griffin declared a quorum and Eric Gray called the meeting to order. He suspended the agenda and introduced Frank Coachman. He noted that TMEA has declared auditions will be virtual through Area (**Editor's note:** TMEA has announced that the Convention in February 2021 will also be virtual).

Griffin shared hosting so Coachman could share his screen. He shared a PowerPoint screen and discussed the items listed, going through the process TMEA has devised. TMEA talked about what this next year will look like, then come up with plans for activities regardless of what happens so schools can make plans. They come up with virtual auditions with no live region activities through Area, hoping to keep students apart so that when the convention comes around, perhaps we will be able to have a real convention-clinic. They felt like it would not be fair across the state (rural to urban). There is no clear idea what things will look like in 6-8 months, but we hope there will be time and place for region clinics and concerts in the spring, depending on the schedules. TMEA hopes to provide some sense of normalcy. Went to Music First (MF) since they have worked with them before. They have a platform TMEA can interface with. MF will host auditions. Students may compete on any Internet-connected digital device. Everything is archived. Recordings can have backing tracks. Recordings will be video, hoping to black out video in adjudications. If not, we are hoping the blended audition process will allow in-person adjudication with a monitor who can screen the video so anonymity is preserved. In the audition process, it will continue as usual but students will be assigned an account. Once the account (entry) has been created, there will be a fee charged for the account (\$2-\$3). The process from there was explained in detail. Darin

Johns raised the question about the additional \$3 fee since most have already set budgets and regions have already set fees. Coachman suggested that a small fee be assessed to those selected to cover the shortfall. Griffin said ATSSB could help if we have to. Brian Sours asked if recorded audition will become permanent. Coachman responded that it could become normal to use as a first round for middle schools for large regions. It might work for some, but not all. Benjamin Keltner asked if region rules would have to be amended and Coachman said to not try to rewrite region rules. TMEA will write an addendum to show how it works depending on how the process falls out. In some districts they will be all virtual, so we do not want them penalized – or if a school closes down. We plan for the worst but hope for the best. Possibilities at this time are 50-50 for February convention. Eric Gray thanked Frank and TMEA for all they are doing and encouraged everyone to gather their questions and send to the Executive Committee which will compile them and send them on to Frank after we have had time to digest this information. Save your questions and let Frank Coachman get back to all his hard work. Coachman thanked the State Board for allowing him to come and told them to let TMEA know how to make the process as easy as possible.

The minutes printed in the March Newsletter were approved after a motion by Darin Johns and a second by Brian Beeson.

- Website report by Marc Nichelson. Job Board facelift by the end of August. Webmaster account \$1017.16 trying to get website back to self-sustaining with advertising. Any concerns, contact him at nichelson@atssb.org. He encouraged Region Coordinators to make their atssb.org accounts active.

Standing Committee Reports:

- CompComp Unable to log into ZOOM meeting
- Past-President Mike Bartley and Kenneth Griffin talked to Todd Toney from Dallas Winds about a survey regarding the purchase of Dallas Winds musicians making a video clinic of the etudes. \$100 per school gets codes for all instruments for all kids with emails of the musicians for questions to start a dialogue about the music. We told them we are doing this at TBA, but it could be a good thing to have a different perspective. Watch for that survey. They need about 50 schools to do that to cover their costs. Griffin asked Bartley to catch the SBOD up on the clinic that ATSSB was going to sponsor at TBA. Griffin explained how TBA's George Little did not think that clinic would fit their virtual parameters. Chris Brannan did not want to get involved with it, so we cancelled. It. Bartley said that they will look at something again (actually Eric Gray will as Immediate Past-President!) for next summer.
- OPS Collin Anderson had no OPS report since we had to cancel OPS. Hopefully, next season we will get there. Griffin reminded him reminded about his motion. Steering Committee moves to raise judging stipend from \$75 to \$100. Griffin amended that to include Jazz judges. Anderson accepted the amendment. Comes as a motion from committee. Second by Jerry Whorton. Brian Beeson asked about the host fee. Griffin suggested raising host fee to \$125. Amendment accepted. Brian Sours asked if the raised honoraria will be too expensive. Griffin noted that ATSSB had sufficient funds to cover the increased honoraria. Collin Anderson clarified the question and Brian Sours agreed. Griffin agreed it was all fine. Fees and proposal were calculated and funds are sufficient to cover the increase. Motion carried.
- JAZZ Brian Donnell thanked Marc Nichelson for his help. Jazz page is up and updated. He shared a screen of the jazz web page, pointing out the changes. Noted that the accompaniment track will not be on CD it will be online at a password-protected site (password will be sent to Region Coordinators). You can download the tracks or run from the site. Area listening sites are posted there, balanced by area.

In the President's Report, Eric Gray noted that we were still working to prepare, with more questions than answers. If you have questions, let us know. If you will think about Frank Coachman's presentation, send questions or suggestions to the representatives on the Executive Committee. We need to consider how it affects small schools. We are still in need of apprentice organizers - send names to him. It is a 3-year process. Thanks to everyone taking care of their situations. We will get through it.

Executive Secretary Kenneth Griffin was not going to have a report, but things came up. Region rules must be on file. He read a list of the regions he still had no updated rules from and asked coordinators to send them as Word documents. He asked coordinators to update their websites. Marc Nichelson will help as needed. As you get updates on your schools, update your webpages.

There being no old business, we moved on to new business:

- Licensee payments. See the link in the agenda to see what we have received from licensees over the years. Asked region coordinators to make sure vendors in their regions are Licensees. We follow TMEA policy of only allowing royalty payments to the Scholarship Fund and cannot pay a royalty to regions. They may pay up to \$300 for refreshments but are not allowed to speak to the assembly.
- Set Fall Region agendas. Hearing no changes suggested or added or deleted, motion made by Brian Beeson, second by Trent Graves. Motion carried.
- Table consideration of recording for State because Scott Probst was not able to get online at the moment.
- Considering the Alignment Agreement, much discussion ensued. The only two things we changed in the original proposal was adding TMEA All-State ensembles (Jazz II) and changing the meeting of the Dialogue Committee from annually to as needed. The TMEA Executive Board made several other changes: adding the two TMEA All-State Percussion Ensembles, changing the color instruments to straight tracking, adding that either organization can call for a Dialogue Committee meeting, and changing the configuration of existing ATSSB ensembles must be "reviewed" by the TMEA Executive Board to must be "approved". Motion made by Darin Johns, seconded by Rod Rodriguez that we add "5A to item 1.a.iii. "TMEA 5A Symphonic Band – open to only", change the wording for color instruments back to the original configuration item 1.b.ii. "ATSSB Concert Band – open to only 3A, 2A and 1A classifications (with the exception of color instruments, restricted to 4A, 3A, 2A, and 1A classifications), replace the "approved" in item 5.a. with "reviewed" as in the original agreement, and remove the "every year" from item 5.c. In the ensuing discussions, Jerry Whorton interjected that if we leave that as saying configuration changes must be "approved", we no longer have the ATSSB All-State Band, but the TMEA Small School All-State Band. Laurie Mollenkopf agrees with the motion – we do not want to lose our independence as ATSSB or ability to configure our ensembles as we see fit – if TMEA has to approve everything we do, we are no longer our own organization. Whorton said color instrument tracking was brought to SARC and it was voted down so color instruments are represented by areas from across the state. Brian Sours questioned TMEA's reason for changing the "reviewed" to "approved". Whorton noted that the agreement has been in force for 12 years and they have not seen the need for the "approval" clause in our ensemble configuration. Brian Sours noted that usually there is a justification clause for changes – TMEA just changed it and said nothing. Trent Graves asked what happens if they say no? Griffin said we go back to the original agreement in 2015 until we both agree on an alignment agreement. Russell Hopkins asked if we were voting on making the changes as discussed and was told yes – as worded above. The question was called. Motion carried.
- We returned to the agenda for recording at state with Scott Probst. The Board had emails and the written proposal for digital recording at State. Still could not connect.
- Moving on to the next item of business, Constitutional interpretation regarding region meeting notifications.
 Interpret "in writing" to mean any form of writing, including electronic. Motion by Matt Knight, second by Marc Nichelson. Motion carried.
- Euphonium numbers Griffin suggested we write a letter to TMEA asking for clarification regarding the numbers entering and the numbers selected to state that they quote because we feel like we have justified the numbers through our process of study: Our regions expressed an interest in the increase to state, the SARC reviewed the issue, and the SBOD considered the matter and voted to add the numbers recommended. Jerry Whorton asked if the membership voted on the baritone increase. Griffin said the SBOD voted on it as representatives of the membership. Laurie Mollenkopf moved that we send the letter, asking for clarification and why TMEA is saying "No" to our increase. Second by Kevin Kuehler. Jerry Whorton, based on discussions with Kenneth Griffin, asked if there been any open dialogue other than they would not approve this. Nothing until the agreement came after the TMEA Executive Board meeting. Brian Sours asked if we could put the baritone issue to the membership. Motion

carried.

The meeting had to be suspended until after the General Session quickly coming up. Jerry Whorton moved to suspend, Brian Sours seconded. Motion carried. Meeting suspended online at 3:30 p.m.

Meeting resumed at 3:50 p.m. Griffin apologized for limit to 100 in General Session. We will fix that for future meetings. Rod Rodriguez offered their school Pro account. Griffin said we have a Pro account, just did not pay the \$50/month fee to increase it to 300.

Admitted Scott Probst to talk about recording the performances at State. Griffin asked if he had anything to share other than the emails and proposal he had already shared with the SBOD. No CDs for sale – all digital. We as an Association will pay that fee, given to all participants at State. Regions will have to make their own plans at the region level. Griffin expressed his opinion that it looks like it is where we need to go. Jerry Whorton asked if the model been used in any locations already. Scott Probst responded that he had done it in several regions last year, pointing out Region 5 All-Region Orchestra. It is online – Spotify, YouTube, etc. Search for TMEA Region Orchestra. Griffin put the link into chat. Probst said the region was happy with it and will do it again next year. He has not heard a lot from ATSSB regions but it may be because they have not had their meetings yet. The other organizations are very happy to do it. Every student that plays can hear it, not having to buy a CD, using any connection free on any device. Griffin thanked Probst for his time and Probst left the meeting.

Next – consider virtual recording at all levels through Area. Griffin noted that this item has no action. We can't do anything about this other than follow TMEA audition procedures.

Next – Region and Area online training July 31. Griffin moved to require each Region/Area must be represented. Second by Matt Knight. Laurie Mollenkopf asked if we could invite others to join us in the meeting. Griffin said he will ask. Eric Gray noted you can always all be in one room with one connection if needed, but they have allowed extras in the past, but we will get clarification. Darin Johns asked if all these were suggestions or motions. Griffin responded there was a motion and a second on the floor to tell Regions they WILL have someone at that meeting. Motion carried.

Consider suspending all clinic-concerts until after Area, January 9, 2021. Encourage Regions to hold clinic-concert in the Spring following the TMEA lead. Motion by Kevin Kuehler, second by Jay Sutton – amended by Kevin Kuehler and the second by Jay Sutton to be after January 10, 2021. Jerry Whorton asked what to do about regions which have a contract with a big name out of state? Are they tied to that, are we going to bail them out, or what? Griffin noted that if the contract was made before the pandemic, you had no way of knowing there would be a pandemic cancelling all public gatherings by law, so if it is cancelled by that, there is nothing to do but tell the clinician. Motion carried.

Recording of state concerts – motion by Brian Beeson, Second by Angie Liss. Brian Beeson asked what it cost us in the past. Griffin replied nothing. It was all based on CD sales. We also pay FOH \$1500 to mike the jazz group (for all jazz groups, including TMEA jazz groups). Motion passed.

New business, Darin Johns asked about omitting timpani in the percussion auditions. Griffin noted that was one of the questions you send to the Executive Committee; also, come up with scenarios of how to deal with quarantined students, etc. that cannot come to a central location or site for recording. Brian Beeson noted that since Region meetings were digital, if they could go ahead and elect officers online? Griffin replied yes. Jerry Whorton asked about pushing the jazz deadline back 30 days, so he moved that we move the window for jazz back 30 days (regions can keep where it is) – second by Brian Sours. Darin Johns asked if we are moving it too close to marching contest. Griffin questioned if we are using TMEA audition process, can we do it at a different time? Frank Coachman said with backtracking, that once the window started there will be 5 to 7 days – could be different in each region. Angie Liss asked if TMEA sets the deadline like in athletics (certified by a certain time) can region coordinators go in and set the audition date or will TMEA set the deadline, taking that away from us? Griffin responde that we do not know but that was a good question to ask of the Executive Committee. We will have to wait on a lot of this stuff. Angie Liss noted that she was confused too. If she goes

in and sets it up and they log on and set up an account, the \$2-\$3 fee is charged, so if a student does not record would they then be a DNA? Laurie Mollenkopf wanted to know why the jazz deadline was set for September 30. Matt Knight thinks it is for if selected for State, they are ineligible to go to Area in other tracks. Jerry Whorton noted it was originally put in place for windows for shipping CDs, now digital and should not require as much time. Russell Hopkins wanted us to keep in mind those that do not make State can then try out in region auditions and be eligible for Area. Laurie Mollenkopf suggested then a deadline different from September 30. Elmer Shenck said the reason for September 30 was to avoid marching contests on Saturdays in October. Ask the Executive Committee to a ask how jazz deadlines will work. Jerry Whorton said he was not suggesting extending deadline for the future, just this fall, that Elmer Schenk's thoughts were correct and we need to address all of these issues. Griffin asked if we could set the deadline. Eric Gray said we can unless TMEA says we all do it at the same time. Griffin noted that we may have different deadlines for entry, but TMEA will set accounts after that and THEN the window opens for 5 days for recordings to be uploaded. Again, ask Executive Committee to ask TMEA. Asa Burk said that just because we move the deadline forward, you can still do your auditions in the normal time frame. No one knows what marching season is going to be like so this can be a great time to get more kids involved in the jazz process. Griffin then wanted clarification: State Marching Contest timeline - regions enter students, they are assigned an account, then have a 5 day window to submit their recording to be selected for region, certain ones are certified to advance to area and the recording they entered is advanced to Area? Darin Johns wanted us to remember we have to judge all of these recordings. Assuming marching contests happen, October will be a busy month. If you set a later date for entry, we still have to judge them. Griffin noted that, while not ideal, judging could be completely virtual – they are hoping it can at least be a hybrid with 6 judges together with social distancing enforced to adjudicate the entries with a monitor not showing the video just playing the audio for the judges. Or it could be from your individual locations if we are in a virtual lockdown. Griffin noted that we ARE going virtual, so be prepared. Brian Donnell was asked online to catch up regarding September 30 deadline extension to October 30. Jerry Whorton told him we were wanting the deadline for Region and Area both 30 days back. Brian Donnell asked then when we would judge area. Whorton responded that we would have the month of November. Whorton then amended the motion to be only this year, following the same Area process, just compressing everything to get schools up and running. Donnell said he was all for more time, especially for getting a handle on the new process, but he was leery of getting all of the materials up in time to certify. Trey Graves reported that the TEA release that just came out part allow schools 3 weeks to phase in an opening. For us to extend this deadline to allow schools to get to some sort of normalcy before we have that deadline. Whorton suggested he withdraw this until later (meet SBOD again digitally). Brian Donnell thought they make one recording then certify, then they have to rerecord. Ask TMEA through Executive Committee. Eric Gray asked if a month was too long. They recorded the same day as region auditions in the past. Gray suggested we bump it two weeks, not a month, to the middle of October. Two weeks to make recordings and still meet deadlines. Brian Donnell noted that he was not the one that gets all of those files together. All of them have to be accurate. A month seems like a long time, but we spent 3 weeks tracking down correct recordings. A lot of things can go wrong and I can't imagine putting an entirely new procedure in place. Whorton asked if we were going to have to use MusicFirst software only all across. Ask Executive Committee to ask TMEA if one or two recordings for jazz. Donnell noted we will work with what is decided. Jerry Whorton removed the motion to discuss it in the future. Angie Liss noted this could all be moot – let's ask TMEA.

Region Reports: Region 13 Rod Rodriguez – to all wanted to know if we could poll the region coordinators to see who is moving their clinic-concert to next semester. Griffin said he would. Rodriguez said Region 13 is discussing not having middle school auditions. Griffin asked if Region 13 is considering not having middle school auditions at all? Eric Gray noted that would be a local decision.

Griffin noted this is the time he asked about patch orders. He will send the patch order to all and wait for all of you to make a decision. We are having lapel pins for our 30th anniversary for the State Board members.

Area Reports – none.

Eric Gray noted that this was all uncharted territory. He wanted us all to listen to what folks tell you and we will gather again soon. Thank you for participation.

Benjamin Keltner asked who the Area South Coordinator will be? Emerico Perez, moved to Alice but they are 4A now. Griffin thanked the Board all for the help.

Meeting adjourned at 4:55 p.m.

State Jazz Coordinator's Column

Hello everyone. Hope this finds you and your families safe and well.

With the cancellation of the TMEA convention, we will turn to seating our region, area and state jazz bands virtually.

To prepare for the upcoming auditions, make sure you have this year's set of music, have contacted your region chair for the region auditions, and set aside some time in late September to familiarize yourself with the MusicFirst platform that will be used for the audition submissions.

Things to consider about the virtual auditions:

- students will be submitting the auditions within MusicFirst. Although coaching by directors during the audition is not allowed, directors will have the opportunity to listen to the student's recording prior to them pushing the submit button. Once the student pushes submit, their recording chance is finished.
- students will record a separate audition for area if they qualify. They may not use the same recording for more than one event.
- drumset players would benefit from using a headphone splitter so that external speakers are used for the backing tracks and headphones used by the player.
- microphone placement for drumset should be in front of the set and backed away to help with the balance. Do not place the mic close to the set or you will pick up mostly cymbals and extra noise.
- students may use one (ONE, 1) USB microphone to record. You MAY NOT use any type of audio processing device between the mic and computer. Also, there may not be any editing used in the recordings.
- I would recommend finding the very best USB microphone you can or an XLR to USB adapter for your existing mics.
- spend time in September exploring the best place to audition so it's a clear recording that showcases each student's tone quality, style, articulation and timbre.
