Greetings from ATSSB!

We have all seen unanticipated and troubling times over the past year and a half with the onset of COVID-19, the cancellation of school activities, the uncertainty of planned activities ... only to see them cancelled or postponed.

Even with all of the restrictions, ATSSB enjoyed another exciting and productive year in 2020-21. It was evident from the number of members we had in our thirtieth year (1247, up from 1237 in the previous year) and from the quality of the 2021 ATSSB All-State Bands that we were able to seat and allow to perform in Melissa June 9-12, 2021, that our organization has maintained our original goal to be "sensitive to the needs and interests of small school band programs in Texas." Most small schools in Texas that have band programs are participating members of the Association.

Almost two hundred directors and friends enjoyed a luncheon in McKinney on June 11 celebrating ATSSB's Thirtieth Anniversary. ATSSB Executive Secretary Kenneth Griffin was announced as the inaugural inductee in the ATSSB Hall of Fame at the Luncheon.

The All-State Band Clinic in Melissa June 9-12 was a positive one with Dr. Mo Trout from Purdue University leading the All-State Jazz Ensemble opening the concert. Don Lefevre from West Texas A&M University led the Concert Band and Brian Balmages from FJH Music conducted the Symphonic Band, premiering his **Breaking Through** (commissioned by ATSSB). Be sure to listen to Balmages' comments at the performance <u>HERE</u>. Melissa ISD was a gracious host, providing facilities for rehearsals, clinics, exhibits and performances in its new facilities. ATSSB is grateful to Melissa Superintendent Keith Murphy, Melissa High School Principal Kenneth Wooten, Fine Arts Director Jerry Whorton, and the entire Melissa Band staff for their contributions to the success of this clinic. Eighteen colleges and universities provided information and presented materials during a College Fair for the all-state students on Friday of the clinic, organized by Tammy Summersgill from Shallowater. There were eleven professional development clinics presented to overflow crowds of directors during the clinic, organized by Brian Sours from Tenaha.

We invite you to join ATSSB and hope that we can help you achieve your goals this year. You can download the application from the ATSSB website (https://www.atssb.org/files/execsec/App.pdf). You can also open the application online and enter your data using your computer before printing it. Or you can use the online application process to join and use your credit card to pay dues (https://www.atssb.org/atssb-membership-application-form/). A membership card and receipt will be emailed to you and your name added to the roster of your ATSSB Region Coordinator so you can be kept up to date on ATSSB activities. If you wish to have students participate in ATSSB activities this year, you must also become a member of TMEA (http://www.tmea.org) because the two organizations have unified the audition procedure for membership in Texas All-State Bands.

We hope you will get actively involved in ATSSB - or at least communicate your desires and suggestions to the State Board of Directors through your Region Coordinator (or directly to the Executive Committee).

We start our thirty-first year of service to small-school bands, growing together as unified small-school band directors, and we want you to be a part of it. Thank you for your continued support.


Kenneth Griffin is the backbone of our organization. You could not say enough about what he does for ATSSB. ATSSB is better every day because of everything he does.

OPS State Chair Collin Anderson did a great job organizing the process and overseeing the State Adjudications at TBA. Congratulations to the participants and winners this year. Look for the PDDs (Permanent Digital Downloads) links on the website when they have been mastered.

2021 ALL-STATE BAND The ATSSB All-State Band Clinic and Concert in Melissa June 9-12 was a huge success due to the amazing efforts of many, many people and the beautiful facilities provided by Melissa ISD. If you were able to attend, you have many fond memories to carry with you into the new year: 1) Really intense rehearsals by all three ensembles (the students were very focused

during rehearsals - you could tell they really missed being together and were relishing every moment!); 2) Great clinics by outstanding clinicians with overflow crowds, organized by Brian Sours of Tenaha; 3) Really interesting tables at the College Fair where eighteen colleges provided materials and talking points to the all-state students on Friday of the clinic, organized by Tammy Summersgill from Shallowater; 4) Happy and busy exhibitors who offered their wares in an exhibit area (one travel company noted that this was the very first exhibit in the COUNTRY they were able to provide since the onset of the pandemic, so they were all happy to be there); 5) A celebration of success with the 30th Anniversary Luncheon, at which I was honored to be named as the initial inductee into the newly created ATSSB Hall of Fame! The luncheon was great, the speakers captivating, and the award humbling for me; 6) And the culmination - the only all-state performances in Texas took place on Saturday to a full house (with standing room only in the foyers - along with the performances live-streamed thanks to the help from Stephen Cox from Eastland). We really cannot say enough about how Melissa Fine Arts Director Jerry Whorton and his staff pulled off the event of the year!

ATSSB HALL OF FAME Initiated at the 30th Anniversary Luncheon during the All-State Clinic, members are inducted in February during the ATSSB General Session if selected from nominations received by the previous November 1. See the <u>Hall of Fame Guidelines</u> and <u>Nomination Form</u> online if you would like to nominate someone for this prestigious honor.

LOST CARD? If you have misplaced your new ATSSB membership card, you can go online to retrieve it and your receipt. Just go to https://www.atssb.org/membership/ to type in your last name, then the last four digits of your Social Security number. You will get a pdf file of your card and receipt. Should you have any problem accessing it, email me and I will get it to you promptly (atssb@att.net).

STATE OFFICERS Class 2C/3C, 2A and 4A Representatives are up for election in February. Nominations for these offices are open through your region meetings, so be thinking about your fellow directors and who would serve best in these positions. Nominee biographies will be published online in the December Newsletter and voting will take place at the General Session (tentatively scheduled for Thursday, February 11, 2022, at 3:30 p.m. in Room 207 of the Convention Center.

Want to serve as an ATSSB officer? Volunteer to help in region band auditions (as a judge, a clinic host, clinic organizer, etc.) and respond positively when asked to run for a region office. Your service will encourage members to nominate you for state office (Class Representative or President-Elect). If you would like to serve in an appointed leadership role (Area Coordinator, OPS State Chair, State Chair Audition

Coordinator, State Jazz Coordinator, All-State Band Organizer, etc.), let the President know via email or other contact of your interest in the position. If you would like to be considered for the appointed position of Executive Secretary, notify the President who will inform the Executive Committee of your interest, then when the position is up for review (at TBA in odd years), your name will be submitted to the Executive Committee for consideration. Just so you know, the Executive Committee is charged with this review every two years, but is also charged with replacing the Executive Secretary in case of a vacancy for any reason.

ONLINE ENTRY Remember that entries for all-region band auditions (jazz, middle school or high school) must be done online. Go to the TMEA website (www.tmea.org), click on DIVISION, then BAND, then AUDITION ENTRY, then DIRECTOR LOGIN, then follow the prompts. You should end up on your profile page which will also list available competitions in which you are eligible to enter students. If a contest is not listed, contact your Region Coordinator to see why not (or when it will be available). CAUTION DIRECTORS AND STUDENTS: Read all data regarding entries!

AUDITIONS As you send in entries to ATSSB all-region auditions, remember that students from schools in class 1A, 2A and 3A are auditioning in the 3A Track to All-State and students in class 4A and all color instruments are auditioning in the 4A Track. If you have a class 1A, 2A or 3A student who wishes to take the 4A Track - or any student wishing to take the 5A or 6A track - they **MUST** submit a Track Selection Form with their first audition entry (whether it is to ATSSB or TMEA) - color instruments do not need to submit a Track Selection Form since all color instruments are adjudicated in the 4A Track. Also, please realize that since we are aligned with TMEA regarding auditions, directors will be held accountable regarding the policies and procedures which include an obligation to judge at region and area auditions.

TRACKING Students advancing to Area will be designated by the Track they selected (4A or 3A). The number allowed to advance in each Track is listed online as "All-State Band Profile". The region auditions determine the Area Candidates from each of the regions in the state. Be sure you are aware of eligibility requirements and that you have taken care of all of the necessary paperwork (ATSSB membership, TMEA membership, region entry fees, forms completed, etc.) in advance of auditions. Please see the updated ATSSB Officers and Organizers in this Newsletter (and keep up with changes online) and contact your Region Coordinator if you have any questions regarding auditions. If you are already a member of ATSSB for 2021-22, your name and address is in your Region Coordinator's database and you will be receiving emails and/or mailouts regarding these auditions.

JAZZ This process remains unchanged. The only clarifications are that no mutes are to be used in the improv section of the recorded area auditions (see the current <u>Year A Update</u> online).

ADUANCING PAST REGION If you have students who are selected to audition at the ATSSB Area auditions January 8, 2022, be sure to pay the Area fee or they will not be allowed to audition at the Area level. All students who audition at Area will receive an Area patch. No forms are necessary at the virtual Area auditions. If you have a student make State, they will receive a link to TMEA from which they will download documentation required for All-State.

WEBSITE Webmaster Marc Nichelson has done a great job managing the new website. It is a treasure trove of information and forms needed for all aspects of the ATSSB audition and competition experience, so check it out and keep track of all updates as they are announced, especially the catch-all page (https://www.atssb.org/ executive-secretary/atssb-a-to-z/).

Best wishes for a successful fall semester. Please let me know if there is anything ATSSB can do to help you in your task.

Applications are now being accepted from seniors in ATSSB schools interested in getting a teacher certificate and teaching band in a public or private school. Mr. Kenner was a band director in small schools all over Texas for 30 years and a proud member of ATSSB. His family wanted to continue his passion and love of music, teaching, and helping students for years to come. They wanted to honor him with this scholarship.

Minutes of the SBOD ZOOM meeting February 31, 2021, as printed in the March Newsletter were approved after a motion by Brian Beeson of Burkburnett and a second by Mike Bartley of Canton.

Under the reports of Special Committees:

Mr. Knight introduced UIL Assistant Music Director Gabe Musella who gave a UIL report:

He thanked the Board for the invitation to attend on behalf of himself and Dr. Kent.

- UIL activities for 2021-22 will be as pre-pandemic with exceptions noted on the UIL website.
- House Bill 547 set a policy that homeschoolers may participate in public school activities if adopted by the individual ISD.
- Please note current COVID guidelines on the UIL website.
- The sightreading pilot program will go forward in regions 6, 13,15,25, and 26. After a question from the Board, he assumed the combined ATSSB regions will be involved in the pilot: 6, 13/17, 15/28, 24/25, 18/26.
- There are many more options in the PML which will go online September 1 with 15 additions in Grade 1, 6 in Grade 2, 7 in Grade 3, 11 in Grade 4, and 8 in Grade 5.
- All UIL Solo-Ensemble codes have been updated.
- Mariachi contests will take place in 5 regions with a 7-judge panel, advancing only traditional mariachi bands to State.
- The State Marching Contest will be for all conferences this fall with 1A, 3A and 5A on November 1,2,3 and 2A, 4A and 6A on November 8,9,10.
- Check the UIL website for the physical requirements and timelines, hours allowed in summer marching practices.
- The new Marching Band adjudication sheets may be reviewed online and will use 3 judges at region, 5 at Area (3 marching, 2 visual) and 7 at State for 5A and 6A (4 marching, 3 visual).

The advisory committee will be meeting to discuss rule changes for marching band after this fall. The Website Report was given by Marc Nichelson:

- He asked Regions to keep their pages updated, noting that they can insert a Google calendar very easily using WordPress by Googling how to do it or to contact him so he can guide them through the process.
- Be sure to let us know of broken links or outdated links. The site is huge with many pages simply transferred from the old site which might result it duplicate pages one of which would be outdated, so let us know.

The Website account has \$850.50 in it. He has updated the vendor accounts for banner ads.

He told them of the induction of Kenneth Griffin as the Inaugural Inductee into the ATSSB Hall of Fame – also resulting in a round of applause.

State Jazz Coordinator Brian Donnell noted that Dr. Mo and the Jazz Ensemble had a great time. Dr. Mo is originally from Texas, having taught at UNT. He noted that Russell Schmidt from the Valley Jazz Cooperative will be the clinician for 2022.

The Area Jazz adjudications will be posted on the ATSSB jazz page: Region 29 = alto sax, Region 9 = tenor and bari sax, Region 15 = trumpet, Region 24 - tenor trombone, Region 6 = bass trombone, Region 7 = rhythm, and Region 8 = drums.

He reminded Regions that they need to submit Form 9 showing how many auditioned when they send their Area checks.

He thanked the Executive Committee for the hours of meetings and planning to bring it all together. He asked that Region and Area Coordinators read and respond to all emails, polls and votes.

Executive Secretary's Report by Kenneth Griffin:

Gave a Scholarship Report which showed a value of \$189,842.57 as of June 1, 2021, noting that

ATSSB awarded 19 \$500 Scholarships and 5 \$2000 Scholarships at Melissa in June, and that \$424,000 had been awarded to 490 individuals since 1997. Noted that the Kenner Scholarship Fund was valued at \$14,462.15 as of June 1, 2019, and that 7 \$1000 scholarships had been awarded in the last 7 years. The Program Fund was valued at \$26,006.07 as of June 1, 2021 and that dividends from that fund have consistently paid for all-state programs since the fund was started with a donation from the Elmer and Anita Family Trust. Noted that the Commission Fund was valued at \$25,560.67 and that we have paid for the commission from Brian Balmages. He noted that Regions 2,3,4,5,6,10,11,13,14,15,18, and 22 have Region Rules on file but the rest will not have access to the audition entry process until they submit their updated rules. He gave out a patch order form for the year.

There was no old business.

Under new business:

The Executive Committee met and voted to make the motion to renew Kenneth Griffin's appointment as Executive Secretary for 2021-2023. After a motion by Angie Liss, the motion passed.

Reporting about Licensees, Mr. Griffin noted that 16 ACTIVE Licensees have paid \$264,110.66 into the Scholarship Fund beginning in 1997. That fund has expended \$424,000 since then due in part from donations from regions and individuals and that blessed late fee for dues! We also have done very well in our brokerage accounts over that span of time.

Regarding Fall Region Agenda items, Mike Bartley made the motion to approve the Agenda. After a second by Brian Beeson, the motion passed.

Mr. Knight reported that the Dialogue Committee met Wednesday evening and, after an amicable meeting, agreed on terms for the new Agreement. The Executive Committee approved it and it will be published online. Brian Donnell asked that the Jazz Ensemble be added to the commission rotation. Mr. Knight referred the proposal to the Executive Committee for discussion.

Rod Rodriguez moved and Bryce Victory seconded that ATSSB accept the proposal from Pepwear to be the All-State Vendor for a three-year term. After a short discussion, the motion passed.
